The candidate must ensure that the election advertisement particulars submitted comply with the rules and requirements as set out in section 87(2) and (3) of the Electoral Procedure) (Chief Executive Election) Regulation (Cap 541J), and paragraphs 8.44 of Chapter 8 of the "Guidelines on Election-related Activities in respect of the Chief Executive Election".
