2022 Chief Executive Election Points to Note for Submission of Nomination Forms for Candidates

- 1. The nomination forms may be obtained free of charge during ordinary business hours on any day between 25 March 2022 and 16 April 2022 (other than a general holiday) on the ground floor, City Gallery, 3 Edinburgh Place, Central, Hong Kong, or may be downloaded from the website of the Registration and Electoral Office (<u>http://www.reo.gov.hk</u>).
- 2. The nomination period will run from 3 April 2022 until 16 April 2022 (both dates inclusive). The nomination form must be handed in by the candidate in person and received by the Returning Officer ("RO") within the nomination period during ordinary business hours (Mondays to Fridays: from 9:00 a.m. to 5:00 p.m.; Saturdays: from 9:00 a.m. to 12:00 noon) on any day other than a general holiday. Late submission will not be accepted.
- 3. Candidates must submit their nomination forms in person at the RO's office at 3/F, City Gallery, 3 Edinburgh Place, Central, Hong Kong. If a candidate cannot submit the nomination form in person (e.g. because of the candidate's temporary absence from Hong Kong, incapacity due to illness or under quarantine requirement or medical surveillance of the Government), he/she must obtain the RO's authorization to submit the nomination form by a designated representative. The application shall clearly state the name of the candidate, the reason for not being able to submit the nomination form in person (with documentary proof if available), and the full name and Hong Kong Identity Card number of the proposed representative (as shown on the Hong Kong Identity Card). The application should be submitted to the RO by fax (fax no.: 2151 0426) or e-mail to "nomination@reo.gov.hk".
- 4. In view of the latest epidemic situation, if a member of the Election Committee ("EC") is under compulsory quarantine at the **designated quarantine hotels or quarantine facilities** during the nomination period and is unable to submit the original of page 3 of the nomination form to the candidate before the end of the nomination period, please contact, as soon as practicable, the Registration and Electoral Office by phone on 2891 1001 or by email to nomination@reo.gov.hk for assistance.
- 5. If a member of the EC is undergoing compulsory quarantine (whether at home or at designated community isolation facilities) or is absent from Hong Kong, he/she may submit, by electronic means, the completed and signed page 3 of the nomination form (with the serial number of page 3 left blank and to be filled by the candidate) to the candidate he/she nominated. The candidate must then submit, the copy of said page 3 of the nomination form with the serial number filled as appropriate, together with the originals of other completed and signed parts of page 3 of the nomination form, to the RO no later than 5:00 p.m. on 14 April 2022. No addition (including the filling of the serial number of page 3), alteration or deletion should be made to the original of page 3 of the nomination form after the copy is submitted to the RO. The candidate concerned must submit the original of page 3 of the nomination form to the RO in person no later than 5:00 p.m. on 19 April 2022. The original must be the same as the copy previously submitted (except the serial number of page 3). Failure to comply with the above requirements will render the subscription by the EC member invalid. The RO will bear no liability to the EC Member or the candidate concerned for the invalidity of nomination arising from such failure.
- 6. Candidates are strongly advised to submit their nomination forms as early as practicable so that any mistakes found in the nomination form can be rectified before the end of the nomination period.
- 7. The nomination forms will be handled by the RO on a first-come-first-served basis.
- 8. Due to limited space in the RO's office, each candidate shall only be accompanied by <u>two companions</u> during submission of the nomination form (that is, not more than three persons with the candidate included).
- 9. A nomination form must be subscribed by not less than 188 members of the EC, with not less than 15 members from each of the 5 sectors of the EC. Each EC member may nominate one candidate only.

- 10. In the course of receiving a nomination form by the RO, all persons present at or entering the RO's office must **observe the following rules** and follow the instructions of the RO or his/her authorized officers:
 - (a) To ensure public safety at the RO's office, no person shall bring into, use or display in the RO's office any article which RO or his/her authorized officers consider(s) that may cause nuisance, inconvenience, disturbance, interference, obstruction or danger to other persons (including but not limited to, luggage, helmet, loudhailers, sound emitting objects) or publicity materials of any kind (including banners, bunting flyers).
 - (b) Shouting, yelling or any activities that would cause nuisance to other parties are prohibited in the RO's office.
 - (c) Smoking, eating, drinking, photo-taking, sound/video-recording and live/relay broadcast are prohibited in the RO's office.
 - (d) Persons entering or present at the RO's office shall not deliberately cause obstruction at points of entry or exit, nor shall they impede, obstruct or detrimentally affect the flow of pedestrians or traffic outside the office.
 - (e) Found property will be handled by security staff, RO or his/her authorized officers or the Police without further notice.
 - (f) Should there be any imminent threat of a breach of the peace and / or any act contrary to the Laws of Hong Kong, enforcement action may be taken by the Police as they see fit.
- 11. In view of public health considerations, the following prevention and crowd management measures will be implemented:
 - (a) All persons entering the RO's office are required to wear a surgical mask all the time, except that the candidate is required to temporarily remove his/her mask for the purpose of verification of identity.
 - (b) All persons entering the RO's office should comply with all the access control arrangements in force imposed by the RO's office and/or the management of the building in which the RO's office is located, including use of the LeaveHomeSafe mobile app upon entry. Otherwise, the relevant person's entry to the RO's office may be denied.
 - (c) Please use hand sanitiser upon entering the RO's office.
 - (d) All persons entering the RO's office are required to have their body temperature taken. No one is allowed to enter the office if he/she shows signs of fever (i.e. temperature higher than 38°C).
 - (e) Necessary queuing and other crowd management measures, as well as security controls to limit the number of persons entering and staying in the RO's office at the same time, will be put in place as appropriate.
 - (f) All persons subject to quarantine requirement or medical surveillance of the Government should not come to the RO's office.

Note: Candidates having fever or respiratory tract infection symptoms or being subject to quarantine requirement or medical surveillance of the Government may apply to the RO for authorization to submit the nomination form by a designated representative. Please refer to item 3 above for details.

- 12. The RO or his/her authorized officers shall ask any person who does not observe the aforesaid rules or follow the instructions of the RO or his/her authorized officers to leave the RO's office immediately.
- 13. The RO and/or REO hereby reserve(s) the right to amend these "Points to Note" any time as he/she/it sees appropriate.
