I declare that to the best of my knowledge I am not disqualified from being nominated as a candidate or elected as an elected member by any reason provided in section 21 of the District Councils Ordinance (Cap. 547) or any other law. [see Note 17]

Notes on Completion of Nomination Form for the District Council Election

以下說明只供參考。有關提名事宜的法例，請參閱《區議會條例》（第547章）、《選舉（舞弊及非法行為）條例》（第554章）及其他有關法例，包括《選舉管理委員會（選舉程序）（區議會）規例》（第541F章）。

The Notes below are for reference only. For legislation concerning nomination matters, please refer to the District Councils Ordinance (Cap. 547), the Elections (Corrupt and Illegal Conduct) Ordinance (Cap. 554) and other relevant legislation, including the Electoral Affairs Commission (Electoral Procedure) (District Councils) Regulation (Cap. 541F).

1. 每份提名表格只能用以提名一位候選人。
A separate nomination form must be used for each candidate.
2. 是否提供聯絡資料予傳媒使用及公眾查閱屬自願性質。該等資料會提供予傳媒以便他們直接聯絡有關候選人。
The supply of contact information for the media and public inspection is optional. The information will be provided to the media to facilitate them to contact the candidates concerned directly.
3. 根據《區議會（提名所需的選舉按金及簽署人）規例》（第547A章），每份提名表格須由10位提名人親自簽署表示同意提名。所有提名人必須已登記為有關選區的選民。為避免因有提名人不符合資格而令提名失效，提名表格可由多於10位，但不超過20位提名人簽署。候選人應查證提名人的資格。倘若基於任何原因，某位提名人被發現不符合資格在提名表格上提名，他／她的提名將不予理會。候選人亦須提醒每位提名人應填寫在其身分證明文件（指提名人記錄在地方選區正式選民登記冊內的資料所依據的身分證明文件）上所顯示的姓名。
According to the District Councils (Subscribers and Election Deposit for Nomination) Regulation (Cap. 547A), a nomination form must be **personally subscribed and signed by 10 subscribers**. All the **subscribers must be registered electors for the relevant constituency**. To avoid the risk of invalidation of the nomination if any subscriber is unqualified, the nomination form may be subscribed by more than 10 but not exceeding 20 subscribers. A candidate should check the qualification of the subscribers. If for any reason a subscriber is found to be unqualified to subscribe the nomination form, his/her subscription will be disregarded. A candidate should also remind each subscriber to provide the name as shown on his/her identity document (being the identity document based on which the particulars of the subscriber are recorded in the geographical constituencies final register).
4. 每一位登記選民只可就其所屬的選區以提名人身分簽署一份提名表格。
A registered elector in respect of a constituency is entitled to subscribe only ONE nomination form.
5. 任何人在某份提名表格上以提名人身分簽署，如其簽署超出有效地提名有關候選人所需的提名人數（由優先編號1起計），則該人將被視為不曾在該提名表格上以提名人身分簽署。該人可簽署另一份提名表格。
Any person whose signature as a subscriber is in surplus of the number of qualified subscribers required to effect the nomination of the candidate concerned (counting from Priority No. 1 onwards) will be regarded as not having subscribed the nomination form. In this case, that person may subscribe another nomination form.
6. 請以中文及英文提供候選人的姓名及主要住址，以便在政府憲報上刊登有效提名公告。有關填寫中文姓名及主要住址的注意事項，可參閱附錄。候選人必須填寫在其身分證明文件（指候選人記錄在地方選區正式選民登記冊內的資料所依據的身分證明文件，通常是其香港身分證）上所顯示的姓名。候選人在填寫中文姓名時須嚴格依照在其身分證明文件上所顯示的繁體字或簡體字寫法（按情況而定）。未能遵守這項規定會延誤檢查身分證明文件工作及／或令候選人須返回選舉主任辦事處更正寫法。如果選舉主任信納某候選人通常為人所知的姓名與其身分證明文件上所顯示的姓名有所不同，該候選人可在別名一欄中加上該姓名。有效提名公告上顯示的候選人姓名（包括別名）會印在選票上。根據《選舉管理委員會（選舉程序）（區議會）規例》（第541F章）第19(3)及(4)條，選舉主任必須將一份關於某人是否獲有效提名的決定的通知，送交該人及有關選區的每名獲有效提名的候選人。這份通知必須按各有關提名表格上所提供的主要住址送交。

For publication of the Notice of Valid Nominations in the Government Gazette, please provide the name and principal residential address of the candidate in both Chinese and English. The candidate may refer to the Appendix for the points to note when filling in the Chinese name and principal residential address. The candidate must provide the name as shown on his/her identity document (being the identity document based on which the particulars of the candidate are recorded in the geographical constituencies final register, which is usually his/her Hong Kong Identity Card). The candidate should strictly follow the writing of his/her Chinese name as shown on his/her identity document in Traditional Chinese or Simplified Chinese (as the case may be). Failure to comply with this requirement would cause a delay in checking the candidate's identity document and/or require him/her to return to the Returning Officer's office for rectification. If the Returning Officer is satisfied that the candidate is usually known by a name different from that shown on his/her identity document, that candidate may include such different name as his/her alias. The name(s) (including alias(es)) of the candidate(s) as shown in the Notice of Valid Nominations will be printed on the ballot papers. According to section 19(3) and (4) of the Electoral Affairs Commission (Electoral Procedure) (District Councils) Regulation (Cap. 541F), the Returning Officer must send a notice of a decision that a person is validly nominated or is not validly nominated to the person concerned and each validly nominated candidate for the constituency concerned. Such a notice must be sent to the principal residential addresses of the person/candidate(s) concerned as given on their nomination forms.

7. 候選人可選擇在提名表格填寫其職業、任職公司／機構名稱及政治聯繫的資料，公眾將可查閱此等資料。

A candidate can choose to state his/her occupation, name of company/organisation and political affiliation in the nomination form, which will be available for public inspection.

8. 提名表格必須在提名期：2015年10月2日至2015年10月15日內（首尾兩天包括在內），除公眾假期外的任何日子，於通常辦公時間內（星期一至星期五：上午九時正至下午五時正；星期六：上午九時正至中午十二時正）由候選人親自送交有關的選舉主任（已向總選舉事務主任申請並獲批准以其他方式遞交者除外）。根據《選舉管理委員會（選舉程序）（區議會）規例》（第541F章）第2A(3)條，如提名期的最後一日適逢惡劣天氣警告日（在該工作日中，在通常辦公時間內的任何時間有烈風警告或暴雨警告生效；烈風警告及暴雨警告的涵義與該詞在《司法程序（烈風警告期間聆訊延期）條例》（第62章）中的涵義相同），提名期將會延長至並非惡劣天氣警告日的下一個工作日結束。除提名表格外，候選人須一併遞交選舉按金港幣3,000元，以現金或劃線支票／銀行本票（抬頭請寫「香港特別行政區政府」）支付。**為避免因支票遭銀行退票而令提名失效，候選人應盡量以現金或銀行本票支付選舉按金。**

A nomination form must be handed in by the candidate **in person** (except where the Chief Electoral Officer, on application, allows another means of delivery) and received by the relevant Returning Officer within the nomination period from 2 October 2015 to 15 October 2015 (both days inclusive) during ordinary business hours (Monday to Friday: from 9 am to 5 pm; Saturday: from 9 am to 12 noon) on any day other than a general holiday. According to section 2A(3) of the Electoral Affairs Commission (Electoral Procedure) (District Councils) Regulation (Cap. 541F), if the last day of the nomination period falls on an inclement weather warning day (a working day on which a gale warning or a rainstorm warning is in force at any time during ordinary business hours; gale warning and rainstorm warning have the same meaning as in the Judicial Proceedings (Adjournment During Gale Warnings) Ordinance (Cap. 62)), the period is extended to end on the next working day which is not an inclement weather warning day. The nomination form should be accompanied by an election deposit in the sum of HK\$3,000 in cash, or by crossed cheque/cashier order made payable to "The Government of the Hong Kong Special Administrative Region". **In order to avoid the risk of invalidation of the nomination due to dishonoured cheque, candidates are strongly advised to submit the election deposit in cash or by cashier order.**

9. 準候選人應盡早遞交提名表格，以便於提名期結束前，將提名表格上可能發現的錯處更正。
A prospective candidate is strongly advised to **submit his/her nomination form as early as practicable** so that any mistakes found in his/her nomination form can be rectified **before the end of nomination period.**

10. 任何提名表格所載候選人姓名或其他重要資料如經更改，將可能不被選舉主任接納。
The Returning Officer may not accept any nomination form on which the name or other important particulars of the candidate has/have been amended, altered or corrected.

11. 一般而言，除非選舉主任決定提名表格無效，否則獲提名的候選人即作為正式獲提名論，並可展開選舉活動。選舉主任所作的決定，將為最終決定，除以選舉呈請提出質疑外，不可循任何法律程序提出質疑。

Generally, unless the Returning Officer decides that a nomination form is invalid, the candidate is deemed to stand nominated and he/she may hence carry out activities to promote his/her election. The Returning Officer's decision on the validity of a nomination is final and cannot be questioned in any proceeding except by an election petition.

12. 提名表格必須按《區議會條例》（第547章）及《選舉管理委員會（選舉程序）（區議會）規例》（第541F章）的規定列載所需的資料，方才有效。在決定候選人是否合乎資格及其提名有效與否時，有關的選舉主任可要求候選人提供其認為需要的額外資料。

A nomination form will not be valid unless it contains the information as required in the District Councils Ordinance (Cap. 547) and the Electoral Affairs Commission (Electoral Procedure) (District Councils) Regulation (Cap. 541F). The Returning Officer concerned may request such other information from a candidate as he/she considers necessary to satisfy himself/herself as to the eligibility of the candidate and the validity of the nomination.

13. 候選人不得在2015年區議會一般選舉中在超過一個選區接受提名。候選人遞交提名表格時，必須已退出所有其他選區的選舉，否則，他／她其後所遞交的提名表格將被當作無效。

A candidate cannot be nominated for more than one constituency in the 2015 District Council Ordinary Election. When he/she hands in his/her nomination form, he/she must have withdrawn his/her candidature in respect of all other constituencies, if any, or else his/her latest nomination form will be treated as invalid.

14. 候選人如欲退出選舉，可填寫一份「候選人退選通知書」的指定表格（REO/C/5/2015DCE (SF)），並最遲於提名期結束前送遞予有關的選舉主任。

If a candidate wishes to withdraw his/her candidature, he/she may do so by completing and delivering to the Returning Officer concerned a “Notice of Withdrawal of Candidature” in a specified form (REO/C/5/2015DCE (SF)) before the end of nomination period.

The interpretation of “prescribed public officer”, qualifications and disqualifications for nomination as a candidate or election as an elected Member and the disqualifications for voting at an election are dealt with in sections 2, 20, 21 and 30 of the District Councils Ordinance (Cap. 547) which are reproduced below for reference –

釋義〔《區議會條例》（第547章）第2條〕

“訂明公職人員” (prescribed public officer) 指—

- (a) 公務員敍用委員會主席；或
- (b) 廉政專員、副廉政專員及擔任在《廉政公署條例》（第 204 章）下的任何其他職位的人；或
- (c) 申訴專員及根據《申訴專員條例》（第 397 章）第 6 條獲委任的人；或
- (d) 選舉管理委員會的成員；或
- (e) 金融管理局的行政總裁及該局的高層管理人員，包括科主管、行政總監、經理及該局僱用的律師；或
- (f) 個人資料私隱專員及其根據《個人資料（私隱）條例》（第 486 章）僱用或聘用的人；或

Interpretation (section 2 of the District Councils Ordinance (Cap. 547))

"prescribed public officer" (訂明公職人員) means any of the following—

- (a) the Chairman of the Public Service Commission; or
- (b) the Commissioner and Deputy Commissioner of the Independent Commission Against Corruption and the holder of any other office under the Independent Commission Against Corruption Ordinance (Cap. 204); or
- (c) The Ombudsman and the holder of any appointment under section 6 of The Ombudsman Ordinance (Cap. 397); or
- (d) a member of the Electoral Affairs Commission; or
- (e) the chief executive of the Monetary Authority and any member of the senior management of that Authority, including divisional heads, executive directors, managers and counsel employed by that Authority; or
- (f) the Privacy Commissioner for Personal Data and any person employed or engaged by him or her under the Personal Data (Privacy) Ordinance (Cap. 486); or
- (g) the Chairperson of the Equal Opportunities Commission and any person employed or whose services are engaged by the Commission under the Sex Discrimination Ordinance (Cap. 480); or
- (h) any person holding an office, whether permanent or temporary, in a Government department or bureau and employed in the department or bureau.

- (1) 符合以下條件的人方有資格在選舉中獲提名為候選人—

 - (b) 是一名選民；及

Who is eligible to be nominated as a candidate (section 20 of the District Councils Ordinance (Cap. 547))

- (1) A person is eligible to be nominated as a candidate at an election only if the person—
 - (a) has reached 21 years of age; and
 - (b) is an elector; and
 - (c) is not disqualified from voting at an election; and
 - (d) is not disqualified from being nominated as a candidate or elected as an elected member by virtue of section 21 or any other law; and
 - (e) has ordinarily resided in Hong Kong for the 3 years immediately preceding the nomination.
- (2) A person who holds office as a member of a District Council is not eligible to be nominated in a by-election as a candidate.
- (3) A person who holds office as the Chairman of a Rural Committee is not eligible to be nominated as a candidate at an election.
- (4) A person is not eligible to be nominated as a candidate for a constituency if the person is currently nominated as a candidate for another constituency.

 - (iii) 《防止賄賂條例》（第 201 章）第 II 部所訂的罪行；或
 - (iv) 根據《選舉管理委員會條例》（第 541 章）訂立並正有效的規例所訂明的任何罪行；或
 - (f) 因本條例或任何其他法律的施行而沒有資格擔任候選人或當選為民選議員；或
 - (g) 是香港以外地方的政府的代表或該政府的受薪政府人員；或
 - (h) 是香港以外任何地方的國家級、地區級或市級立法機關、議院或議會（中華人民共和國的全國或地方人民代表大會或人民協商機構除外）的成員；或
 - (i) 是未獲解除破產的人，或於過去 5 年內在沒有向債權人全數償還債務的情況下，獲解除破產或與其債權人訂立《破產條例》（第 6 章）所指的自願安排的人。

¹原訟法庭於 2012 年 6 月 21 日就黃軒璋及另一人訴律政司司長（高院憲法及行政訴訟 2012 年第 51 及 54 號）給予書面判詞，裁定《立法會條例》（第 542 章）第 39(1)(b)條（與《區議會條例》（第 547 章）第 21(1)(b)條相若）違憲。政府當局已於 2012 年 7 月 12 日宣布決定不會就有關判決提出上訴。日後的區議會選舉會按屆時生效的法例進行。任何人士如欲在區議會選舉獲提名為候選人，並對他／她的提名資格有疑問，他／她可徵詢獨立的法律意見，亦可根據現行選舉法例在 2015 年 9 月 30 日或之前向由選舉管理委員會委任的提名顧問委員會（區議會）申請提供意見。

When person is disqualified from being nominated as a candidate and from being elected as an elected member (section 21 of the District Councils Ordinance (Cap. 547))

- (1) A person is disqualified from being nominated as a candidate at an election, and from being elected as an elected member, if the person—
 - (a) is—
 - (i) a judicial officer; or
 - (ii) a prescribed public officer; or
 - (b) has, in Hong Kong, or any other place, been sentenced to death or imprisonment (by whatever name called) and has not either—
 - (i) served the sentence or undergone such other punishment as a competent authority may have substituted for the sentence; or
 - (ii) received a free pardon;¹ or
 - (c) has been convicted of treason; or
 - (d) on the date of nomination, or of the election, is serving a sentence of imprisonment; or
 - (e) without limiting paragraph (b), where the election is to be held or is held within 5 years after the date of the person's conviction, is or has been convicted—
 - (i) in Hong Kong or any other place, of an offence for which the person has been sentenced to imprisonment, whether suspended or not, for a term exceeding 3 months without the option of a fine; or
 - (ii) of having engaged in corrupt or illegal conduct in contravention of the Elections (Corrupt and Illegal Conduct) Ordinance (Cap. 554); or
 - (iii) of an offence against Part II of the Prevention of Bribery Ordinance (Cap. 201); or
 - (iv) of any offence prescribed by regulations in force under the Electoral Affairs Commission Ordinance (Cap. 541); or
 - (f) is ineligible to be a candidate or to be elected as an elected member because of the operation of this Ordinance or any other law; or
 - (g) is a representative or a salaried functionary of the government of a place outside Hong Kong; or
 - (h) is a member of any national, regional or municipal legislature, assembly or council of any place outside Hong Kong, other than a people's congress or people's consultative body of the People's Republic of China, whether established at the national level or local level; or
 - (i) is an undischarged bankrupt or, within the previous 5 years, has either obtained a discharge in bankruptcy or has entered into a voluntary arrangement within the meaning of the Bankruptcy Ordinance (Cap. 6) with the person's creditors, in either case without paying the creditors in full.

¹ The Court of First Instance delivered written judgment on 21 June 2012 on *Wong Hin Wai & another v Secretary for Justice* (HCAL 51&54/2012) and declared section 39(1)(b) of the Legislative Council Ordinance (Cap. 542) (which is similar to section 21(1)(b) of the District Councils Ordinance (Cap. 547)) to be unconstitutional. On 12 July 2012, the Administration announced its decision not to appeal against the judgment. The future District Council elections will be held in accordance with the prevalent electoral laws. Any person who would like to be nominated as a candidate for a District Council election and is doubtful about his/her eligibility for nomination may seek independent legal advice, and may also apply to the Nominations Advisory Committee (District Councils) appointed by the Electoral Affairs Commission for advice on or before 30 September 2015 in accordance with the electoral law.

- (2) A person is also disqualified from being nominated as a candidate at an election if the person is found under the Mental Health Ordinance (Cap. 136) to be incapable, by reason of mental incapacity, of managing and administering his or her property and affairs, but a person disqualified under this subsection is eligible for nomination as a candidate if, under that Ordinance, it is subsequently found that the person has become capable of managing and administering his or her property and affairs.
- (3) A person is also disqualified from being elected as an elected member if the person is found under the Mental Health Ordinance (Cap. 136) to be incapable, by reason of mental incapacity, of managing and administering his or her property and affairs, but a person disqualified under this subsection ceases to be disqualified if, under that Ordinance, it is subsequently found that the person has become capable of managing and administering his or her property and affairs.

- (a) has ceased to be eligible to be registered as an elector under the Legislative Council Ordinance (Cap. 542); or
- (b)-(d) (Repealed 7 of 2009 s. 9)
- (e) is found under the Mental Health Ordinance (Cap. 136) to be incapable, by reason of mental incapacity, of managing and administering his or her property and affairs; or
- (f) is a member of the armed forces of the Central People's Government or any other country or territory.
