In respect of the election advertisements which cannot be practically or conveniently produced in specie, 2 identical full colour photographs/printouts/photocopies of each election advertisement together with 1 copy of the information sheet, consent and/or permission must be provided. The candidate must ensure that the election advertisement particulars submitted comply with the rules and requirements as set out in section 106 of the Electoral Affairs Commission (Electoral Procedure) (District Councils) Regulation (Cap. 541F), and Chapter 7 of the "Guidelines on Election-related Activities in respect of the District Council Election".
