Failure to comply with this requirement would cause a delay in checking the candidate's identity document or require him/her to return to the office of the Returning Officer for the relevant constituency for rectification. If the Returning Officer for the relevant constituency is satisfied that the candidate is usually known by a name different from that shown on his/her Hong Kong Identity Card, that candidate may include such different name as his/her alias. If necessary, candidate may use the "2023 District Council Ordinary Election Supplementary Sheet for Subscribers – District Committees constituency" (Form no.: REO/N/2023DC(SF) (Supplementary sheet for DCC subscribers)). Each supplementary sheet should be marked with a consecutive sub-page number according to the District Committee the subscriber belongs to. All pages (including all supplementary sheets of pages 5 to 7) of this form must be submitted to the Returning Officer for relevant constituency in one complete set. Candidate should check the eligibility of the subscribers and remind each subscriber to personally sign this form. If for any reason a subscriber is found not to be qualified to subscribe the nomination form, his/her subscription will be disregarded. Candidate should also remind each subscriber to provide the name as shown on his/her identity document (being the identity document based on which the particulars of the subscriber are recorded in the geographical constituencies final register).

According to section 2A(3) of the Electoral Affairs Commission (Electoral Procedure) (District Councils) Regulation (Cap. 541F), if the last day of the nomination period falls on an inclement weather warning day (a working day on which a gale warning or a rainstorm warning is in force at any time during ordinary business hours; gale warning and rainstorm warning have the same meaning as in the Judicial Proceedings (Adjournment During Gale Warnings) Ordinance (Cap. 62)), the nomination period will be extended to end on the next working day which is not an inclement weather warning day. - 12. 準候選人<u>應盡早呈交提名表格</u>,以便於<u>提名期結束前</u>,適時更正在其提名表格上發現的任何錯處。 A prospective candidate is strongly advised to <u>submit his/her nomination form as early as practicable</u> so that any mistakes found in his/her nomination form can be rectified before the end of nomination period.
- 13. 任何提名表格所載候選人姓名或其他重要資料如經更改,將可能不會被有關選區的選舉主任接納。
  The Returning Officer for the relevant constituency may not accept any nomination form on which the name or other important particulars of the candidate has/have been amended, altered or corrected.
- 14. 區議會資格審查委員會就提名是否有效所作的決定,除以選舉呈請提出質疑外,不可循任何法律程序 提出質疑。
  - The District Council Eligibility Review Committee's decision on the validity of a nomination cannot be questioned in any proceeding except by an election petition.
- 15. 提名表格必須按《區議會條例》(第547章)及《選舉管理委員會(選舉程序)(區議會)規例》(第541F章)(下稱《規例》)的規定列載所需的資料,提名方才有效。根據《規例》第12(10)條,有關選區的選舉主任可要求候選人提供選舉主任認為就下述目的而屬適當的任何其他資料:為使區議會資格審查委員會信納(a)該候選人有資格獲提名為有關選區的候選人;或(b)其他關於提名是否有效的事宜。另外,根據《規例》第16(3A)(b)條,區議會資格審查委員會在決定某候選人是否就某選區獲有效提名時,亦可要求該候選人提供該委員會認為適當的任何其他資料,以令該委員會信納(i)該候選人有資格獲提名為有關選區的候選人;或(ii)其他關於提名是否有效的事宜。若區議會資格審查委員會要求候選人提供資料,候選人應以委員會所指明的方式向委員會提交有關資料。

A nomination will not be valid unless the nomination form contains the information as required in the District Councils Ordinance (Cap. 547) and the Electoral Affairs Commission (Electoral Procedure) (District Councils) Regulation (Cap. 541F) ("the Regulation"). According to section 12(10) of the Regulation, the Returning Officer for the relevant constituency may require a candidate to furnish any other information that the Returning Officer considers appropriate for enabling the District Council Eligibility Review Committee to be satisfied (a) that the candidate is eligible to be nominated as a candidate for a constituency; or (b) otherwise as to the validity of the nomination. In addition, according to section 16(3A)(b) of the Regulation, in deciding whether a candidate is validly nominated for a constituency, the District Council Eligibility Review Committee may

require the candidate to furnish any other information the Committee considers appropriate to be satisfied (i) that the candidate is eligible to be nominated as a candidate for the constituency concerned; or (ii) otherwise as to the validity of the nomination. If the District Council Eligibility Review Committee requires such information from the candidate, the candidate should provide the same to the Committee in accordance with the manner specified by the Committee.

16. 候選人不得在2023年區議會一般選舉中在多於一(1)個界別或選區接受提名。候選人呈交提名表格時,必須已撤回所有其他界別或選區的提名(如有的話),否則,他/她其後所呈交的提名表格將被當作無效。

A candidate cannot be nominated for more than one (1) constituency in the 2023 District Council Ordinary Election. When he/she submits his/her nomination form, he/she must have withdrawn his/her nomination in respect of all other constituencies, if any, otherwise his/her nomination form subsequently submitted will be treated as invalid.

- 17. 根據《選舉管理委員會(選舉程序)(區議會)規例》(第541F章)第104(1)、(4)及(5)條,任何人在 與選舉有關的文件中作出他/她明知在要項上屬虛假的陳述,或任何人罔顧後果地在該等文件中作出 在要項上不正確的陳述,或任何人明知而在該等文件中遺漏任何要項,均屬犯罪。第104條所訂的罪 行是為施行《區議會條例》(第547章)第21及26A條而訂明的罪行。與選舉有關的文件指為施行《選 舉管理委員會(選舉程序)(區議會)規例》而規定或使用的表格、格式、聲明(第102條所指的聲 明除外)、宣布、申請、授權書、通知、公告、陳述、報表或提名表格。
  - In accordance with section 104(1), (4) and (5) of the Electoral Affairs Commission (Electoral Procedure) (District Councils) Regulation (Cap. 541F), a person who, in an election related document, makes a statement which that person knows to be false in a material particular or recklessly makes a statement which is incorrect in a material particular or knowingly omits a material particular from an election related document commits an offence. An offence under section 104 is an offence prescribed for the purposes of sections 21 and 26A of the District Councils Ordinance (Cap. 547). Election related document means a form, declaration (other than a declaration under section 102), application, authorization, notice, statement or a nomination form required or used for the purposes of the Electoral Affairs Commission (Electoral Procedure) (District Councils) Regulation.
- 18. 候選人如欲撤回提名,他/她可填寫「<u>候選人退選通知書</u>」的指明表格(REO/C/5/2023DCE(SF)), 並於提名期結束前送遞予有關選區的選舉主任。
  - If a candidate wishes to withdraw his/her nomination, he/she may do so by completing and delivering to the Returning Officer for the relevant constituency a "Notice of Withdrawal of Candidature" in a specified form (REO/C/5/2023DCE(SF)) before the end of nomination period.
- 19. 本提名表格第二部分必須<u>於見證人在場下</u>由候選人填寫及簽署。任何年滿18歲並持有身分證明文件的人士均可擔任見證人。見證人必須填寫及簽署本提名表格第三部分。根據《區議會條例》 (第547章)第2條,「身分證明文件」(identity document)指—
  - PART II of this nomination form should be completed and signed by a candidate <u>in the presence of a witness</u> who can be any person who is in possession of an identity document and aged 18 years or over. The witness is required to complete PART III of this nomination form and sign thereunder. According to section 2 of the District Councils Ordinance (Cap. 547), "identity document" (身分證明文件) means—
  - (a) 根據《人事登記條例》(第 177 章)向某人發出的身分證;或 an identity card issued to a person under the Registration of Persons Ordinance (Cap. 177); or
  - (b) 《人事登記條例》(第 177 章)第 1A(1)條所指的人事登記處處長向某人發出的文件,而該文件證明該人根據《人事登記規例》(第 177A章)第 25 條獲豁免,無須根據該條例登記;或 a document issued by the Commissioner of Registration (within the meaning of section 1A(1) of the Registration of Persons Ordinance (Cap. 177)) to a person certifying that the person is exempt, under regulation 25 of the Registration of Persons Regulations (Cap. 177A), from being required to register under that Ordinance; or
  - (c) 向某人發出的獲選舉登記主任接受為該人的身分證明的任何其他文件。 any other document issued to a person that is acceptable to the Electoral Registration Officer as proof of the person's identity.
- 20. 如有任何關於填寫提名表格的查詢,請與有關選區的選舉主任聯絡或致電選舉事務處查詢熱線 2891 1001。
  - For enquiries concerning the completion of the nomination form, please contact the Returning Officer for the relevant constituency or call the Enquiry Hotline of the Registration and Electoral Office at 2891 1001.

21. 根據《區議會條例》(第547章)第2、20、21、30及34條,有關訂明公職人員的釋義、獲提名為候選人的資格、喪失獲提名為候選人及當選為議員的資格的情況、選民喪失在選舉中投票的資格的情況及 獲提名為候選人須遵從的規定載列如下,以作參考-

The interpretation of "prescribed public officer", the eligibility for being nominated as a candidate, the disqualification from being nominated as a candidate and from being elected as a member, the disqualification from voting at an election, and the requirements to be complied with by persons nominated as candidates are dealt with in sections 2, 20, 21, 30 and 34 of the District Councils Ordinance (Cap. 547) which are reproduced below for reference –

「訂明公職人員」(prescribed public officer) 指一

- (a) 公務員敍用委員會主席;或
- (b) 廉政專員、副廉政專員及擔任在《廉政公署條例》(第 204 章)下的任何其他職位的 人;或
- (c) 申訴專員及根據《申訴專員條例》(第397章)第6條獲委任的人;或
- (d) 選舉管理委員會的成員;或
- (e) 金融管理局的行政總裁及該局的高層管理人員,包括科主管、行政總監、經理及該局 僱用的律師;或
- (f) 個人資料私隱專員及其根據《個人資料(私隱)條例》(第 486 章)僱用或聘用的 人;或
- (g) 平等機會委員會的主席及由該委員會根據《性別歧視條例》(第 480 章)僱用或聘用 的人;或
- (h) 受僱於政府部門或政策局而在該政府部門或政策局任職(不論該職位屬永久性或臨時性的)的人。

# Interpretation (section 2 of the District Councils Ordinance (Cap. 547))

"prescribed public officer" (訂明公職人員) means any of the following-

- (a) the Chairman of the Public Service Commission; or
- (b) the Commissioner and Deputy Commissioner of the Independent Commission Against Corruption and the holder of any other office under the Independent Commission Against Corruption Ordinance (Cap. 204); or
- (c) The Ombudsman and the holder of any appointment under section 6 of The Ombudsman Ordinance (Cap. 397); or
- (d) a member of the Electoral Affairs Commission; or
- (e) the chief executive of the Monetary Authority and any member of the senior management of that Authority, including divisional heads, executive directors, managers and counsel employed by that Authority; or
- (f) the Privacy Commissioner for Personal Data and any person employed or engaged by him or her under the Personal Data (Privacy) Ordinance (Cap. 486); or
- (g) the Chairperson of the Equal Opportunities Commission and any person employed or whose services are engaged by the Commission under the Sex Discrimination Ordinance (Cap. 480); or
- (h) any person holding an office, whether permanent or temporary, in a Government department or bureau and employed in the department or bureau.

## 獲提名為候選人的資格〔《區議會條例》(第547章)第20條〕

- (1) 符合以下條件的人方有資格在選舉中獲提名為候選人-
  - (a) 年滿 21 歲;及
  - (b) 已在現有的地方選區選民登記冊內登記為選民;及
  - (c) 並無喪失在選舉中投票的資格;及
  - (d) 並無憑藉第21條或任何其他法律喪失獲提名為候選人或當選為議員的資格;及
  - (e) 在緊接提名前的 3 年內通常在香港居住。
- (2) 擔任區議會議員的人並無資格在補選中獲提名為候選人。
- (3) 擔任鄉事委員會主席的人並無資格在選舉中獲提名為候選人。
- (4) 任何人如獲提名為某界別或選區的候選人,則並無資格同時獲提名為另一界別或選區的候選人。

### Who is eligible to be nominated as a candidate (section 20 of the District Councils Ordinance (Cap. 547))

- (1) A person is eligible to be nominated as a candidate at an election only if the person—
  - (a) has reached 21 years of age; and
  - (b) is registered as an elector in the existing GC register; and
  - (c) is not disqualified from voting at an election; and
  - (d) is not disqualified from being nominated as a candidate or elected as a member by virtue of section 21 or any other law; and
  - (e) has ordinarily resided in Hong Kong for the 3 years immediately preceding the nomination.
- (2) A person who holds office as a member of a District Council is not eligible to be nominated in a by-election as a candidate.
- (3) A person who holds office as the Chairman of a Rural Committee is not eligible to be nominated as a candidate at an election.
- (4) A person is not eligible to be nominated as a candidate for a constituency if the person is currently nominated as a candidate for another constituency.

# 喪失獲提名為候選人及當選為議員的資格的情況〔《區議會條例》(第547章)第21條〕

- (1) 任何人如有以下情況,即喪失在選舉中獲提名為候選人的資格及於選舉當選為議員的 資格-
  - (a) 是一
    - (i) 司法人員;或

  - (b) 已在香港或任何其他地方被判處死刑或監禁(不論如何稱述),但-
    - (i) 既未服該刑罰或主管當局用以替代該項刑罰的其他懲罰;而
    - (ii) 亦未獲赦免<sup>2</sup>;或
  - (c) 已被裁定犯叛逆罪;或
  - (d) 在提名當日或選舉當日,正因服刑而受監禁;或
  - (e) 在不局限(b)段的原則下,被裁定或曾被裁定犯以下罪行,而選舉於或將於其被定罪的日期後的5年內舉行—
    - (i) 任何罪行(不論是在香港或是在任何其他地方被定罪),並就該罪行被判處 為期超逾3個月而又不得選擇以罰款代替的監禁(不論是否獲得緩刑);或
    - (ii) 作出舞弊或非法行為;或
    - (iii) 《防止賄賂條例》(第201章)第II部所訂的罪行;或
    - (iv) 附表 4A 第 7 條或根據《選舉管理委員會條例》(第 541 章)訂立並正有效的 規例所訂明的任何罪行;或
  - (f) 因本條例或任何其他法律的施行而沒有資格擔任候選人或於選舉當選為議員;或
  - (g) 是香港以外地方的政府的代表或該政府的受薪政府人員;或
  - (h) 是香港以外任何地方的國家級、地區級或市級立法機關、議院或議會(中華人民 共和國的全國或地方人民代表大會或人民協商機構除外)的成員;或
  - (i) 是未獲解除破產的人,或於過去 5 年內在沒有向債權人全數償還債務的情況下, 獲解除破產或與其債權人訂立《破產條例》(第6章)所指的自願安排的人。
- (1A) 任何人如有以下情况,亦即喪失在選舉中獲提名為候選人及於選舉當選為議員的資格-
  - (a) 該人因拒絕或忽略作出指明誓言而根據法律離任,或喪失就任的資格,而選舉於或將於該人離任或喪失資格的日期後的5年內舉行;或
  - (b) 該人被按照任何法律宣告、宣布或裁定為-
    - (i) 違反指明誓言;或
    - (ii) 不符合擁護《基本法》、效忠中華人民共和國香港特別行政區的法定要求和 條件,

而選舉於或將於作出該項宣告、宣布或裁定的日期後的5年內舉行。

# When person is disqualified from being nominated as a candidate and from being elected as a member (section 21 of the District Councils Ordinance (Cap. 547))

- (1) A person is disqualified from being nominated as a candidate at an election, and from being elected as a member at an election, if the person—
  - (a) is-
    - (i) a judicial officer; or
    - (ii) a prescribed public officer; or
  - (b) has, in Hong Kong, or any other place, been sentenced to death or imprisonment (by whatever name called) and has not either
    - (i) served the sentence or undergone such other punishment as a competent authority may have substituted for the sentence; or
    - (ii) received a free pardon<sup>2</sup>; or
  - (c) has been convicted of treason; or
  - (d) on the date of nomination, or of the election, is serving a sentence of imprisonment; or
  - (e) without limiting paragraph (b), where the election is to be held or is held within 5 years after the date of the person's conviction, is or has been convicted—
    - (i) in Hong Kong or any other place, of an offence for which the person has been sentenced to imprisonment, whether suspended or not, for a term exceeding 3 months without the option of a fine; or
    - (ii) of having engaged in corrupt or illegal conduct; or
    - (iii) of an offence against Part II of the Prevention of Bribery Ordinance (Cap. 201); or
    - (iv) of any offence prescribed by section 7 of Schedule 4A or regulations in force under the Electoral Affairs Commission Ordinance (Cap. 541); or
  - (f) is ineligible to be a candidate or to be elected as a member at an election because of the operation of this Ordinance or any other law; or
  - (g) is a representative or a salaried functionary of the government of a place outside Hong Kong; or
  - (h) is a member of any national, regional or municipal legislature, assembly or council of any place outside Hong Kong, other than a people's congress or people's consultative body of the People's Republic of China, whether established at the national level or local level; or
  - (i) is an undischarged bankrupt or, within the previous 5 years, has either obtained a discharge in bankruptcy or has entered into a voluntary arrangement within the meaning of the Bankruptcy Ordinance (Cap. 6) with the person's creditors, in either case without paying the creditors in full.
- (1A) A person is also disqualified from being nominated as a candidate at an election, and from being elected as a member at an election, if the election is held or is to be held within 5 years after—
  - (a) the date on which the person vacates an office, or is disqualified from entering on an office, under the law, for declining or neglecting to take a specified oath; or
  - (b) the date on which the person is declared or decided in accordance with any law-
    - (i) to be in breach of a specified oath; or
    - (ii) to have failed to fulfil the legal requirements and conditions on upholding the Basic Law and bearing allegiance to the Hong Kong Special Administrative Region of the People's Republic of China.

- (3) A person is also disqualified from being elected as a member at an election if the person is found under the Mental Health Ordinance (Cap. 136) to be incapable, by reason of mental incapacity, of managing and administering his or her property and affairs, but a person disqualified under this subsection ceases to be disqualified if, under that Ordinance, it is subsequently found that the person has become capable of managing and administering his or her property and affairs.
- (4) (Repealed 19 of 2023 s. 22)

# 選民喪失在選舉中投票的資格的情況〔《區議會條例》(第547章)第30條〕

- (1) 任何選民如有以下情況,即喪失在選舉中投票的資格-
  - (a) 已不再有資格根據《立法會條例》(第542章)登記為選民;或
  - (b)-(d) (由 2009 年第 7 號第 9 條廢除)
    - (e) 根據《精神健康條例》(第 136 章)被裁斷為因精神上無行為能力而無能力處理 和管理其財產及事務;或
    - (f) 是中央人民政府或任何其他國家或地區的武裝部隊的成員。
- (2) 如某地區委員會界別的選民不再擔任有關地方行政區的地區委員會的委員,該選民亦即喪失在該界別的選舉中投票的資格。

# When an elector is disqualified from voting at an election (section 30 of the District Councils Ordinance (Cap. 547))

- (1) An elector is disqualified from voting at an election if the elector—
  - (a) has ceased to be eligible to be registered as an elector under the Legislative Council Ordinance (Cap. 542); or
  - (b)-(d) (Repealed 7 of 2009 s. 9)
    - (e) is found under the Mental Health Ordinance (Cap. 136) to be incapable, by reason of mental incapacity, of managing and administering his or her property and affairs; or
    - (f) is a member of the armed forces of the Central People's Government or any other country or territory.
- (2) An elector of a District Committees constituency is also disqualified from voting at an election for the constituency if the elector has ceased to be a member of a District Committee in the District concerned.

- (1) 凡任何人擬在選舉中獲提名為候選人,該人須按照本條及根據《選舉管理委員會條例》 (第 541 章)訂立並正有效的規例,呈交提名表格。
- (1A) 提名表格須一
  - (a) 按照《規例》獲提名人簽署;
  - (b) 附有按金;及
  - (c) 載有或附有有關人士的聲明,示明該人會擁護《基本法》和保證效忠中華人民共和國香港特別行政區。
  - (2) 按金的款額為《規例》為施行本條而訂明者。

# What requirements are to be complied with by persons nominated as candidates (section 34 of the District Councils Ordinance (Cap. 547))

- (1) A person is to be nominated as a candidate for an election by submitting a nomination form in accordance with this section and regulations in force under the Electoral Affairs Commission Ordinance (Cap. 541).
- (1A) The nomination form must-
  - (a) be subscribed in accordance with the regulations;
  - (b) be accompanied by a deposit; and
  - (c) include or be accompanied by a declaration by the person to the effect that the person will uphold the Basic Law and pledge allegiance to the Hong Kong Special Administrative Region of the People's Republic of China.

- (2) The deposit is to be of such an amount as is prescribed by the regulations for the purposes of this section.
- 22. 根據《選舉管理委員會(選舉程序)(區議會)規例》(第541F章)第16(3A)(a)及(3B)條,區議會資格審查委員會可要求選舉主任就下列指明事宜向該委員會提供意見:

In accordance with sections 16(3A)(a) and (3B) of the Electoral Affairs Commission (Electoral Procedure) (District Councils) Regulation (Cap. 541F), the District Council Eligibility Review Committee may require the Returning Officer to advise the Committee on any of the matters specified below:

- (a) 選舉主任認為第 12 條是否就有關候選人而獲遵從; whether, in the opinion of the Returning Officer, section 12 is complied with in relation to the candidate;
- (b) 在第(3C)款的規限下,選舉主任認為《區議會條例》(第 547 章)第 20、21 及 34 條是否就該候選人而獲遵從;

subject to subsection (3C), whether, in the opinion of the Returning Officer, sections 20, 21 and 34 of the District Councils Ordinance (Cap. 547) are complied with in relation to the candidate;

- (c) 選舉主任認為該候選人的提名表格是否有效; whether, in the opinion of the Returning Officer, the nomination form of the candidate is valid;
- (d) 該候選人是否已在有關界別或選區的選舉中退選; whether the candidate has withdrawn candidature for that constituency;
- (e) 在該候選人的提名表格上簽署為提名人而其資格是符合《區議會(提名所需的選舉按金及簽署人)規例》(第 547A 章)所訂的以提名人身分簽署提名表格的資格的人,是否已達訂明數目; whether the nomination form of the candidate has been signed by the prescribed number of subscribers qualified to subscribe to the nomination form under the District Councils (Subscribers and Election Deposit for Nomination) Regulation (Cap. 547A);
- (f) 該候選人的提名表格是否已按本規例的規定填寫或簽署; whether the nomination form of the candidate has been completed or signed as required under this Regulation;
- (g) 選舉主任認為 in the opinion of the Returning Officer—
  - (i) 根據《區議會條例》(第 547 章),該候選人是否有資格獲提名為候選人;及 whether the candidate is eligible to be nominated as a candidate under the District Councils Ordinance (Cap. 547); and
  - (ii) 根據該條例,該候選人是否喪失獲提名為候選人的資格; whether the candidate is disqualified from being nominated as a candidate under that Ordinance;
- (h) 該候選人是否在同一選舉中,已在另一界別或選區中獲提名;如是,該候選人是否已在該另一界 別或撰區的撰舉中退撰;

whether the candidate has been nominated for another constituency in the same election and, if so, whether the other candidature has been withdrawn;

- (i) 該候選人是否已繳存適當的按金;及 whether the candidate has lodged the appropriate deposit; and
- (j) 根據選舉主任所得的資料,該候選人是否已去世。 whether, according to the information available to the Returning Officer, the candidate is dead.

In accordance with section 34(1A)(c) of the District Councils Ordinance (Cap. 547), a candidate must declare in the nomination form that he/she will uphold the Basic Law and pledge allegiance to the Hong Kong Special Administrative Region of the People's Republic of China. Upholding the Basic Law means to uphold all the provisions of the Basic Law, including the following provisions –

#### 第一條

香港特別行政區是中華人民共和國不可分離的部分。

#### Article 1

The Hong Kong Special Administrative Region is an inalienable part of the People's Republic of China.

### 第十二條

香港特別行政區是中華人民共和國的一個享有高度自治權的地方行政區域,直轄於中央 人民政府。

#### Article 12

The Hong Kong Special Administrative Region shall be a local administrative region of the People's Republic of China, which shall enjoy a high degree of autonomy and come directly under the Central People's Government.

## 第一百五十九(四)條

本法的任何修改,均不得同中華人民共和國對香港既定的基本方針政策相抵觸。

#### Article 159(4)

No amendment to this Law shall contravene the established basic policies of the People's Republic of China regarding Hong Kong.

A person upholds the Basic Law and bears allegiance to the Hong Kong Special Administrative Region of the People's Republic of China ("HKSAR") if the positive list is satisfied; and that the person does not uphold the Basic Law and bear allegiance to the HKSAR if the person does or intends to do any of the things set out in the negative list. Section 3AA of the Interpretation and General Clauses Ordinance (Cap. 1) is reproduced below -

- (1) 就施行條例而言,任何人如一
  - (a) 擁護《中華人民共和國憲法》及《基本法》確立的香港特別行政區的憲制秩序;

  - (c) 擁護-
    - (i) 香港特別行政區是中華人民共和國不可分離的部分;
    - (ii) 中華人民共和國對香港特別行政區行使主權;及
    - (iii) 中央根據《基本法》對香港特別行政區行使管治權力;
  - (d) 擁護"一國兩制"原則的落實,維護香港特別行政區的政治體制;
  - (e) 擁護在《基本法》的框架下,保持香港特別行政區繁榮穩定的目的;及
  - (f) 忠於香港特別行政區,維護香港特別行政區的利益,

即屬擁護《基本法》、效忠中華人民共和國香港特別行政區。

- (2) 在第(1)款中,提述擁護,即提述在意圖上及言行上均真心地及真誠地遵守、支持、維護及 信奉。
- (3) 就施行條例而言,任何人當作出或意圖作出以下任何行為時,不屬擁護《基本法》、效忠 中華人民共和國香港特別行政區 —
  - (a) 作出或進行危害國家安全的行為或活動,包括—
    - (i) 作出《基本法》第23條規定禁止的行為;
    - (ii) 犯《中華人民共和國香港特別行政區維護國家安全法》規定的罪行;及
    - (iii) 犯成文法則或普通法規定的關於危害國家安全的罪行;
  - (b) 拒絕承認中華人民共和國對香港特別行政區擁有並行使主權,包括反對中央政權機關按照—
    - (i) 《中華人民共和國憲法》;
    - (ii) 《基本法》;或
    - (iii) 《中華人民共和國香港特別行政區維護國家安全法》,

履行職務和職能;

- (c) 拒絕承認香港特別行政區作為中華人民共和國一個地方行政區域的憲制地位;
- (d) 宣揚或支持"港獨"主張,包括—
  - (i) 主張、推動或實施香港"獨立建國";
  - (ii) 參與以"香港獨立"為宗旨的組織;
  - (iii) 主張、推動或實施"自決主權或治權"、"全民公投"、"全民制憲"等活動,或參與以"自決"為宗旨的組織;及
  - (iv) 主張或推動香港轉歸外國統治;
- (e) 尋求外國政府或組織干預香港特別行政區的事務;
- (f) 作出損害或有傾向損害《基本法》中以行政長官為主導的政治體制秩序的行為,包括—

- (i) 以非法手段強迫或威嚇行政長官改變某項政策或提交立法會審議的議案;
- (ii) 無差別地反對特區政府提出的議案,並—
  - (A) 意圖以此要脅特區政府;
  - (B) 意圖以此使特區政府無法正常履行職務和職能;或
  - (C) 意圖以此逼使行政長官下台及推翻特區政府;及
- (iii) 利用特區政府舉行的選舉,組織或實施(或煽動他人組織或實施)任何形式的對抗中央人民政府和特區政府的"變相公投";
- (g) 作出損害或有傾向損害香港特別行政區的整體利益的行為;
- (h) 公開及故意以焚燒、毀損、塗劃、玷污、踐踏等方式侮辱國旗或國徽或區旗或區徽;
- (i) 侮辱或貶損國歌或國家主權的任何其他象徵和標誌。
- (4) 就施行條例而言,本條並不局限對擁護《基本法》、效忠中華人民共和國香港特別行政區的提述的涵義。

# References to upholding Basic Law and bearing allegiance to HKSAR (section 3AA of the Interpretation and General Clauses Ordinance (Cap. 1))

- (1) For the purposes of an Ordinance, a person upholds the Basic Law and bears allegiance to the Hong Kong Special Administrative Region of the People's Republic of China if the person -
  - (a) upholds the constitutional order of the Hong Kong Special Administrative Region established by the Constitution of the People's Republic of China and the Basic Law;
  - (b) upholds the national sovereignty, unity, territorial integrity and national security of the People's Republic of China;
  - (c) upholds -
    - (i) the fact that the Hong Kong Special Administrative Region is an inalienable part of the People's Republic of China;
    - (ii) the People's Republic of China's exercise of sovereignty over the Hong Kong Special Administrative Region; and
    - (iii) the Central Authorities' exercise of governance over the Hong Kong Special Administrative Region under the Basic Law;
  - (d) upholds the implementation of "one country, two systems" principle, and safeguards the political structure of the Hong Kong Special Administrative Region;
  - (e) upholds the objective to maintain the prosperity and stability of the Hong Kong Special Administrative Region within the framework of the Basic Law; and
  - (f) is loyal to, and safeguards the interests of, the Hong Kong Special Administrative Region.
- (2) In subsection (1), a reference to uphold is a reference to intend to genuinely and truthfully observe, support, maintain and embrace, and genuinely and truthfully observe, support, maintain and embrace in words and deeds.
- (3) For the purposes of an Ordinance, a person does not uphold the Basic Law and bear allegiance to the Hong Kong Special Administrative Region of the People's Republic of China when the person does, or intends to do, any of the following
  - (a) commits acts or carries out activities that endanger national security, including
    - (i) commits an act required by Article 23 of the Basic Law to be prohibited;
    - (ii) commits an offence under the Law of the People's Republic of China on Safeguarding National Security in the Hong Kong Special Administrative Region (a translation of "《中華人民共和國香港特別行政區維護國家安全法》"); and
    - (iii) commits an offence relating to endangering national security under an enactment or under the common law;
  - (b) refuses to recognize the People's Republic of China's sovereignty over the Hong Kong Special Administrative Region and the exercise of the sovereignty, including objecting to the performance of duties and functions by the body of central power in accordance with
    - (i) the Constitution of the People's Republic of China;
    - (ii) the Basic Law; or
    - (iii) the Law of the People's Republic of China on Safeguarding National Security in the Hong Kong Special Administrative Region (a translation of "《中華人民共和國香港特別行政區維護國家安全法》");
  - (c) refuses to recognize the constitutional status of the Hong Kong Special Administrative Region as a local administrative region of the People's Republic of China;
  - (d) advocates or supports "Hong Kong independence", including
    - (i) pursues, promotes or implements "independence and state-building" of Hong Kong;
    - (ii) participates in an organization the object of which is "Hong Kong independence";
    - (iii) pursues, promotes or implements an activity for "self-determination of sovereignty or

jurisdiction", "referendum" or "devising constitution by all people", or participates in an organization the object of which is "self-determination"; and

- (iv) pursues or promotes the reign over Hong Kong to be transferred to a foreign country;
- (e) solicits interference by foreign governments or organizations in the affairs of the Hong Kong Special Administrative Region;
- (f) commits acts that undermine or have a tendency to undermine the order of the political structure led by the Chief Executive, contained in the Basic Law, including—
  - (i) compels or overawes the Chief Executive by any unlawful means to change a policy, or a motion to be submitted to the Legislative Council for consideration;
  - (ii) indiscriminately objects to the Government's motion, and with this
    - (A) intends to threaten the Government;
    - (B) intends to render the Government incapable of performing its duties and functions as normal; or
    - (C) intends to force the Chief Executive to step down and to overthrow the Government; and
  - (iii) makes use of an election held by the Government to organize or implement, or to incite another person to organize or implement, a "de facto referendum" in any form to confront the Central People's Government and the Government;
- (g) commits acts that undermine or have a tendency to undermine the overall interests of the Hong Kong Special Administrative Region;
- (h) desecrates the national flag or national emblem, or regional flag or regional emblem, by publicly and wilfully burning, mutilating, scrawling on, defiling or trampling on it;
- (i) insults or disrespects the national anthem or any other symbol and sign of national sovereignty.
- (4) For the purposes of an Ordinance, this section does not limit the meaning of a reference to upholding the Basic Law and bearing allegiance to the Hong Kong Special Administrative Region of the People's Republic of China.
