However, no legal proceedings may be instituted in respect of a decision made by the Candidate Eligibility Review Committee pursuant to the opinion of the Committee for Safeguarding National Security of the Hong Kong Special Administrative Region.

According to section 8(10) of the Regulation, the Returning Officer for the relevant subsector may require a person who is being nominated as a candidate to furnish any other information that the Officer considers appropriate for enabling the Candidate Eligibility Review Committee to be satisfied (a) that the person is eligible to be nominated as a candidate for the subsector concerned; or (b) otherwise as to the validity of the nomination. In addition, according to section 13(3A)(b) of that Regulation, in deciding whether a candidate is validly nominated for a subsector, the Candidate Eligibility Review Committee may require the candidate to furnish any other information that the Committee considers appropriate for enabling the Committee to be satisfied as to the validity of the nomination. If the Candidate Eligibility Review Committee requires such information from the candidate, the candidate should provide the same to the Committee in accordance with the manner specified by the Committee.

A candidate cannot be:

- (b) a nominee selected by a designated body under section 7(1) of the Schedule to the Chief Executive Election Ordinance (Cap. 569).

According to section 1(3)(b) of the Schedule to the Chief Executive Election Ordinance (Cap. 569), the circumstances in which a person has a substantial connection with an Election Committee subsector include, but are not limited to, being a member, partner, officer or employee of a body included in the subsector or of a corporate member of such a body. No amendment to this Law shall contravene the established basic policies of the PRC regarding Hong Kong.

- (a) upholds the constitutional order of the HKSAR established by the Constitution of the PRC and the Basic Law;
- (b) upholds the national sovereignty, unity, territorial integrity and national security of the PRC;
- (c) upholds —
 - (i) the fact that the HKSAR is an inalienable part of the PRC;
 - (ii) the PRC’s exercise of sovereignty over the HKSAR; and
 - (iii) the Central Authorities’ exercise of governance over the HKSAR under the Basic Law;
- (d) upholds the implementation of “one country, two systems” principle, and safeguards the political structure of the HKSAR;
- (e) upholds the objective to maintain the prosperity and stability of the HKSAR within the framework of the Basic Law; and
- (f) is loyal to, and safeguards the interests of, the HKSAR.

- (f) 作出損害或有傾向損害《基本法》中以行政長官為主導的政治體制秩序的行為，包括 —

- (3) For the purposes of an Ordinance, a person does not uphold the Basic Law and bear allegiance to the HKSAR of the PRC when the person does, or intends to do, any of the following –
 - (a) commits acts or carries out activities that endanger national security, including –
 - (i) commits an act required by Article 23 of the Basic Law to be prohibited;
 - (ii) commits an offence under the Law of the People’s Republic of China on Safeguarding National Security in the Hong Kong Special Administrative Region (a translation of “《中華人民共和國香港特別行政區維護國家安全法》”); and
 - (iii) commits an offence relating to endangering national security under an enactment or under the common law;
 - (b) refuses to recognize the PRC’s sovereignty over the HKSAR and the exercise of the sovereignty, including objecting to the performance of duties and functions by the body of central power in accordance with –
 - (i) the Constitution of the PRC;
 - (ii) the Basic Law; or
 - (iii) the Law of the People’s Republic of China on Safeguarding National Security in the Hong Kong Special Administrative Region (a translation of “《中華人民共和國香港特別行政區維護國家安全法》”);
 - (c) refuses to recognize the constitutional status of the HKSAR as a local administrative region of the PRC;
 - (d) advocates or supports “Hong Kong independence”, including –
 - (i) pursues, promotes or implements “independence and state-building” of Hong Kong;
 - (ii) participates in an organization the object of which is “Hong Kong Independence”;
 - (iii) pursues, promotes or implements an activity for “self-determination of sovereignty or jurisdiction”, “referendum” or “devising constitution by all people”, or participates in an organization the object of which is “self-determination”; and
 - (iv) pursues or promotes the reign over Hong Kong to be transferred to a foreign country;
 - (e) solicits interference by foreign governments or organizations in the affairs of the HKSAR;

 - (i) compels or overawes the CE by any unlawful means to change a policy, or a motion to be submitted to Legislative Council for consideration;

An offence under section 101 is an offence prescribed for the purposes of section 14 of, and sections 9 and 18 of the Schedule to, the Chief Executive Election Ordinance (Cap. 569). Election related document means a form, declaration, application, authorization, notice, statement or a nomination form required or used for the purposes of the Regulation.

- (1) 除非任何人已以或已由他人代其以《選管會規例》所訂明的方式，向有關的界別分組的選舉主任繳存按金，否則該人不得獲有效提名為該界別分組選舉中的候選人。
- (2) 按金的款額須為《規例》為施行本條而訂明者，並須按該等《規例》的規定處置。

任何人不得在多於一個界別分組中獲提名（《行政長官選舉條例》（第 569 章）附表第 20 條）

在某人已在界別分組選舉中獲提名為某界別分組候選人之時，他即沒有資格在同日舉行或提名期與該選舉完全或部分重疊的另一界別分組選舉中獲提名為候選人。

另外，《中華人民共和國香港特別行政區維護國家安全法》第三十五條訂明：—

任何人經法院判決犯危害國家安全罪行的，即喪失作為候選人參加香港特別行政區舉行的立法會、區議會選舉或者出任香港特別行政區任何公職或者行政長官選舉委員會委員的資格；曾經宣誓或者聲明擁護中華人民共和國香港特別行政區基本法、效忠中華人民共和國香港特別行政區的立法會議員、政府官員及公務人員、行政會議成員、法官及其他司法人員、區議員，即時喪失該等職務，並喪失參選或者出任上述職務的資格。

Eligibility for being nominated as a candidate at a subsector election, disqualifications from being nominated as a subsector candidate and from being elected as a member of the Election Committee, the requirement for a person not to be nominated for more than 1 subsector are dealt with in sections 17, 17A, 18, 18A, 19 and 20 of

the Schedule to the Chief Executive Election Ordinance (Cap. 569) which are reproduced below for reference –

***Who is eligible to be nominated as a candidate at a subsector election
(s. 17 of the Schedule to the Chief Executive Election Ordinance (Cap. 569))***

- (1) A person is eligible to be nominated as a candidate at a subsector election for a subsector only if the person –
 - (a) has reached 18 years of age;
 - (b) is both registered and eligible to be registered for a geographical constituency; and
 - (c) either –
 - (i) is both registered and eligible to be registered as a voter for that subsector; or
 - (ii) satisfies the Returning Officer for the subsector that the person has a substantial connection with the subsector.
- (2) A person is not eligible to be nominated as a candidate at a subsector ordinary election if the person is –
 - (a) a nominee of a designated body under section 7(1);
 - (b) a specified person (whether or not the person is an ex-officio member of the Election Committee); or
 - (c) a designated person (whether or not the person is an ex-officio member of the Election Committee).
- (3) A person is not eligible to be nominated as a candidate at a subsector by-election if –
 - (a) the person is a nominee of a designated body under section 7(2) and the period during which the nomination under that section is to be made and the nomination period for the by-election coincide or partly coincide; or
 - (b) the person is a member of the Election Committee.

***Validity of nomination contingent on declaration
(s. 17A of the Schedule to the Chief Executive Election Ordinance (Cap. 569))***

A nomination of a person as a candidate at a subsector election under section 17 is not valid unless –

- (a) the nomination form contains a declaration to the effect that the person will uphold the Basic Law and pledge allegiance to the Hong Kong Special Administrative Region of the People's Republic of China; and
- (b) the declaration is signed by the person.

***When a person is disqualified from being a subsector candidate
(s. 18 of the Schedule to the Chief Executive Election Ordinance (Cap. 569))***

- (1) A person is disqualified from being nominated as a candidate at a subsector election and from being elected as a member of the Election Committee if the person –
 - (a) has ceased to have a substantial connection with the subsector concerned;
 - (b) has ceased to be registered or eligible to be registered as an elector for a geographical constituency;
 - (c) has in Hong Kong or in any other place been sentenced to death or imprisonment (by whatever name called) and has not either –
 - (i) served the sentence or undergone such other punishment as a competent authority may have substituted for the sentence; or
 - (ii) received a free pardon²;
 - (ca) has been convicted of an offence endangering national security;
 - (d) on the date of nomination or on the date of the subsector election, is serving a sentence of imprisonment;
 - (e) without limiting paragraph (c), where the subsector election is to be held or is held within 5 years after the date of the person's conviction, is or has been convicted –
 - (i) of having engaged in corrupt conduct or illegal conduct in contravention of the Elections (Corrupt and Illegal Conduct) Ordinance (Cap. 554);
 - (ii) of an offence against Part II of the Prevention of Bribery Ordinance (Cap. 201); or
 - (iii) of any offence prescribed by section 7 of Schedule 4A to the District Councils Ordinance (Cap. 547) or the EAC Regulations;
 - (f) is found for the time being under the Mental Health Ordinance (Cap. 136) to be incapable, by reason of mental incapacity, of managing and administering his property and affairs; or

² The Court of First Instance delivered written judgment on 21 June 2012 on *Wong Hin Wai & another v Secretary for Justice* (HCAL 51&54/2012) and declared section 39(1)(b) of the Legislative Council Ordinance (Cap. 542) (which is similar to section 18(1)(c) of the Schedule to the Chief Executive Election Ordinance (Cap. 569)) to be unconstitutional. On 12 July 2012, the Government announced its decision not to appeal against the judgment. The future Election Committee Subsector Elections will be held in accordance with the prevailing electoral laws. Any person who would like to be nominated as a candidate for the Election Committee Subsector Ordinary Elections and is doubtful about his/her eligibility for nomination may seek independent legal advice, and may also apply to the Nominations Advisory Committee (Election Committee) appointed by the Electoral Affairs Commission for advice on or before 5 October 2026 in accordance with the current electoral laws. - (g) is a member of the armed forces of the People's Republic of China or any other country or territory.
- (2) Without prejudice to section 13(1)(c) of the Electoral Affairs Commission Ordinance (Cap. 541), a person is also disqualified from being nominated as a candidate at a subsector election and from being elected as a member of the Election Committee if, within the 5 years before the date of nomination –
- (a) the person has vacated an office, or has been disqualified from entering on an office, under the law, for declining or neglecting to take a specified oath; or
 - (b) the person has been declared or decided in accordance with any law –
 - (i) to be in breach of a specified oath; or
 - (ii) to have failed to fulfil the legal requirements and conditions on upholding the Basic Law and bearing allegiance to the Hong Kong Special Administrative Region of the People's Republic of China.
- (3) In this section –
specified oath (指明誓言) means an oath taken under the law that the oath-taker will uphold the Basic Law and bear allegiance to the Hong Kong Special Administrative Region of the People's Republic of China.

**When a person is disqualified from being a candidate for certain subsectors
(s. 18A of the Schedule to the Chief Executive Election Ordinance (Cap. 569))**

- (1) This section is without prejudice to section 18.
- (1A) This section applies to the following subsectors –
- (a) the Heung Yee Kuk subsector;
 - (b) the Hong Kong and Kowloon District Committees subsector; and
 - (c) the New Territories District Committees subsector.
- (2) A person is disqualified from –
- (a) being nominated as a candidate at a subsector election for a subsector; or
 - (b) being elected as a member of the Election Committee representing the subsector, if the person is not a specified entity of the subsector.

Candidate to lodge deposit (s. 19 of the Schedule to the Chief Executive Election Ordinance (Cap. 569))

- (1) A person is validly nominated as a candidate for a subsector at a subsector election only if a deposit has, in the manner prescribed by the EAC Regulations, been lodged with the Returning Officer for the subsector concerned by or on behalf of the person.
- (2) The deposit is to be of such an amount as prescribed by the regulations for the purposes of this section and is to be disposed of as provided by the regulations.

**Person not to be nominated for more than one subsector
(s. 20 of the Schedule to the Chief Executive Election Ordinance (Cap. 569))**

A person who is nominated as a candidate for a subsector at a subsector election is not eligible to be nominated as a candidate at another subsector election that is to be held on the same day or if the nomination periods for the elections coincide or partly coincide.

In addition, Article 35 of The Law of the People's Republic of China on Safeguarding National Security in the Hong Kong Special Administrative Region stipulates that: –

A person who is convicted of an offence endangering national security by a court shall be disqualified from standing as a candidate in the elections of the Legislative Council and district councils of the Hong Kong Special Administrative Region, holding any public office in the Region, or serving as a member of the Election Committee for electing the Chief Executive. If a person so convicted is a member of the Legislative Council, a government official, a public servant, a member of the Executive Council, a judge or a judicial officer, or a member of the district councils, who has taken an oath or made a declaration to uphold the Basic Law of the Hong Kong Special Administrative Region of the People's Republic of China and swear allegiance to the Hong Kong Special Administrative Region of the People's Republic of China, he/she shall be removed from his/her office upon conviction, and shall be disqualified from standing for the aforementioned elections or from holding any of the aforementioned posts.

In accordance with section 13(3A)(a) and (3B) of the Electoral Affairs Commission (Electoral Procedure) (Election Committee) Regulation (Cap. 541I), the Candidate Eligibility Review Committee may require the Returning Officer to advise the Committee on any of the matters specified below:

- (a) whether, in the opinion of the Returning Officer, sections 17, 18 and 18A of the Schedule to the Chief Executive Election Ordinance (Cap. 569) and section 8 of that Regulation are complied with in relation to the candidate;
- (b) whether, in the opinion of the Returning Officer, the subsector nomination form is valid;
- (c) whether the candidate has withdrawn the candidature for the subsector concerned;
- (d) whether the subsector nomination form has been signed by the prescribed number of subscribers qualified to subscribe to the subsector nomination form as required under the Election Committee (Subscribers and Election Deposit for Nomination) Regulation (Cap. 569C);
- (e) whether the subsector nomination form has been completed or signed as required under this Regulation;
- (f) in the opinion of the Returning Officer –
 - (i) whether the candidate is eligible to be nominated as a candidate of the subsector concerned under the Schedule to the Chief Executive Election Ordinance (Cap. 569); and
 - (ii) whether the candidate is disqualified from being so nominated under that Schedule;
- (g) whether the candidate has lodged the appropriate deposit; and
- (h) whether, according to the information available to the Returning Officer, the candidate is dead.
