Since the number of validly nominated nominees in (a) is sufficient for the purpose of making up the assigned number for the designated body, this Committee will not decide the validity of nomination of the remaining nominees not listed in this part.

Notes on Completion of Nomination Form for Designated Bodies

以下說明只供參考。有關提名事宜的法例，請參閱《行政長官選舉條例》（第569章）及其他有關法例，包括《選舉管理委員會（選舉程序）（選舉委員會）規例》（第541I章）。

The Notes below are for reference only. For legislation concerning nomination matters, please refer to the Chief Executive Election Ordinance (Cap. 569) and other relevant legislation, including the Electoral Affairs Commission (Electoral Procedure) (Election Committee) Regulation (Cap. 541I).

1. 每個指定團體可提名若干數目的人士。如某指定團體的獲提名人的人數超逾該團體的獲配席位數目，則該團體須示明獲優先挑選以符合獲配席位數目的獲提名人，並將超額的獲提名人按優先次序排列。如任何獲優先挑選的獲提名人被裁定為提名無效，則獲配席位數目須由超額的獲提名人按其優先次序補足。由每個指定團體提名而成為選舉委員會委員的獲提名人數，不得超逾該指定團體的獲配席位數目。各指定團體、其所屬的界別分組及提名委員的獲配名額詳列於附錄三。

Each designated body may nominate a number of persons. If the number of nominees of a designated body exceeds the assigned number for the body, the body shall indicate which of the nominees are to be given preference in making up the assigned number and rank the excess nominees in order of priority. In the case that any nominee who has been given preference has been determined to be not validly nominated, the assigned number will be made up from the excess nominees in their order of priority. The number of nominees to become members of the Election Committee from each designated body cannot exceed the assigned number for that designated body. The designated bodies, their corresponding subsector, and the assigned number of members to be returned by nomination by each designated body are at Appendix 3.

2. 附錄三所列明的每個指定團體，必須用1份提名表格提名一組人士成為在選舉委員會中代表有關的界別分組的委員。

Each designated body as mentioned in Appendix 3 must use 1 nomination form to nominate a number of persons representing the relevant subsector on the Election Committee.

3. 每個指定團體須向有關界別分組的選舉主任呈交1份完整的提名表格（包括第1至7頁）。每份提名表格須由有關指定團體的負責人及每名獲提名人填寫及親自簽署。如指定團體在選舉事務處的網頁下載提名表格，請使用**A4尺寸白色紙張**列印表格。請勿使用鉛筆或可擦式原子筆填寫提名表格。如有需要，指定團體可使用2026年選舉委員會界別分組一般選舉指定團體提名表格的「獲提名人補充頁第一部分」（表格編號：REO/N/2 (2026ECSSE)(SF)(Supplementary sheet for nominees – Part I)）及「獲提名人補充頁第二部分」（表格編號：REO/N/2 (2026ECSSE)(SF)(Supplementary sheet for nominees – Part II)）。請在每張補充頁填上順序的子頁碼，例如表格第一部分的頁碼為「1(1)」及「1(2)」，此部分的補充頁應填上頁碼「1(3)」及「1(4)」，如此類推，而表格第二部分的補充頁則應填上頁碼「2(6)」至「2(10)」，如此類推。此表格的所有頁面（包括所有補充頁）在呈交提名表格時必須一併交予有關界別分組的選舉主任。

Each designated body should submit a duly completed nomination form (including pages 1 to 7) to the Returning Officer for the relevant subsector. A nomination form must be completed and signed personally by the responsible person of the designated body concerned and each of its nominees. If a designated body downloads the nomination form from the website of the Registration and Electoral Office, please print it on **A4 size white papers**. Please do not use pencil or erasable pen to fill in the nomination form. If necessary, a designated body may use the “Supplementary Sheet for Nominees – Part I” (Form no.: REO/N/2 (2026ECSSE)(SF)(Supplementary sheet for nominees – Part I)) and “Supplementary Sheet for Nominees – Part II” (Form no.: REO/N/2 (2026ECSSE)(SF)(Supplementary sheet for nominees – Part II)) of the nomination form for designated bodies for the 2026 Election Committee Subsector Ordinary Elections. Each supplementary sheet should be marked with a consecutive sub-page number. For example, as the page numbers of Part I of the nomination form are “1(1)” and “1(2)”, the supplementary sheets for Part I should be marked “1(3)” and “1(4)” and so on, while the supplementary sheets for Part II should be marked “2(6)” - “2(10)” and so on. All pages (including all supplementary sheets) of this form must be submitted to the Returning Officer for the relevant subsector in one complete set.

4. 如某指定團體提名的人數超逾該團體的獲配席位數目，該團體須示明獲優先挑選的獲提名人及將所餘獲提名人（如超逾1名）按優先次序排列。如該團體沒有依照上述規定或獲優先挑選的獲提名人的數目少於該團體的獲配席位數目，則有關界別分組的選舉主任會以抽籤方式決定由該團體的獲提名人補足該獲配席位數目的優先次序。獲有效提名及按優先次序補足有關指定團體的獲配席位數目的獲提名人即成為選舉委員會代表有關界別分組的委員。

If the number of persons nominated by a designated body exceeds the assigned number for the body, the body shall indicate which of the nominees are to be given preference and rank the excess nominees (if more than 1) in order of priority. If the body has not followed the above requirement or the number of nominees to whom preference is given is less than the assigned number for that body, the Returning Officer for the relevant subsector will

determine, by drawing lots, the order of priority in which the nominees of that body are to make up the assigned number. Validly nominated nominees who make up the assigned number for the designated body in their order of priority become members representing the relevant subsector on the Election Committee.

5. 請以中文及英文提供獲提名人在其香港身分證上所顯示的姓名及其地址，以便根據《選舉管理委員會（選舉程序）（選舉委員會）規例》（第541I章）在政府憲報上刊登公告，宣布獲有效提名為選舉委員會委員的獲提名人。獲提名人在填寫中文姓名時必須嚴格依照在其香港身分證上所顯示的繁體字或簡體字寫法（按情況而定）〔見附錄一第一部分〕。未能遵守這項規定會延誤檢查身分證明文件工作或令獲提名人須返回有關界別分組的選舉主任辦事處更正寫法。有關填寫中文姓名及地址的注意事項，可參閱附錄一。另外，獲提名人可選擇填寫其辦事處或業務地址、通訊地址¹、住址或郵政信箱號碼作為地址，但有關地址資料必須完整〔見附錄一第二部分〕。

For the publication of the notice in the Government Gazette declaring the validly nominated nominee(s) as member(s) of the Election Committee, in accordance with the Electoral Affairs Commission (Electoral Procedure) (Election Committee) Regulation (Cap. 541I), please provide the name as shown on the nominee's Hong Kong Identity Card and his/her address in both Chinese and English. The nominee must strictly follow the writing of Chinese name as shown on his/her Hong Kong Identity Card in Traditional Chinese or Simplified Chinese (as the case may be) [see Part I of Appendix 1]. Failure to comply with this requirement would cause a delay in checking the nominee's identity document or require him/her to return to the office of the Returning Officer for the relevant subsector for rectification. Please refer to Appendix 1 for the points to note when filling in the Chinese name and address. Besides, a nominee can fill in his/her office or business address, correspondence address¹, residential address or post office box number as address, but the address information must be complete [see Part II of Appendix 1].

6. 根據《選舉管理委員會（選舉程序）（選舉委員會）規例》（第541I章）第16(3)條，有關界別分組的選舉主任必須將一份關於候選人資格審查委員會根據《選舉管理委員會（選舉程序）（選舉委員會）規例》（第541I章）第12(2)或12(4)條就獲提名人所作的裁定或決定，送交有關獲提名人、提名該獲提名人的指定團體及其他由該指定團體提名的獲提名人。這份通知必須按各獲提名人在有關的提名表格上所提供的地址送交。除有關提名是否有效的通知外，所有由選舉事務處、有關界別分組的選舉主任或候選人資格審查委員會發出的信件、重要資料及公告，將會以電郵、傳真或按提名表格上所提供的地址／通訊地址（如有的話）送交給獲提名人。

According to section 16(3) of the Electoral Affairs Commission (Electoral Procedure) (Election Committee) Regulation (Cap. 541I), the Returning Officer for the relevant subsector must send a notice of a determination or a decision by the Candidate Eligibility Review Committee under section 12(2) or 12(4) of the Electoral Affairs Commission (Electoral Procedure) (Election Committee) Regulation (Cap. 541I) made in a relation to a nominee to the nominee concerned, the designated body that nominated the nominee and the other nominees who are nominated by that designated body. Such a notice must be sent to the address of the nominee as given on the relevant nomination form. All correspondence, important information and notices, except the relevant notices on the validity of a nomination, from the Registration and Electoral Office, the Returning Officer for the relevant subsector or the Candidate Eligibility Review Committee will be sent to the nominee by email, by fax or by mail to the address/correspondence address, if provided, as given on the nomination form.

7. 獲提名人可選擇在提名表格上填寫其職業，此資料將會供公眾查閱。獲提名人的地址、通訊地址、電話號碼、傳真號碼及電郵地址將不會提供予公眾查閱。獲提名人可選擇另行提供其聯絡資料予傳媒使用及公眾查閱以便他們直接聯絡有關獲提名人，是否提供該等聯絡資料屬自願性質〔見說明第24(b)項〕。

A nominee may choose to state his/her occupation in the nomination form, which will be made available for public inspection. The nominee's address, correspondence address, telephone numbers, fax number and email address will not be made available for public inspection. The nominees may choose to separately provide his/her contact information for the media and public inspection to facilitate them to contact the nominees concerned directly. The supply of contact information is optional [see Note 24(b)].

8. 提名表格必須在提名期內：即由2026年10月7日至2026年10月20日（首末兩天包括在內），除公眾假期外的任何日子，於通常辦公時間內（星期一至星期五：上午九時至下午五時；星期六：上午九時至中午十二時），由有關指定團體於有關憲報公告列明之地點呈交予有關界別分組的選舉主任。根據《選舉管理委員會（選舉程序）（選舉委員會）規例》（第541I章）第1A(3)條，如提名期的最後一日適逢惡劣天氣警告日（即在該工作日中，在通常辦公時間內的任何時間有烈風警告或暴雨警告生效；烈風警告及暴雨警告的涵義與該詞在《司法程序（烈風警告期間聆訊延期）條例》（第62章）中的涵義相同），提名期將會延長至並非惡劣天氣警告日的下一個工作日結束。

¹ 如使用其他人士／團體的地址作為通訊地址，須事先獲得有關人士／團體的同意。

If an address of another person/organization is used as the correspondence address, prior consent of the person/organization concerned must be obtained.

A nomination form must be submitted by the designated body concerned to the Returning Officer for the relevant subsector at the address specified in the relevant Gazette Notice within the nomination period i.e. from 7 October 2026 to 20 October 2026 (both days inclusive) during ordinary business hours (Monday to Friday: from 9 a.m. to 5 p.m.; Saturday: from 9 a.m. to 12 noon) on any day other than a general holiday. According to section 1A(3) of the Electoral Affairs Commission (Electoral Procedure) (Election Committee) Regulation (Cap. 541I), if the last day of the nomination period falls on an inclement weather warning day (i.e. a working day on which a gale warning or a rainstorm warning is in force at any time during ordinary business hours; gale warning and rainstorm warning have the same meaning as in the Judicial Proceedings (Adjournment During Gale Warnings) Ordinance (Cap. 62)), the nomination period will be extended to end on the next working day which is not an inclement weather warning day.

9. 指定團體應盡早呈交提名表格，以便於提名期結束前，在有需要時更正在其提名表格上發現的任何錯處。
A designated body is strongly advised to **submit its nomination form as early as practicable** so that any mistakes found in its nomination form can be rectified as needed **before the end of the nomination period**.

10. 任何提名表格所載的獲提名人姓名或其他重要資料如經更改，將可能不會被有關界別分組的選舉主任接納。

The Returning Officer for the relevant subsector may not accept any nomination form on which the name or other important particulars of any nominee has/have been amended, altered or corrected.

11. 有關候選人資格審查委員會就提名是否有效所作的決定，可向審裁官提出上訴作出質疑。然而，就候選人資格審查委員會根據香港特別行政區維護國家安全委員會的審查意見書作出的決定，不得提出訴訟。

The Candidate Eligibility Review Committee's decision on the validity of a nomination can be questioned by an appeal to the Revising Officer. However, no legal proceedings may be instituted in respect of a decision made by the Candidate Eligibility Review Committee pursuant to the opinion of the Committee for Safeguarding National Security of the Hong Kong Special Administrative Region.

12. 提名表格必須按《行政長官選舉條例》（第569章）附表及《選舉管理委員會（選舉程序）（選舉委員會）規例》（第541I章）（下稱《規例》）的規定列載所需的資料，提名方為有效。根據《規例》第7(6)條，有關界別分組的選舉主任可要求指定團體或獲提名人提供該主任認為就下述目的而屬適當的任何其他資料：為使候選人資格審查委員會信納(a)該人有資格獲提名為選委會委員；或(b)其他關於提名是否有效的事宜。另外，根據《規例》第12(6)(b)條，候選人資格審查委員會在裁定某獲提名人是否就某界別分組獲有效提名時，可要求指定團體或該獲提名人提供該委員會認為為使該委員會信納該指定提名表格或該項提名是否有效而屬適當的任何其他資料。若候選人資格審查委員會要求有關團體或獲提名人提供資料，後者應以委員會所指明的方式向委員會提交有關資料。

A nomination will not be valid unless the nomination form contains the information as required in the Schedule to the Chief Executive Election Ordinance (Cap. 569) and the Electoral Affairs Commission (Electoral Procedure) (Election Committee) Regulation (Cap. 541I) ("the Regulation"). According to section 7(6) of the Regulation, the Returning Officer for the relevant subsector may require a designated body or a person who is being nominated to furnish any other information that the Officer considers appropriate for enabling the Candidate Eligibility Review Committee to be satisfied (a) that the person is eligible to be nominated as a member of the Election Committee; or (b) otherwise as to the validity of the nomination. In addition, according to section 12(6)(b) of that Regulation, in determining whether a nominee is validly nominated for a subsector, the Candidate Eligibility Review Committee may require a designated body or the nominee to furnish any other information that the Committee considers appropriate for enabling the Committee to be satisfied as to the validity of the designated nomination form or the nomination. If the Candidate Eligibility Review Committee requires such information from the designated body or the nominee, the latter should provide the same to the Committee in accordance with the manner specified by the Committee.

13. 下述人士沒有資格被挑選為獲提名人：

The following persons are not eligible to be selected as a nominee:

- (a) 擔任《行政長官選舉條例》（第569章）附表第2A部第1分部任何指明職位〔見附錄二〕或獲指定登記成為選舉委員會當然委員的人；或
a person holding any specified office in Division 1 of Part 2A of the Schedule to the Chief Executive Election Ordinance (Cap. 569) [see Appendix 2] or a person being designated to be registered as an ex-officio member of the Election Committee; or
- (b) 2026年選舉委員會界別分組一般選舉的候選人；或
a candidate at the 2026 Election Committee Subsector Ordinary Elections; or

- (c) 在2026年選舉委員會界別分組一般選舉已被其他指定團體挑選的獲提名人。
a nominee selected by another designated body at the 2026 Election Committee Subsector Ordinary Elections.

14. 《行政長官選舉條例》（第569章）附表第1(3)(b)條列明某人與某界別分組有密切聯繫的情況包括（但不限於）身為列入該界別分組的團體的成員、會員、合夥人、僱員或（如該團體是法人團體）高級人員或（如該團體不是法人團體）人員；或身為該團體的團體成員的成員、會員、合夥人、僱員或（如該團體是法人團體）高級人員或（如該團體不是法人團體）人員。倘準獲提名人對其是否有資格作為獲提名人，或指定團體對準獲提名人是否有資格作為獲提名人有任何疑問，他／她／該團體應向其法律顧問查詢或要求提名顧問委員會提供意見。有關申請表格可向各區民政事務處或選舉事務處（地址：九龍長沙灣東京街西3號庫務大樓8樓）索取或於選舉事務處網頁（<https://www.reo.gov.hk>）下載。申請截止日期為2026年10月5日。

According to section 1(3)(b) of the Schedule to the Chief Executive Election Ordinance (Cap. 569), the circumstances in which a person has a substantial connection with a subsector include, but are not limited to, being a member, partner, officer or employee of a body included in the subsector; or a corporate member of such a body. If a prospective nominee is not clear whether he/she is eligible to be a nominee, or a designated body is not clear whether a prospective nominee is eligible to be a nominee, he/she/the body should consult his/her/its own legal advisor or seek advice from the Nominations Advisory Committee. The relevant application forms can be obtained from all District Offices or the Registration and Electoral Office (Address: 8th Floor, Treasury Building, 3 Tonkin Street West, Cheung Sha Wan, Kowloon) or can be downloaded from the website of the Registration and Electoral Office (<https://www.reo.gov.hk>). The deadline for submitting such application is 5 October 2026.

15. 獲提名人必須根據《行政長官選舉條例》（第569章）附表第7A條的規定於提名表格內作出聲明，表明他／她會擁護《基本法》及保證效忠中華人民共和國香港特別行政區。擁護《基本法》是指擁護《基本法》各項條文，包括擁護下述條文——

In accordance with section 7A of the Schedule to the Chief Executive Election Ordinance (Cap. 569), a nominee must declare in the nomination form that he/she will uphold the Basic Law and pledge allegiance to the Hong Kong Special Administrative Region (“HKSAR”) of the People’s Republic of China (“PRC”). Upholding the Basic Law means to uphold all the provisions of the Basic Law, including the following provisions –

第一條

香港特別行政區（“香港特區”）是中華人民共和國不可分離的部分。

Article 1

The HKSAR is an inalienable part of the PRC.

第十二條

香港特區是中華人民共和國的一個享有高度自治權的地方行政區域，直轄於中央人民政府。

Article 12

The HKSAR shall be a local administrative region of the PRC, which shall enjoy a high degree of autonomy and come directly under the Central People's Government.

第一百五十九（四）條

本法的任何修改，均不得同中華人民共和國對香港既定的基本方針政策相抵觸。

Article 159(4)

No amendment to this Law shall contravene the established basic policies of the PRC regarding Hong Kong.

16. 某人若符合正面清單則屬「擁護《基本法》、效忠中華人民共和國香港特別行政區」，而他／她若作出或意圖作出負面清單所列行為，則不屬「擁護《基本法》、效忠中華人民共和國香港特別行政區」。《釋義及通則條例》（第1章）第3AA條載列如下：—

A person upholds the Basic Law and bears allegiance to the HKSAR of the PRC if the positive list is satisfied and that the person does not uphold the Basic Law and bear allegiance to the HKSAR if the person does or intends to do any of the things set out in the negative list. Section 3AA of the Interpretation and General Clauses Ordinance (Cap. 1) is reproduced below: –

對擁護《基本法》、效忠特區的提述（《釋義及通則條例》（第1章）第3AA條）

References to upholding Basic Law and bearing allegiance to HKSAR (section 3AA of the Interpretation and General Clauses Ordinance (Cap. 1))

- (1) 就施行條例而言，任何人如 —

- (a) 擁護《中華人民共和國憲法》及《基本法》確立的香港特區的憲制秩序；
(b) 擁護中華人民共和國國家主權、統一、領土完整和國家安全；

- (c) 擁護 —
 - (i) 香港特區是中華人民共和國不可分離的部分；
 - (ii) 中華人民共和國對香港特區行使主權；及
 - (iii) 中央根據《基本法》對香港特區行使管治權力；
 - (d) 擁護“一國兩制”原則的落實，維護香港特區的政治體制；
 - (e) 擁護在《基本法》的框架下，保持香港特區繁榮穩定的目的；及
 - (f) 忠於香港特區，維護香港特區的利益，
即屬擁護《基本法》、效忠中華人民共和國香港特別行政區。
- (1) For the purposes of an Ordinance, a person upholds the Basic Law and bears allegiance to the HKSAR of the PRC if the person –
- (a) upholds the constitutional order of the HKSAR established by the Constitution of the PRC and the Basic Law;
 - (b) upholds the national sovereignty, unity, territorial integrity and national security of the PRC;
 - (c) upholds –
 - (i) the fact that the HKSAR is an inalienable part of the PRC;
 - (ii) the PRC’s exercise of sovereignty over the HKSAR; and
 - (iii) the Central Authorities’ exercise of governance over the HKSAR under the Basic Law;
 - (d) upholds the implementation of “one country, two systems” principle, and safeguards the political structure of the HKSAR;
 - (e) upholds the objective to maintain the prosperity and stability of the HKSAR within the framework of the Basic Law; and
 - (f) is loyal to, and safeguards the interests of, the HKSAR.
- (2) 在第(1)款中，提述擁護，即提述在意圖上及言行上均真心地及真誠地遵守、支持、維護及信奉。
- (2) In subsection (1), a reference to uphold is a reference to intend to genuinely and truthfully observe, support, maintain and embrace, and genuinely and truthfully observe, support, maintain and embrace in words and deeds.
- (3) 就施行條例而言，任何人當作出或意圖作出以下任何行為時，不屬擁護《基本法》、效忠中華人民共和國香港特別行政區 —
- (a) 作出或進行危害國家安全的行為或活動，包括 —
 - (i) 作出《基本法》第23條規定禁止的行為；
 - (ii) 犯《中華人民共和國香港特別行政區維護國家安全法》規定的罪行；及
 - (iii) 犯成文法則或普通法規定的關於危害國家安全的罪行；
 - (b) 拒絕承認中華人民共和國對香港特區擁有並行使主權，包括反對中央政權機關按照 —
 - (i) 《中華人民共和國憲法》；
 - (ii) 《基本法》；或
 - (iii) 《中華人民共和國香港特別行政區維護國家安全法》，履行職務和職能；
 - (c) 拒絕承認香港特區作為中華人民共和國一個地方行政區域的憲制地位；
 - (d) 宣揚或支持“港獨”主張，包括 —
 - (i) 主張、推動或實施香港“獨立建國”；
 - (ii) 參與以“香港獨立”為宗旨的組織；
 - (iii) 主張、推動或實施“自決主權或治權”、“全民公投”、“全民制憲”等活動，或參與以“自決”為宗旨的組織；及
 - (iv) 主張或推動香港轉歸外國統治；
 - (e) 尋求外國政府或組織干預香港特區的事務；
 - (f) 作出損害或有傾向損害《基本法》中以行政長官為主導的政治體制秩序的行為，包括 —
 - (i) 以非法手段強迫或威嚇行政長官改變某項政策或提交立法會審議的議案；
 - (ii) 無差別地反對特區政府提出的議案，並 —
 - (A) 意圖以此要脅特區政府；
 - (B) 意圖以此使特區政府無法正常履行職務和職能；或
 - (C) 意圖以此逼使行政長官下台及推翻特區政府；及
 - (iii) 利用特區政府舉行的選舉，組織或實施（或煽動他人組織或實施）任何形式的對抗中央人民政府和特區政府的“變相公投”；
 - (g) 作出損害或有傾向損害香港特區的整體利益的行為；
 - (h) 公開及故意以焚燒、毀損、塗劃、玷污、踐踏等方式侮辱國旗或國徽或區旗或區徽；
 - (i) 侮辱或貶損國歌或國家主權的任何其他象徵和標誌。

- (3) For the purposes of an Ordinance, a person does not uphold the Basic Law and bear allegiance to the HKSAR of the PRC when the person does, or intends to do, any of the following –
- (a) commits acts or carries out activities that endanger national security, including –
 - (i) commits an act required by Article 23 of the Basic Law to be prohibited;
 - (ii) commits an offence under the Law of the People's Republic of China on Safeguarding National Security in the Hong Kong Special Administrative Region (a translation of “《中華人民共和國香港特別行政區維護國家安全法》”); and
 - (iii) commits an offence relating to endangering national security under an enactment or under the common law;
 - (b) refuses to recognize the PRC's sovereignty over the HKSAR and the exercise of the sovereignty, including objecting to the performance of duties and functions by the body of central power in accordance with –
 - (i) the Constitution of the PRC;
 - (ii) the Basic Law; or
 - (iii) the Law of the People's Republic of China on Safeguarding National Security in the Hong Kong Special Administrative Region (a translation of “《中華人民共和國香港特別行政區維護國家安全法》”);
 - (c) refuses to recognize the constitutional status of the HKSAR as a local administrative region of the PRC;
 - (d) advocates or supports “Hong Kong independence”, including –
 - (i) pursues, promotes or implements “independence and state-building” of Hong Kong;
 - (ii) participates in an organization the object of which is “Hong Kong Independence”;
 - (iii) pursues, promotes or implements an activity for “self-determination of sovereignty or jurisdiction”, “referendum” or “devising constitution by all people”, or participates in an organization the object of which is “self-determination”; and
 - (iv) pursues or promotes the reign over Hong Kong to be transferred to a foreign country;
 - (e) solicits interference by foreign governments or organizations in the affairs of the HKSAR;
 - (f) commits acts that undermine or have a tendency to undermine the order of the political structure led by the Chief Executive (“CE”), contained in the Basic Law, including –
 - (i) compels or overawes the CE by any unlawful means to change a policy, or a motion to be submitted to the Legislative Council for consideration;
 - (ii) indiscriminately objects to the Government's motion, and with this –
 - (A) intends to threaten the Government;
 - (B) intends to render the Government incapable of performing its duties and functions as normal; or
 - (C) intends to force the CE to step down and to overthrow the Government; and
 - (iii) makes use of an election held by the Government to organize or implement, or to incite another person to organize or implement, a “de facto referendum” in any form to confront the Central People's Government and the Government;
 - (g) commits acts that undermine or have a tendency to undermine the overall interests of the HKSAR;
 - (h) desecrates the national flag or national emblem, or regional flag or regional emblem, by publicly and wilfully burning, mutilating, scrawling on, defiling or trampling on it;
 - (i) insults or disrespects the national anthem or any other symbol and sign of national sovereignty.

 - (e) 是中華人民共和國或任何其他國家或地區的武裝部隊的成員。

Eligibility to be selected as and disqualifications from being a nominee are dealt with in sections 7A, 8, 9 and 9A of the Schedule to the Chief Executive Election Ordinance (Cap. 569) which are reproduced below for reference –

Validity of nomination contingent on declaration (section 7A of the Schedule to the Chief Executive Election Ordinance (Cap. 569))

A nomination of a person under section 7(1) or (2) is not valid unless –

- (a) the nomination form contains a declaration to the effect that the person will uphold the Basic Law and pledge allegiance to the Hong Kong Special Administrative Region of the People's Republic of China; and
- (b) the declaration is signed by the person.

Who is eligible for selection as a nominee (section 8 of the Schedule to the Chief Executive Election Ordinance (Cap. 569))

- (1) A person is eligible to be selected as a nominee for a subsector under section 7 if the person –
 - (a) is both registered and eligible to be registered under the Legislative Council Ordinance (Cap. 542) as an elector for a geographical constituency, and is not disqualified from being so registered; and
 - (b) has a substantial connection with the subsector.
- (2) A person is not eligible to be selected as a nominee under section 7(1) if the person –
 - (a) is a specified person (whether or not the person is an ex-officio member of the Election Committee);
 - (ab) is a designated person (whether or not the person is an ex-officio member of the Election Committee); or
 - (b) is a candidate at a subsector ordinary election.
- (3) A person is not eligible to be selected as a nominee under section 7(2) if the person –
 - (a) is a member of the Election Committee; or
 - (b) is a candidate at a subsector by-election, the nomination period for which coincides or partly coincides with the period during which the nomination under that section is to be made.
- (4) A person who is selected as a nominee by a designated body as a member of the Election Committee is not eligible to be selected by another designated body as such a member if the period during which the nominations are to be made coincides or partly coincides.

When a person is disqualified from being a nominee (section 9 of the Schedule to the Chief Executive Election Ordinance (Cap. 569))

- (1) A person is disqualified from being a nominee under section 7 if the person –
 - (a) has in Hong Kong or in any other place been sentenced to death or imprisonment (by whatever name called) and has not either –
 - (i) served the sentence or undergone such other punishment as a competent authority may have substituted for the sentence; or
 - (ii) received a free pardon²;
 - (ab) has been convicted of an offence endangering national security;
 - (b) on the date of nomination, is serving a sentence of imprisonment;
 - (c) without limiting paragraph (a), where the nomination is made within 5 years after the date of the person's conviction, is or has been convicted –
 - (i) of having engaged in corrupt conduct or illegal conduct in contravention of the Elections (Corrupt and Illegal Conduct) Ordinance (Cap. 554);
 - (ii) of an offence against Part II of the Prevention of Bribery Ordinance (Cap. 201); or
 - (iii) of any offence prescribed by section 7 of Schedule 4A to the District Councils Ordinance (Cap. 547) or the EAC Regulations;
 - (d) is found for the time being under the Mental Health Ordinance (Cap. 136) to be incapable, by reason of mental incapacity, of managing and administering his property and affairs; or

² The Court of First Instance delivered written judgment on 21 June 2012 on *Wong Hin Wai & another v Secretary for Justice* (HCAL 51&54/2012) and declared section 39(1)(b) of the Legislative Council Ordinance (Cap. 542) (which is similar to section 9(1)(a) of the Schedule to the Chief Executive Election Ordinance (Cap. 569)) to be unconstitutional. On 12 July 2012, the Government announced its decision not to appeal against the judgment. The future Election Committee Subsector Ordinary Elections will be held in accordance with the prevailing electoral laws. If a prospective nominee is doubtful about his/her eligibility for nomination or a designated body is doubtful about a prospective nominee's eligibility for nomination, he/she/it may seek independent legal advice, and may also apply to the Nominations Advisory Committee (Election Committee) appointed by the Electoral Affairs Commission for advice on or before 5 October 2026 in accordance with the current electoral laws.  - (a) the person has vacated an office, or has been disqualified from entering on an office, under the law, for declining or neglecting to take a specified oath; or
 - (b) the person has been declared or decided in accordance with any law –
 - (i) to be in breach of a specified oath; or
 - (ii) to have failed to fulfil the legal requirements and conditions on upholding the Basic Law and bearing allegiance to the Hong Kong Special Administrative Region of the People's Republic of China.
- (3) In this section –
specified oath (指明誓言) means an oath taken under the law that the oath-taker will uphold the Basic Law and bear allegiance to the Hong Kong Special Administrative Region of the People's Republic of China.

When a person is disqualified from being a nominee for certain subsectors (section 9A of the Schedule to the Chief Executive Election Ordinance (Cap. 569))

- (1) This section is without prejudice to section 9.
- (2) A person is disqualified from being a nominee for the accountancy subsector if the person is not a Hong Kong Accounting Advisor appointed by the Ministry of Finance of the People's Republic of China.
- (3) A person is disqualified from being a nominee for the Chinese medicine subsector if the person is not a Hong Kong member of the Council of the World Federation of Chinese Medicine Societies.
- (4) A person is disqualified from being a nominee for the legal subsector if the person is not a Hong Kong member of the Council of the China Law Society.
- (5) A person is disqualified from being a nominee for the technology and innovation subsector if the person is not a Hong Kong academician of the Chinese Academy of Sciences or the Chinese Academy of Engineering.

In addition, Article 35 of The Law of the People's Republic of China on Safeguarding National Security in the Hong Kong Special Administrative Region stipulates that: –

A person who is convicted of an offence endangering national security by a court shall be disqualified from standing as a candidate in the elections of the Legislative Council and district councils of the Hong Kong Special Administrative Region, holding any public office in the Region, or serving as a member of the Election Committee for electing the Chief Executive. If a person so convicted is a member of the Legislative Council, a government official, a public servant, a member of the Executive Council, a judge or a judicial officer, or a member of the district councils, who has taken an oath or made a declaration to uphold the Basic Law of the Hong Kong Special Administrative Region of the People's Republic of China and swear allegiance to the Hong Kong Special Administrative Region of the People's Republic of China, he/she shall be removed from his/her office upon conviction, and shall be disqualified from standing for the aforementioned elections or from holding any of the aforementioned posts.

In accordance with section 12(6)(a) and (7) of the Electoral Affairs Commission (Electoral Procedure) (Election Committee) Regulation (Cap. 541I), the Candidate Eligibility Review Committee may require the Returning Officer to advise the Committee on any of the matters specified below:

- (a) whether, in the opinion of the Returning Officer, section 8, 9 or 9A of the Schedule to the Chief Executive Election Ordinance (Cap. 569) are complied with in relation to the nominee;
- (b) whether, in the opinion of the Returning Officer, the designated nomination form or the nomination of the nominee on the form is valid;
- (c) whether the designated nomination form has been completed or signed as required under this Regulation;
- (d) in the opinion of the Returning Officer –

- (i) whether the nominee is eligible to be nominated as an Election Committee member of the subsector concerned under the Schedule to the Chief Executive Election Ordinance (Cap. 569); and
- (ii) whether the nominee is disqualified from being so nominated under that Schedule; and
- (e) whether, according to the information available to the Returning Officer, the nominee is dead.

In accordance with section 101 of the Electoral Affairs Commission (Electoral Procedure) (Election Committee) Regulation (Cap. 541I) (“the Regulation”), a person who, in an election related document, makes a statement which that person knows to be false in a material particular or recklessly makes a statement which is incorrect in a material particular or knowingly omits a material particular from an election related document commits an offence. An offence under section 101 is an offence prescribed for the purposes of section 14 of, and sections 9 and 18 of the Schedule to, the Chief Executive Election Ordinance (Cap. 569). Election related document means a form, declaration, application, authorization, notice, statement or a nomination form required or used for the purposes of the Regulation.

Part I: Chinese Name

獲提名人在填寫中文姓名時必須嚴格依照在其身分證明文件（指獲提名人記錄在地方選區正式選民登記冊內的資料所依據的身分證明文件，通常是其香港身分證）上所顯示的繁體字或簡體字寫法（按情況而言）。

The nominee must strictly follow the writing of his/her Chinese name as shown on his/her identity document (being the identity document based on which the particulars of the nominee are recorded in the geographical constituencies final register, which is usually his/her Hong Kong Identity Card) in terms of Traditional Chinese or Simplified Chinese (as the case may be).
