

**ELECTORAL AFFAIRS COMMISSION (NOMINATIONS ADVISORY
COMMITTEES (ELECTION COMMITTEE)) REGULATION
(Cap. 541H)**

Pursuant to sections 3(2), 3(3), 3(5), 4(3), 4(4), 6(4), 6(5) and 7(3) of the Electoral Affairs Commission (Nominations Advisory Committees (Election Committee)) Regulation (“the Regulation”), the following notices are given —

I. Appointment of Nominations Advisory Committees (Election Committee)

The following legal practitioners are each appointed as a Nominations Advisory Committee (Election Committee) (“NAC(EC)”) for the period from 11 September 2026 to 22 October 2026 (both days inclusive) in relation to the Election Committee Subsector Ordinary Elections to be held on 22 November 2026 and the nominations by designated bodies under section 7(1) of the Schedule to the Chief Executive Election Ordinance (Cap. 569), both of which have the nomination period from 7 October 2026 to 20 October 2026 —

II. Periods in which each NAC(EC) performs its functions

Each NAC(EC) is to perform its functions specified under section 4(1) of the Regulation during the following periods —

- (a) Between 11 September 2026 and 9 October 2026, to perform its functions on applications by (i) prospective candidates, and (ii) prospective nominees and designated bodies seeking advice and to complete the same by 9 October 2026.
- (b) Between 7 October 2026 and 22 October 2026, to perform its functions on applications by Returning Officers seeking advice and to complete the same by 22 October 2026.

III. Periods in which applications for advice from the NAC(EC) are to be made

- (a) Applications under paragraph II(a) above by (i) prospective candidates, and (ii) prospective nominees and designated bodies must be made in the specified form and lodged with the Chief Electoral Officer either in person, by post or by facsimile transmission, so as to be received by that Officer between 11 September 2026 and 5 October 2026 (both days inclusive).
- (b) Applications under paragraph II(b) above by Returning Officers must be in writing and lodged with the Chief Electoral Officer, so as to be received by that Officer between 7 October 2026 and 21 October 2026 (both days inclusive).

The specified form mentioned under paragraph III(a) above may be obtained free of charge during business hours from 11 September 2026 to 5 October 2026 (both days inclusive other than a general holiday) from the District Offices, or at the offices of the Registration and Electoral Office at 8th Floor, Treasury Building, 3 Tonkin Street West, Cheung Sha Wan, Kowloon, or Unit 2301-03, 23/F, Millennium City 6, 392 Kwun Tong Road, Kwun Tong, or downloaded from the website of the Registration and Electoral Office (<https://www.reo.gov.hk>).
