Specified nomination forms may be obtained free of charge during ordinary business hours from 22 September 2026 to 20 October 2026 (both days inclusive and other than a general holiday) from the offices of the Registration and Electoral Office at 8/F, Treasury Building, 3 Tonkin Street West, Cheung Sha Wan, Kowloon or Unit 2301-03, 23/F, Millennium City 6, 392 Kwun Tong Road, Kwun Tong, Kowloon, or from the offices of the Returning Officer for the relevant subsector, or can be downloaded from the website of the Registration and Electoral Office (<https://www.reo.gov.hk>).
