# Notes on Completion of Nomination Form for a Geographical Constituency of the Legislative Council General Election

以下說明只供參考。有關提名事宜的法例,請參閱《立法會條例》(第542章)、《選舉(舞弊及非法 行為)條例》(第554章)及其他有關法例,包括《選舉管理委員會(選舉程序)(立法會)規例》 (第541D章)。

The Notes below are for reference only. For legislation concerning nomination matters, please refer to the Legislative Council Ordinance (Cap. 542), the Elections (Corrupt and Illegal Conduct) Ordinance (Cap. 554) and other relevant legislation, including the Electoral Affairs Commission (Electoral Procedure) (Legislative Council) Regulation (Cap. 541D).

- 1. 每份提名表格只能用以提名一份候選人名單。 A separate nomination form must be used for each list of candidate.
- 2. 是否提供聯絡資料予傳媒使用及公眾查閱屬自願性質。該等資料會提供予傳媒以便他們直接聯絡有關候選人。
  - The supply of contact information for the media and public inspection is optional. The information will be provided to the media to facilitate them to contact the candidate concerned directly.

According to the Legislative Council (Subscribers and Election Deposit for Nomination) Regulation (Cap. 542C), a nomination form in respect of a geographical constituency must be **personally subscribed** and **signed by 100** subscribers. All the <u>subscribers must be registered electors for the relevant geographical constituency</u>. To avoid the risk of invalidation of the nomination if any subscriber is unqualified, the nomination form may be subscribed by more than 100 but not exceeding 200 subscribers. Page 15 of the form should comprise not less than 10 parts. Each of the parts of page 15 should be marked with a consecutive serial number starting with "15(1)". All pages (including all parts of page 15) of the form must be returned to the Returning Officer in one complete set. A candidate should check the qualification of the subscribers. If for any reason a subscriber is found to be unqualified to subscribe the nomination form, his/her subscription will be disregarded. A candidate should also remind each subscriber to provide the name as shown on his/her identity document (being the identity document based on which the particulars of the subscriber are recorded in the geographical constituencies final register).

- 4. 每一位登記選民只可就其所屬的地方選區以提名人身分簽署<u>一份</u>提名表格。
  A registered elector in respect of a geographical constituency is entitled to subscribe only <u>ONE</u> nomination form regarding his/her own geographical constituency.
- 6. 候選人須為每名提名人編配一個優先編號。任何人在某份提名表格上以提名人身分簽署,如其簽署超出有效地提名有關候選人所需的提名人人數(由優先編號 1 起計),則該人將被視為不曾在該提名表格上以提名人身分簽署。該人可簽署另一份提名表格。
  - Candidate should assign a priority number for each subscriber. Any person whose signature as a subscriber is in surplus of the number of qualified subscribers required to effect the nomination of the candidate concerned (counting from Priority No. 1 onwards) will be regarded as not having subscribed the nomination form. In this case, that person may subscribe another nomination form.

6. 請以中文及英文提供候選人的姓名及主要住址,以便在政府憲報上刊登有效提名公告。有關填寫中文姓名及主要住址的注意事項,可參閱附錄。候選人必須填寫在其身分證明文件(指候選人記錄在地方選區正式選民登記冊內的資料所依據的身分證明文件,通常是其香港身分證)上所顯示的姓名。候選人在填寫中文姓名時須嚴格依照在其身分證明文件上所顯示的繁體字或簡體字寫法(按情況而定)。未能遵守這項規定會延誤檢查身分證明文件工作及/或令候選人須返回選舉主任辦事處更正寫法。如果選舉主任信納某候選人通常為人所知的姓名與其身分證明文件上所顯示的姓名有所不同,該候選人可在別名一欄中加上該姓名。有效提名公告上顯示的候選人姓名(包括別名)會印在選票上。根據《選舉管理委員會(選舉程序)(立法會)規例》(第541D章)第19(3)及(4)條,選舉主任必須將一份關於某人是否獲有效提名的決定的通知,送交該人及有關選區的每名獲有效提名的候選人。這份通知必須按各有關提名表格上所提供的主要住址送交。

For publication of the Notice of Valid Nominations in the Government Gazette, please provide the name and principal residential address of the candidate in both Chinese and English. The candidate may refer to the Appendix for the points to note when filling in the Chinese name and principal residential address. The candidate must provide the name as shown on his/her identity document (being the identity document based on which the particulars of the candidate are recorded in the geographical constituencies final register, which is usually his/her Hong Kong Identity Card). The candidate should strictly follow the writing of his/her Chinese name as shown on his/her identity document in Traditional Chinese or Simplified Chinese (as the case may be). Failure to comply with this requirement would cause a delay in checking the candidate's identity document and/or require him/her to return to the Returning Officer's office for rectification. If the Returning Officer is satisfied that the candidate is usually known by a name different from that shown on his/her identity document, that candidate may include such different name as his/her alias. The name(s) (including alias(es)) of the candidate(s) as shown in the Notice of Valid Nominations will be printed on the ballot papers. According to section 19(3) and (4) of the Electoral Affairs Commission (Electoral Procedure) (Legislative Council) Regulation (Cap. 541D), the Returning Officer must send a notice of a decision that a person is validly nominated or is not validly nominated to the person concerned and each validly nominated candidate for the constituency concerned. Such a notice must be sent to the principal residential addresses of the person/candidate(s) concerned as given on their nomination forms.

Upon receiving the nomination form, the Returning Officer will strike out the name of any candidate who is not validly nominated, whose nomination has been withdrawn from the nomination list or has died and adjust the order of priority accordingly. If, after the close of nominations, the number of names of candidates on a nomination list exceeds the number of Members to be returned for the constituency concerned, the Returning Officer will, having regard to the order of priority, exclude from the list the names of the surplus candidates. All correspondence, except the notices on the validity of a nomination, from the Registration and Electoral Office or the Returning Officer concerned will be sent to the candidate ranking first in priority on a list.

  A candidate can choose to state his/her occupation, name of company/organisation and political affiliation in the nomination form, which will be made available for public inspection. If the candidate mentions the name of any organisation when stating his/her political affiliation, he/she must seek the agreement of the organisation concerned beforehand. Candidate's name, sex, occupation and political affiliation will also be published in the dedicated website of the election.

A nomination form must be handed in by the candidate/one of the candidates on the nomination list <u>in</u> <u>person</u> and received by the relevant Returning Officer within the nomination period from 16 July 2016 to 29 July 2016 (both days inclusive) during ordinary business hours (Monday to Friday: from 9 am to 5 pm; Saturday: from 9 am to 12 noon) on any day other than a general holiday. According to section 2A(3) of the Electoral Affairs Commission (Electoral Procedure) (Legislative Council) Regulation (Cap. 541D), if the last day of the nomination period falls on an inclement weather warning day (a working day on which a gale warning or a rainstorm warning is in force at any time during ordinary business hours; gale warning and rainstorm warning have the same meaning as in the Judicial Proceedings (Adjournment During Gale Warnings) Ordinance (Cap. 62)), the period is extended to end on the next working day which is not an inclement weather warning day. In general, unless the Returning Officer decides otherwise, the candidate(s) is/are deemed to stand nominated and he/she/they may hence carry out activities to promote his/her/their election. The Returning Officer's decision on the validity of a nomination is final and cannot be questioned in any proceeding except by an election petition.

A nomination will not be valid unless the nomination form contains the information as required in the Legislative Council Ordinance (Cap. 542) and the Electoral Affairs Commission (Electoral Procedure) (Legislative Council) Regulation (Cap. 541D). The Returning Officer may request such additional information from candidate(s) as he/she considers necessary to satisfy himself/herself as to the eligibility of the candidate(s) and the validity of the nomination.

A candidate cannot be nominated for more than one geographical or functional constituency in the 2016 Legislative Council General Election. When he/she hands in his/her nomination form, he/she must have withdrawn his/her candidature in respect of all other constituencies, if any. Otherwise his/her subsequently submitted nomination will be treated as invalid.

Part II of this nomination form should be completed and signed by each of the candidate(s) <u>in the presence of a witness</u> who can be any person who is in possession of an identity document and aged 18 years or over. According to section 3(1) of the Legislative Council Ordinance (Cap. 542), "identity document" (身分證明文件) means —

Eligibility for being nominated as a candidate, disqualification from being nominated as a candidate and from being elected as a member, requirements to be complied with by persons nominated as candidates and the requirement for a person not to be nominated for more than one constituency are dealt with in sections 37(1), 38, 39, 40 and 41 of the Legislative Council Ordinance (Cap. 542) which are reproduced below for reference-

- (1) A person is eligible to be nominated as a candidate at an election for a geographical constituency only if the person
  - (a) has reached 21 years of age; and
  - (b) is both registered and eligible to be registered as an elector for a geographical constituency; and
  - (c) is not disqualified from being elected as a Member by virtue of section 39 or any other law; and
  - (d) has ordinarily resided in Hong Kong for the 3 years immediately preceding the nomination; and
  - (e) is a Chinese citizen who is a permanent resident of Hong Kong with no right of abode in any country other than the People's Republic of China.

# Nomination lists for geographical constituencies and District Council (second) functional constituency (section 38 of the Legislative Council Ordinance (Cap. 542))

- (1) In this section -
  - "nominee" (獲提名人) means a person whose name is included in a nomination list as a candidate.
- (2) The nomination of candidates for election as Members for a geographical constituency or the District Council (second) functional constituency is to be by a list submitted to the Returning Officer containing either -
  - (a) the names of 2 or more persons contesting the election for that constituency as a group; or
  - (b) the name of a person contesting that election as a single candidate.
- (3) A nomination list must -
  - (a) be submitted -
    - (i) on a nomination form that complies with regulations in force under the Electoral Affairs Commission Ordinance (Cap. 541);
    - (ii) by a nominee on the nomination list concerned;
    - (iii) within the nomination period; and
    - (iv) in the manner prescribed by those regulations; and
  - (b) be accompanied by the written consent, made on the nomination form, of each nominee on the nomination list; and
  - (c) contain any other particulars required by regulations in force under the Electoral Affairs Commission Ordinance (Cap. 541).
- (4) If a nomination list contains the names of 2 or more persons, the names are to be ranked in the order of priority of the group for which the nomination list is submitted.
- (4A) After a nomination list has been submitted to a Returning Officer -
  - (a) the order in which names of nominees appear in the list cannot be altered;
  - (b) the names of other persons cannot be added to the list; and
  - (c) the names of persons already on the list cannot be deleted.
- (5) The Returning Officer must determine, for each nominee whose name appears on the nomination list, whether or not the nominee is validly nominated.
- (6) If -
  - (a) the Returning Officer determines that a nominee is not validly nominated; or
  - (b) a nominee's nomination is withdrawn; or
  - (c) a nominee dies.
  - that Officer must strike out the name of that nominee from the nomination list and adjust the order of priority in which the names of nominees appear on that list accordingly.
- (6A) If, after the Returning Officer has determined that a nominee is validly nominated, but before the close of nominations, proof is given to the satisfaction of the Returning Officer that the nominee has died or is disqualified from being nominated, that Officer must strike out the name of that nominee from the nomination list and adjust the order of priority in which the names of nominees appear on that list accordingly.

- (7) If, after striking out names from a nomination list in accordance with subsection (6) or (6A), no name remains on the list, the Returning Officer must reject the list.
- (8) (Renumbered as subsection (4A))
- (9) If, after the close of nominations, the names of more nominees remain on a nomination list than the number of Members to be returned for the constituency concerned, the Returning Officer must, having regard to the order in which the nominees' names appear on the list, exclude from the list the names of the surplus nominees so that only a number of nominees equal to the number of Members to be returned for the constituency remain on the list.
- (10) The nominees whose names remain on a nomination list after the Returning Officer has taken the action referred to in subsections (6), (6A) and (9) (as arranged in the order of priority indicated on the nomination list if there are 2 or more such remaining nominees) are taken as constituting a list of candidates for the purposes of section 49.
- (11) If, before the date of the election, proof is given to the satisfaction of the Returning Officer that a candidate whose name appears on a list of candidates has died or is disqualified from being nominated as a candidate, the Returning Officer must strike out the name of that candidate from the list.
- (12) After striking out a name from a list of candidates under subsection (11), the Returning Officer must not add the name of any other person to the list.
- (13) If, after taking the action referred to in subsection (11), no name remains on the list of candidates, the Returning Officer must reject the list.
- (14) The candidates whose names remain on a list of candidates after the Returning Officer has taken the action referred to in subsection (11) are taken as constituting a new list of candidates that replaces the one constituted under subsection (10) for the purposes of section 49.

  - (c) 申訴專員及根據《申訴專員條例》(第397章)第6條獲委任的人;
  - (d) 選舉管理委員會的成員;
  - (e) 金融管理局的行政總裁及該局的高層管理人員,包括科主管、行政總監、經理及該局僱用的律師;或
  - (ea) 個人資料私隱專員及其根據《個人資料(私隱)條例》(第486章)僱用或聘用的人;

# When person is disqualified from being nominated as a candidate and from being elected as a Member (section 39 of the Legislative Council Ordinance (Cap. 542))

- (1) A person is disqualified from being nominated as a candidate at an election, and from being elected as a Member, if the person -
  - (a) is -
    - (i) a judicial officer; or
    - (ii) a prescribed public officer; or
    - (iii) an officer of the Legislative Council or a member of staff of The Legislative Council Commission; or
  - (b) has, in Hong Kong or any other place, been sentenced to death or imprisonment (by whatever name called) and has not either -
    - (i) served the sentence or undergone such other punishment as a competent authority may have been substituted for the sentence; or
    - (ii) received a free pardon; <sup>1</sup> or
  - (c) has been convicted of treason; or
  - (d) on the date of nomination, or of the election, is serving a sentence of imprisonment; or
  - (e) without limiting paragraph (b), where the election is to be held or is held within 5 years after the date of the person's conviction, is or has been convicted -
    - (i) in Hong Kong or any other place, of an offence for which the person has been sentenced to imprisonment, whether suspended or not, for a term exceeding 3 months without the option of a fine; or
    - (ii) of having engaged in corrupt or illegal conduct in contravention of the Elections (Corrupt and

The Court of First Instance delivered written judgment on 21 June 2012 on *Wong Hin Wai & another v Secretary for Justice* (HCAL 51&54/2012) and declared section 39(1)(b) of the Legislative Council Ordinance (Cap. 542) to be unconstitutional. On 12 July 2012, the Government announced its decision not to appeal against the judgment. The future Legislative Council elections will be held in accordance with the prevalent electoral laws. Any person who would like to be nominated as a candidate for a Legislative Council General Election and is doubtful about his/her eligibility for nomination may seek independent legal advice, and may also apply to the Nominations Advisory Committee (Legislative Council) appointed by the Electoral Affairs Commission for advice on or before 15 July 2016 in accordance with the existing electoral law.

- (g) is a representative or salaried functionary of a government of a place outside Hong Kong; or
- (h) is a member of any national, regional or municipal legislature, assembly or council of any place outside Hong Kong, other than a people's congress or people's consultative body of the People's Republic of China, whether established at the national or local level; or
- (i) is an undischarged bankrupt or, within the previous 5 years, has either obtained a discharge in bankruptcy or has entered into a voluntary arrangement within the meaning of the Bankruptcy Ordinance (Cap. 6) with the person's creditors, in either case without paying the creditors in full.
- (2) A person is also disqualified from being nominated as a candidate at an election if the person has been found under the Mental Health Ordinance (Cap. 136) to be incapable, by reason of mental incapacity, of managing and administering his or her property and affairs, but a person disqualified under this subsection is eligible for nomination as a candidate if, under that Ordinance, it is subsequently found that the person has become capable of managing and administering his or her property and affairs.
- (2A) A person is also disqualified from being nominated as a candidate at a by-election if
  - (a) within the 6 months ending on the date of the by-election
    - (i) the person's resignation under section 14 as a Member took effect; or
    - (ii) the person was taken under section 13(3) to have resigned from office as a Member; and
  - (b) no general election was held after the relevant notice of resignation or notice of non-acceptance took effect.
- (3) A person is also disqualified from being elected as a Member if the person has been found under the Mental Health Ordinance (Cap. 136) to be incapable, by reason of mental incapacity, of managing and administering his or her property and affairs, but a person disqualified under this subsection ceases to be disqualified if, under that Ordinance, it is subsequently found that the person has become capable of managing and administering his or her property and affairs.
- (4) A person is also disqualified from being elected as a Member for a functional constituency (other than the District Council (first) functional constituency and the District Council (second) functional constituency) if, since the close of nominations, the person has ceased to have a substantial connection with the constituency.
- (5) In this section -
  - "judicial officer" (司法人員) means the holder of a judicial office, as defined in section 2 of the Public Service Commission Ordinance (Cap. 93);
  - "prescribed public officer" (訂明的公職人員) means any of the following -
  - (a) the Chairman of the Public Service Commission;
  - the Commissioner and Deputy Commissioner of the Independent Commission Against Corruption and the holder of any other office under the Independent Commission Against Corruption Ordinance (Cap. 204);
  - (c) The Ombudsman and the holder of any appointment under section 6 of The Ombudsman Ordinance (Cap. 397);
  - (d) a member of the Electoral Affairs Commission;
  - the chief executive of the Monetary Authority and any member of the senior management of that Authority, including divisional heads, executive directors, managers and counsel employed by that Authority;
  - (ea) the Privacy Commissioner for Personal Data and any person employed or engaged by him or her under the Personal Data (Privacy) Ordinance (Cap. 486);
  - (eb) the Chairperson of the Equal Opportunities Commission and any person employed or whose services are engaged by the Commission under the Sex Discrimination Ordinance (Cap. 480);
  - (f) any person holding an office, whether permanent or temporary, in a Government department or bureau and employed in the department or bureau.

# What requirements are to be complied with by persons nominated as candidates (section 40 of the Legislative Council Ordinance (Cap. 542))

- (1) A person is not validly nominated as a candidate for an election for a constituency unless -
  - (a) a deposit has, in the manner prescribed by regulations in force under the Electoral Affairs Commission Ordinance (Cap. 541), been lodged by or on behalf of the person with the Returning Officer concerned; and
  - (b) the nomination form includes or is accompanied by -
    - (i) a declaration to the effect that the person will uphold the Basic Law and pledge allegiance to the Hong Kong Special Administrative Region; and
    - (ii) a declaration as to the person's nationality and as to whether or not the person has a right of abode in a country other than the People's Republic of China; and
    - (iii) a promissory oath given by the person to the effect that, if elected, he or she will not do anything during his or her term of office that results in his or her -
      - (A) becoming -
        - (I) a prescribed public officer within the meaning of section 39(5); or
        - (II) an officer of the Legislative Council or a member of staff of The Legislative Council Commission;
      - (B) being sentenced to death in Hong Kong or any other place;
      - (C) being convicted of treason;
      - (D) being convicted -
        - (I) of having engaged in corrupt or illegal conduct in contravention of the Elections (Corrupt and Illegal Conduct) Ordinance (Cap. 554); or
        - (II) of an offence against Part II of the Prevention of Bribery Ordinance (Cap. 201); or
        - (III) of any offence prescribed by regulations in force under the Electoral Affairs Commission Ordinance (Cap. 541);
      - (E) being disqualified from being elected as a Member at an election because of the operation

- of this or any other law;
- (F) becoming a representative or salaried functionary of a government of a place outside Hong Kong;
- (G) becoming a member of any national, regional or municipal legislature, assembly or council of any place outside Hong Kong, other than a people's congress or people's consultative body of the People's Republic of China, whether established at the national or local level:
- (H) becoming a member of the armed forces of the Central People's Government or any other country or territory; or
- (I) in the case of a Member elected for a functional constituency (other than the District Council (first) functional constituency and the District Council (second) functional constituency), ceasing to have a substantial connection with the constituency.
- (2) The person must sign the declarations.
- (3) The deposit is to be of such an amount as is prescribed by the regulations for the purposes of this section.

# Person not to be nominated for more than one constituency (section 41 of the Legislative Council Ordinance (Cap. 542))

- A person is not eligible to be nominated as a candidate for a constituency if the person is currently nominated as a candidate for another constituency.
- (2) The name of a person whose name is included in a nomination list for a geographical constituency is not, at the same election, eligible to be included in another list of candidates nominated for the constituency.
- (3) The name of a person whose name is included in a nomination list for the District Council (second) functional constituency is not, at the same election, eligible to be included in another list of candidates nominated for the constituency.
