### Notes on Completion of Nomination Form for a Geographical Constituency of the Legislative Council General Election

以下說明只供參考。有關提名事宜的法例，請參閱《立法會條例》（第542章）、《選舉（舞弊及非法行為）條例》（第554章）及其他有關法例，包括《選舉管理委員會（選舉程序）（立法會）規例》（第541D章）。

The Notes below are for reference only. For legislation concerning nomination matters, please refer to the Legislative Council Ordinance (Cap. 542), the Elections (Corrupt and Illegal Conduct) Ordinance (Cap. 554) and other relevant legislation, including the Electoral Affairs Commission (Electoral Procedure) (Legislative Council) Regulation (Cap. 541D).

1. 每份提名表格只能用以提名一份候選人名單。在2020年立法會換屆選舉中，5個地方選區須選出的議員人數詳列如下：

- (a) 香港島地方選區選出 6 名議員；
- (b) 九龍西地方選區選出 6 名議員；
- (c) 九龍東地方選區選出 5 名議員；
- (d) 新界西地方選區選出 9 名議員；以及
- (e) 新界東地方選區選出 9 名議員。

A separate nomination form must be used for each list of candidates. In the 2020 Legislative Council General Election, the number of Members to be returned for the 5 geographical constituencies are set out below:

- (a) the Hong Kong Island Geographical Constituency to return 6 Members;
- (b) the Kowloon West Geographical Constituency to return 6 Members;
- (c) the Kowloon East Geographical Constituency to return 5 Members;
- (d) the New Territories West Geographical Constituency to return 9 Members; and
- (e) the New Territories East Geographical Constituency to return 9 Members.

2. 候選人須向有關的選舉主任遞交一份完整的提名表格（包括第1至50頁）。如候選人在選舉事務處的網頁下載提名表格，請使用A4尺寸白色紙張列印。

Candidate(s) should submit a duly completed nomination form (including Page 1 to Page 50) to the relevant Returning Officer. If a candidate downloads the form from the website of the Registration and Electoral Office, please print on A4 size white papers.

3. 候選人的地址將不會提供予公眾查閱。候選人可另行提供聯絡資料予傳媒使用及公眾查閱，是否提供該等聯絡資料屬自願性質，而該等資料亦會提供予傳媒以便他們直接聯絡有關候選人。

Candidate's/Candidates' address(es) will not be made available for public inspection. Candidate(s) may choose to separately provide his/her/their contact information for the media and public inspection. The supply of such contact information is optional. The information will also be provided to the media to facilitate them to contact the candidate concerned directly.

4. 根據《立法會（提名所需的選舉按金及簽署人）規例》（第542C章），每份地方選區的提名表格須由100位提名人親自簽署表示同意提名，而每位提名人必須已登記為有關地方選區的選民，候選人不得以提名人身分在其提名表格內簽署。為避免因有提名人不符合資格而令提名失效，提名表格可由多於100位，但不超過200位提名人簽署。第20頁須由不少於10張分頁組成。第20頁的每張分頁均須填上由“20(1)”開始的順序頁碼。表格的每一頁（包括第20頁的所有分頁）在遞交提名表格時必須一併交予選舉主任。候選人應查證提名人的資格。倘若基於任何原因，某位提名人被發現不符合資格在提名表格上提名，他／她的提名將不予理會。候選人亦須提醒每位提名人應填寫在其身分證明文件（指提名人記錄在地方選區正式選民登記冊內的資料所依據的身分證明文件）上所顯示的姓名。

According to the Legislative Council (Subscribers and Election Deposit for Nomination) Regulation (Cap. 542C), a nomination form in respect of a geographical constituency must be personally signed and subscribed by 100 subscribers to indicate agreement to the nomination. All the subscribers must be registered electors for the relevant geographical constituency. Candidate(s) should not sign as

subscriber(s) on his/her/their nomination form. To avoid the risk of invalidation of the nomination if any subscriber is unqualified, the nomination form may be subscribed by more than 100 but not exceeding 200 subscribers. Page 20 of the form should comprise not less than 10 parts. Each of the parts of page 20 should be marked with a consecutive serial number starting with “20(1)”. All pages (including all parts of page 20) of the form must be returned to the Returning Officer in one complete set. A candidate should check the qualification of the subscribers. If for any reason a subscriber is found to be unqualified to subscribe the nomination form, his/her subscription will be disregarded. A candidate should also remind each subscriber to provide the name as shown on his/her identity document (being the identity document based on which the particulars of the subscriber are recorded in the geographical constituencies final register).

5. 每一位登記選民只可就其所屬的地方選區以提名人身分簽署一份提名表格。  
A registered elector is entitled to subscribe only ONE nomination form in respect of his/her own geographical constituency.

6. 候選人須為每名提名人編配一個優先編號。任何人在某份提名表格上以提名人身分簽署，如其簽署超出有效地提名有關候選人所需的提名人人數（由優先編號 1 起計），則該人將被視為不曾在該提名表格上以提名人身分簽署。在此情況下，該人可簽署另一份提名表格。  
Candidate should assign a priority number for each subscriber. Any person whose signature as a subscriber is in surplus of the number of qualified subscribers required to effect the nomination of the candidate concerned (counting from Priority No. 1 onwards) will be regarded as not having subscribed the nomination form. In this case, that person may subscribe another nomination form.

7. 請以中文及英文提供候選人的姓名及地址，以便根據《選舉管理委員會（選舉程序）（立法會）規例》（第 541D 章）在政府憲報上刊登有效提名公告及其他指定公告。候選人可選擇填寫其辦事處或業務地址、通訊地址<sup>1</sup>、住址或郵政信箱號碼作為地址。地址資料必須完整（見附錄第二部分）。另外，候選人必須填寫在其身分證明文件（指候選人記錄在地方選區正式選民登記冊內的資料所依據的身分證明文件，通常是其香港身分證）上所顯示的姓名（見附錄第一部分）。候選人在填寫中文姓名時須嚴格依照在其身分證明文件上所顯示的繁體字或簡體字寫法（按情況而定）。未能遵守這項規定會延誤檢查身分證明文件工作及／或令候選人須返回選舉主任辦事處更正寫法。如果選舉主任信納某候選人通常為人所知的姓名與其身分證明文件上所顯示的姓名有所不同，該候選人可在別名一欄中加上該姓名。**有效提名公告上顯示的候選人姓名（包括別名）會印在選票上。**有關填寫中文姓名及地址的注意事項，可參閱附錄。

For publication of the Notice of Valid Nominations and other specified notices in the Government Gazette in accordance with the Electoral Affairs Commission (Electoral Procedure) (Legislative Council) Regulation (Cap. 541D), please provide the name and address of the candidate in both Chinese and English. A candidate can fill in his/her office or business address, correspondence address<sup>1</sup>, residential address or post office box number as address. The address information should be complete (see Part II of Appendix). Besides, a candidate must provide the name as shown on his/her identity document (being the identity document based on which the particulars of the candidate are recorded in the geographical constituencies final register, which is usually his/her Hong Kong Identity Card) (see Part I of Appendix). The candidate should strictly follow the writing of his/her Chinese name as shown on his/her identity document in Traditional Chinese or Simplified Chinese (as the case may be). Failure to comply with this requirement would cause a delay in checking the candidate's identity document and/or require him/her to return to the Returning Officer's office for rectification. If the Returning Officer is satisfied that the candidate is usually known by a name different from that shown on his/her identity document, that candidate may include such different name as his/her alias. **The name(s) (including alias(es)) of the candidate(s) as shown in the Notice of Valid Nominations will be printed on the ballot papers.** Candidates may refer to the Appendix for the points to note when filling in the Chinese name and address.

If an address of another person/organisation is used as correspondence address, the prior consent of the person/organisation concerned must be obtained.

8. 根據《選舉管理委員會（選舉程序）（立法會）規例》（第 541D 章）第 19(3)及(4)條，選舉主任必須將一份關於某人是否獲有效提名的決定的通知，送交該人及有關選區的每名獲有效提名的候選人。這份通知必須按各候選人在有關的提名表格上所提供的地址送交。  
According to section 19(3) and (4) of the Electoral Affairs Commission (Electoral Procedure) (Legislative Council) Regulation (Cap. 541D), the Returning Officer must send a notice of a decision that a person is validly nominated or is not validly nominated to the person concerned and each validly nominated candidate for the constituency concerned. Such a notice must be sent to the address of the candidate as given on the nomination form.
9. 如提名表格載有多於一名候選人，則該等候選人的姓名必須按該候選人名單中的人士的排名次序排列。在接收提名表格後，選舉主任會從提名名單中剔除不獲有效提名、已撤回提名及去世的候選人，而名列該名單的候選人姓名的排名次序排列亦會據此調整。如在提名期結束後，仍在提名名單上的候選人的人數多於有關選區須選出的議員人數，則選舉主任須顧及該等候選人於該名單上的排名次序，而將多出的候選人的姓名從名單上除去。除有關提名是否有效的通知外，所有由選舉事務處或選舉主任發出的信件、重要資料及公告，將會以電郵、傳真或按提名表格上所提供的通訊地址<sup>1</sup>（如有的話）送交給名單中排名第一的候選人。  
If a nomination form contains the names of 2 or more candidates, the names must be ranked in the order of priority of the list of candidates. Upon receiving the nomination form, the Returning Officer will strike out the name of any candidate who is not validly nominated, whose nomination has been withdrawn from the nomination list or has died and adjust the order of priority accordingly. If, after the close of nominations, the number of names of candidates on a nomination list exceeds the number of Members to be returned for the constituency concerned, the Returning Officer will, having regard to the order of priority, exclude from the list the names of the surplus candidates. All correspondence, important information and notices, except the relevant notices on the validity of a nomination, from the Registration and Electoral Office or the Returning Officer will be sent to the candidate ranking first in priority on a list by email, by fax or by mail to the correspondence address<sup>1</sup>, if provided, as given on the nomination form.
10. 候選人可選擇在提名表格填寫其職業及政治聯繫的資料，此等資料將會供公眾查閱。如候選人公開其政治聯繫時提及任何團體的名稱，他／她必須先取得有關團體的同意。候選人的姓名、性別、職業及政治聯繫的資料亦會在 2020 年立法會換屆選舉的專用網站發布。如候選人在「候選人簡介」的方格表或「立法會功能界別候選人、立法會提名名單上單一候選人或區議會選區候選人提出於選票上印上關於候選人的詳情的請求」（REO/BP/7/2020(SF)）／「有多於一名候選人的立法會提名名單上的候選人提出於選票上印上關於候選人的詳情的請求」（REO/BP/8/2020(SF)）指明表格上提供資料（例如職業及政治聯繫），有關資料應與提名表格上的資料無抵觸。  
A candidate may choose to state his/her occupation and political affiliation in the nomination form, which will be made available for public inspection. If the candidate mentions the name of any organisation when stating his/her political affiliation, he/she must seek the consent of the organisation concerned beforehand. Candidate's name, sex, occupation and political affiliation will also be published in the dedicated website for the 2020 Legislative Council General Election. Information (such as occupation and political affiliation) provided by candidate(s) in the Grid Paper for "Introduction to Candidates" or the specified form "Request by a Candidate for a Legislative Council Functional Constituency or a Sole Candidate on a Legislative Council Nomination List or by a Candidate for a District Council Constituency for Printing of Particulars Relating to the Candidate on a Ballot Paper" (REO/BP/7/2020(SF)) / "Request by Candidates on a Legislative Council Nomination List with More than One Candidate for Printing of Particulars Relating to the Candidates on a Ballot Paper" (REO/BP/8/2020(SF)) should not be inconsistent with the information stated in the nomination form.
11. 提名表格必須在提名期：2020 年 7 月 18 日至 2020 年 7 月 31 日內（首尾兩天包括在內），除公眾假期外的任何日子，於通常辦公時間內（星期一至星期五：上午九時至下午五時；星期六：上午九時至中午十二時）由名單上的候選人或其中一名候選人親自（已向總選舉事務主任申請並獲認可以任何其他方式呈交者除外）送交有關的選舉主任。根據《選舉管理委員會（選舉程序）（立法會）規例》（第 541D 章）第 2A(3)條，如提名期的最後一日適逢惡劣天氣警告

日（在該工作日中，在通常辦公時間內的任何時間有烈風警告或暴雨警告生效；烈風警告及暴雨警告的涵義與該詞在《司法程序（烈風警告期間聆訊延期）條例》（第 62 章）中的涵義相同），提名期將會延長至並非惡劣天氣警告日的下一個工作日結束。除提名表格外，候選人須一併遞交—

A nomination form must be handed in by the candidate/one of the candidates on the nomination list **in person** (except where the Chief Electoral Officer has, on application, authorized any other manner of submission) and received by the relevant Returning Officer within the nomination period from 18 July 2020 to 31 July 2020 (both days inclusive) during ordinary business hours (Monday to Friday: from 9 am to 5 pm; Saturday: from 9 am to 12 noon) on any day other than a general holiday. According to section 2A(3) of the Electoral Affairs Commission (Electoral Procedure) (Legislative Council) Regulation (Cap. 541D), if the last day of the nomination period falls on an inclement weather warning day (a working day on which a gale warning or a rainstorm warning is in force at any time during ordinary business hours; gale warning and rainstorm warning have the same meaning as in the Judicial Proceedings (Adjournment During Gale Warnings) Ordinance (Cap. 62)), the period is extended to end on the next working day which is not an inclement weather warning day. The nomination form should be accompanied by –

- (a) 選舉按金港幣 50,000 元，以現金或劃線支票／銀行本票（抬頭請寫「香港特別行政區政府」）支付。**為避免因支票遭銀行退票而令提名失效，強烈建議候選人應盡量以現金或銀行本票支付選舉按金；**及  
an election deposit in the sum of HK\$50,000, in cash or by crossed cheque/cashier order made payable to “The Government of the Hong Kong Special Administrative Region”. **In order to avoid the risk of invalidation of the nomination due to dishonoured cheque, candidates are strongly advised to submit the election deposit in cash or by cashier order;** and
- (b) 提名名單上每名候選人根據《立法會條例》（第 542 章）第 40(1)(b)(iii)條作出的採用承諾形式的誓言（已附夾在提名表格內）；  
（採用承諾形式的誓言必須在一位監誓員、公證人、太平紳士或持有執業證書的律師面前作出。）  
a promissory oath by each candidate on the nomination list to the effect as required in section 40(1)(b)(iii) of the Legislative Council Ordinance (Cap. 542) (already attached to the nomination form).  
(The promissory oath has to be made before a Commissioner for Oaths, a Notary Public, a Justice of the Peace or a solicitor holding a practising certificate.)

候選人請留意，提名表格必須載有上述採用承諾形式的誓言。

Candidate(s) should note that the nomination form must include the promissory oath mentioned above.

12. 準候選人應盡早呈交提名表格，以便於提名期結束前，將提名表格上可能發現的錯處更正。  
Prospective candidate(s) is/are strongly advised to submit his/her/their nomination form as early as practicable so that any mistakes found in his/her/their nomination form can be rectified before the end of nomination period.
13. 任何提名表格所載候選人姓名或其他重要資料如經更改，將可能不被選舉主任接納。  
The Returning Officer may not accept any nomination form on which the name or other important particulars of the candidate(s) has/have been amended, altered or corrected.
14. 選舉主任就提名是否有效所作的決定，除以選舉呈請提出質疑外，不可循任何法律程序提出質疑。  
The Returning Officer’s decision on the validity of a nomination cannot be questioned in any proceeding except by an election petition.
15. 提名表格必須按《立法會條例》（第 542 章）及《選舉管理委員會（選舉程序）（立法會）規例》（第 541D 章）的規定列載所需的資料，提名方才有效。在決定候選人是否合乎資格及其提名有效與否時，有關的選舉主任可要求候選人提供其認為適當的額外資料。

A nomination will not be valid unless the nomination form contains the information as required in the Legislative Council Ordinance (Cap. 542) and the Electoral Affairs Commission (Electoral Procedure) (Legislative Council) Regulation (Cap. 541D). The Returning Officer concerned may request such additional information from candidate(s) as he/she considers appropriate to satisfy himself/herself as to the eligibility of the candidate(s) and the validity of the nomination.

16. 候選人不得在 2020 年的立法會換屆選舉中在超過一個地方選區或功能界別獲得提名。候選人呈交提名表格時，必須已撤回所有其他選區或界別的提名，否則，他／她其後所呈交的提名表格將被當作無效。

A candidate cannot be nominated for more than one geographical or functional constituency in the 2020 Legislative Council General Election. When he/she submits his/her nomination form, he/she must have withdrawn his/her nomination in respect of all other constituencies, if any, or else his/her nomination form subsequently submitted will be treated as invalid.

17. 根據《選舉管理委員會（選舉程序）（立法會）規例》（第 541D 章）第 103 條，任何人在與選舉有關的文件中作出他／她明知在要項上屬虛假的陳述，或任何人罔顧後果地在該等文件中作出在要項上不正確的陳述，或任何人明知而在該等文件中遺漏任何要項，均屬犯罪。

In accordance with section 103 of the Electoral Affairs Commission (Electoral Procedure) (Legislative Council) Regulation (Cap. 541D), a person who, in an election related document, makes a statement which that person knows to be false in a material particular or recklessly makes a statement which is incorrect in a material particular or knowingly omits a material particular from an election related document commits an offence.

18. 候選人如欲撤回提名，可填寫一份「候選人退選通知書」的指明表格（REO/C/5/2020LC(SF)），並於提名期結束前送遞予有關的選舉主任。

If a candidate wishes to withdraw his/her nomination, he/she may do so by completing and delivering to the Returning Officer concerned a “Notice of Withdrawal of Candidature” in a specified form (REO/C/5/2020LC(SF)) before the end of nomination period.

19. 本提名表格第二部分必須於見證人在場下由各名候選人填寫及簽署。任何年滿18歲並持有身分證明文件的人士均可擔任見證人。見證人必須填寫及簽署本提名表格第三部分。根據《立法會條例》（第542章）第3(1)條，「身分證明文件」（identity document）指—

PART II of this nomination form should be completed and signed by each of the candidate(s) in the presence of a witness who can be any person who is in possession of an identity document and aged 18 years or over. The witness is required to complete PART III of this nomination form and sign thereunder. According to section 3(1) of the Legislative Council Ordinance (Cap. 542), “identity document” (身分證明文件) means –

- (a) 根據《人事登記條例》（第 177 章）向某人發出的身分證；或  
an identity card issued to a person under the Registration of Persons Ordinance (Cap. 177); or
- (b) 《人事登記條例》（第 177 章）第 1A(1)條所指的人事登記處處長向某人發出的文件，而該文件證明該人根據《人事登記規例》（第 177A 章）第 25 條獲豁免，無須根據該條例登記；或  
a document issued by the Commissioner of Registration (within the meaning of section 1A(1) of the Registration of Persons Ordinance (Cap. 177)) to a person certifying that the person is exempt, under regulation 25 of the Registration of Persons Regulations (Cap. 177A), from being required to register under that Ordinance; or
- (c) 向某人發出的獲選舉登記主任接受為該人的身分證明的任何其他文件。  
any other document issued to a person that is acceptable to the Electoral Registration Officer as proof of the person’s identity.

20. 如有任何關於填寫提名表格的查詢，請與選舉主任聯絡或致電選舉事務處查詢熱線 2891 1001。  
For enquiries concerning the completion of the nomination form, please contact the Returning Officer or call the Enquiry Hotline of the Registration and Electoral Office at 2891 1001.

21. 根據《立法會條例》（第 542 章）第 37(1)、38、39、40 及 41 條，有關獲提名為候選人的資格、喪失獲提名為候選人或當選為議員的資格的情況、獲提名的候選人須遵從的規定及不得就多於一個選區或選舉界別獲得提名的規定載列如下，以供參考—

Eligibility for being nominated as a candidate, disqualification from being nominated as a candidate and from being elected as a Member, requirements to be complied with by persons nominated as candidates and the requirement for a person not to be nominated for more than one constituency are dealt with in sections 37(1), 38, 39, 40 and 41 of the Legislative Council Ordinance (Cap. 542) which are reproduced below for reference -

**獲提名為候選人的資格（《立法會條例》（第 542 章）第 37(1) 條）**

- (1) 符合以下條件的人方有資格在地方選區的選舉中獲提名為候選人—
- (a) 年滿 21 歲；及
  - (b) 已登記為地方選區的選民並有資格如此登記；及
  - (c) 並未有憑藉第 39 條或任何其他法律喪失獲選為議員的資格；及
  - (d) 在緊接提名前的 3 年內通常在香港居住；及
  - (e) 是香港永久性居民中的中國公民，並且沒有中華人民共和國以外的國家的居留權。

**Who is eligible to be nominated as a candidate (section 37(1) of the Legislative Council Ordinance (Cap. 542))**

- (1) A person is eligible to be nominated as a candidate at an election for a geographical constituency only if the person -
- (a) has reached 21 years of age; and
  - (b) is both registered and eligible to be registered as an elector for a geographical constituency; and
  - (c) is not disqualified from being elected as a Member by virtue of section 39 or any other law; and
  - (d) has ordinarily resided in Hong Kong for the 3 years immediately preceding the nomination; and
  - (e) is a Chinese citizen who is a permanent resident of Hong Kong with no right of abode in any country other than the People's Republic of China.

**地方選區及區議會(第二)功能界別的提名名單（《立法會條例》（第 542 章）第 38 條）**

- (1) 在本條中—
- “獲提名人” (nominee) 指姓名被列入提名名單內作為候選人的人。
- (2) 在地方選區或在區議會（第二）功能界別參加議員選舉的候選人的提名，須採用向選舉主任呈交名單的方式作出，該名單須載有—
- (a) 以組合形式在該選區或選舉界別的選舉中競選的多於一名人士的姓名；或
  - (b) 以單一候選人身分在該項選舉中競選的人的姓名。
- (3) 提名名單必須—
- (a) 按照以下規定呈交—
    - (i) 以符合根據《選舉管理委員會條例》（第 541 章）訂立並正有效的規例的提名表格呈交；
    - (ii) 由名列該提名名單的獲提名人呈交；
    - (iii) 於提名期內呈交；及
    - (iv) 按上述規例訂明的方式呈交；
  - (b) 附有名列該提名名單的每一名獲提名人以指明表格作出的同意書；及
  - (c) 載有根據《選舉管理委員會條例》（第 541 章）訂立並正有效的規例所規定的任何其他詳情。
- (4) 如為某組合呈交的提名名單載有多於一名人士的姓名，則該等姓名必須按該組合中的人士的優先次序排列。
- (4A) 在提名名單呈交選舉主任後—
- (a) 名列於該名單的獲提名人的姓名次序不能改動；
  - (b) 不能將其他人的姓名加入該名單；及
  - (c) 已在該名單內的人的姓名亦不能刪除。
- (5) 選舉主任必須裁定提名名單上的每名獲提名人是否獲有效提名。
- (6) 如—
- (a) 選舉主任裁定任何獲提名人不獲有效提名；
  - (b) 任何獲提名人的提名被撤回；或
  - (c) 任何獲提名人去世，
- 則選舉主任必須自提名名單剔除該獲提名人的姓名，而名列該名單的獲提名人的姓名的優先次序亦須據此調整。
- (6A) 選舉主任在裁定某獲提名人是獲有效提名之後，如在提名期結束之前接獲證明並信納該人已去世或喪失獲提名資格，選舉主任必須自提名名單剔除該人的姓名，並據此調整名列該名單的獲提名人的姓名的優先次序。



- (7) 如按照第(6)或(6A)款將獲提名人的姓名從提名名單上作出剔除後，該名單上再無任何姓名，則選舉主任必須拒絕接納該名單。
- (8) (重編為第(4A)款)
- (9) 如在提名期結束後，仍在提名名單上的獲提名人的的人數多於有關選區或選舉界別須選出的議員的人數，則選舉主任須顧及該等獲提名人於該名單上的排列次序，而將多出的獲提名人的姓名從名單上除去，使仍在該名單上的獲提名人的的人數與該選區或選舉界別須選出的議員的人數相同。
- (10) 選舉主任在根據第(6)、(6A)及(9)款剔除獲提名人的姓名後，仍在提名名單上的獲提名人須按其姓名列於該名單上的同一優先次序排列(如有多於一名所餘獲提名人)，而為第 49 條的目的，該名單即視作為候選人名單。
- (11) 如在選舉日期之前，選舉主任接獲證明並信納任何名列某候選人名單的候選人已去世或喪失獲提名為候選人的資格，選舉主任必須自該名單剔除該候選人的姓名。
- (12) 選舉主任在根據第(11)款自某候選人名單剔除任何姓名後，不得將任何其他人的姓名加入該名單內。
- (13) 如在採取第(11)款所提述的行動後，候選人名單上再無任何姓名，則選舉主任必須拒絕接納該名單。
- (14) 在選舉主任採取第(11)款所提述的行動後仍在候選人名單上的候選人，為第 49 條的目的，即視作為組成新的候選人名單，以取代根據第(10)款組成的名單。

***Nomination lists for geographical constituencies and District Council (second) functional constituency (section 38 of the Legislative Council Ordinance (Cap. 542))***

- (1) In this section -  
“nominee” (獲提名人) means a person whose name is included in a nomination list as a candidate.
- (2) The nomination of candidates for election as Members for a geographical constituency or the District Council (second) functional constituency is to be by a list submitted to the Returning Officer containing either -
  - (a) the names of 2 or more persons contesting the election for that constituency as a group; or
  - (b) the name of a person contesting that election as a single candidate.
- (3) A nomination list must -
  - (a) be submitted -
    - (i) on a nomination form that complies with regulations in force under the Electoral Affairs Commission Ordinance (Cap. 541);
    - (ii) by a nominee on the nomination list concerned;
    - (iii) within the nomination period; and
    - (iv) in the manner prescribed by those regulations; and
  - (b) be accompanied by the written consent, made on the nomination form, of each nominee on the nomination list; and
  - (c) contain any other particulars required by regulations in force under the Electoral Affairs Commission Ordinance (Cap. 541).
- (4) If a nomination list contains the names of 2 or more persons, the names are to be ranked in the order of priority of the group for which the nomination list is submitted.
- (4A) After a nomination list has been submitted to a Returning Officer -
  - (a) the order in which names of nominees appear in the list cannot be altered;
  - (b) the names of other persons cannot be added to the list; and
  - (c) the names of persons already on the list cannot be deleted.
- (5) The Returning Officer must determine, for each nominee whose name appears on the nomination list, whether or not the nominee is validly nominated.
- (6) If -
  - (a) the Returning Officer determines that a nominee is not validly nominated; or
  - (b) a nominee’s nomination is withdrawn; or
  - (c) a nominee dies,
 that Officer must strike out the name of that nominee from the nomination list and adjust the order of priority in which the names of nominees appear on that list accordingly.
- (6A) If, after the Returning Officer has determined that a nominee is validly nominated, but before the close of nominations, proof is given to the satisfaction of the Returning Officer that the nominee has died or is disqualified from being nominated, that Officer must strike out the name of that nominee from the nomination list and adjust the order of priority in which the names of nominees appear on that list accordingly.
- (7) If, after striking out names from a nomination list in accordance with subsection (6) or (6A), no name remains on the list, the Returning Officer must reject the list.
- (8) (Renumbered as subsection (4A))

- (9) If, after the close of nominations, the names of more nominees remain on a nomination list than the number of Members to be returned for the constituency concerned, the Returning Officer must, having regard to the order in which the nominees' names appear on the list, exclude from the list the names of the surplus nominees so that only a number of nominees equal to the number of Members to be returned for the constituency remain on the list.
- (10) The nominees whose names remain on a nomination list after the Returning Officer has taken the action referred to in subsections (6), (6A) and (9) (as arranged in the order of priority indicated on the nomination list if there are 2 or more such remaining nominees) are taken as constituting a list of candidates for the purposes of section 49.
- (11) If, before the date of the election, proof is given to the satisfaction of the Returning Officer that a candidate whose name appears on a list of candidates has died or is disqualified from being nominated as a candidate, the Returning Officer must strike out the name of that candidate from the list.
- (12) After striking out a name from a list of candidates under subsection (11), the Returning Officer must not add the name of any other person to the list.
- (13) If, after taking the action referred to in subsection (11), no name remains on the list of candidates, the Returning Officer must reject the list.
- (14) The candidates whose names remain on a list of candidates after the Returning Officer has taken the action referred to in subsection (11) are taken as constituting a new list of candidates that replaces the one constituted under subsection (10) for the purposes of section 49.

- (1) 任何人如有以下情況，即喪失在選舉中獲提名為候選人的資格及當選為議員的資格—
  - (a) 是—
    - (i) 司法人員；或
    - (ii) 訂明的公職人員；或
    - (iii) 立法會的人員或立法會管理委員會的職員；或
  - (b) 已在香港或任何其他地方被判處死刑或監禁（不論如何稱述），但—
    - (i) 既未服該刑罰或主管當局用以替代該項刑罰的其他懲罰；而
    - (ii) 亦未獲赦免；<sup>2</sup>或
  - (c) 已被裁定犯叛逆罪；或
  - (d) 在提名當日或選舉當日正因服刑而受監禁；或
  - (e) 在不局限(b)段的原則下，被裁定或曾被裁定犯以下罪行，而選舉於或將於其被定罪的日期後的 5 年內舉行—
    - (i) 任何罪行（不論是在香港或是在任何其他地方被定罪），並就該罪行被判處為期超過 3 個月而又不得選擇以罰款代替的監禁（不論是否獲得緩刑）；或
    - (ii) 在違反《選舉（舞弊及非法行為）條例》（第 554 章）的情況下作出舞弊或非法行為；或
    - (iii) 《防止賄賂條例》（第 201 章）第 II 部所訂的罪行；或
    - (iv) 根據《選舉管理委員會條例》（第 541 章）訂立並正有效的規例所訂明的任何罪行；或
  - (f) 因本條例或任何其他法律的施行而—
    - (i) 無資格在選舉中成為候選人或當選為議員；或
    - (ii) 喪失在選舉中成為候選人或當選為議員的資格；或
  - (g) 是香港以外地方的政府的代表或該政府的受薪政府人員；或
  - (h) 是香港以外任何地方的國家級、地區級或市級立法機關、議院或議會（中華人民共和國的全國或地方人民代表大會或人民協商機構除外）的成員；或
  - (i) 是未獲解除破產的人，或於過去 5 年內在沒有向債權人全數償還債務的情況下，獲解除破產或與其債權人訂立《破產條例》（第 6 章）所指的自願安排的人。
- (2) 任何人如根據《精神健康條例》（第 136 章）已被裁斷為因精神上無行為能力而無能力處理和管理其財產及事務，即喪失在選舉中獲提名為候選人的資格，但如在其後根據該條例被裁斷為已有能力處理和管理其財產及事務，則根據本款喪失資格的人有獲提名為候選人的資格。

- “司法人員” (judicial officer) 指擔任《公務員絀用委員會條例》（第 93 章）第 2 條所界定的司法職位的人；
- “訂明的公職人員” (prescribed public officer) 指—
- (a) 公務員絀用委員會主席；
  - (b) 廉政專員、副廉政專員及擔任在《廉政公署條例》（第 204 章）下的任何其他職位的人；
  - (c) 申訴專員及根據《申訴專員條例》（第 397 章）第 6 條獲委任的人；
  - (d) 選舉管理委員會的成員；
  - (e) 金融管理局的行政總裁及該局的高層管理人員，包括科主管、行政總監、經理及該局僱用的律師；或
  - (ea) 個人資料私隱專員及其根據《個人資料（私隱）條例》（第 486 章）僱用或聘用的人；
  - (eb) 平等機會委員會的主席及由該委員會根據《性別歧視條例》（第 480 章）僱用或聘用的人；
  - (f) 受僱於政府部門或政策局而在該政府部門或政策局任職（不論該職位屬永久性或臨時性的）的人。

***When person is disqualified from being nominated as a candidate and from being elected as a Member (section 39 of the Legislative Council Ordinance (Cap. 542))***

- (1) A person is disqualified from being nominated as a candidate at an election, and from being elected as a Member, if the person -
- (a) is -
    - (i) a judicial officer; or
    - (ii) a prescribed public officer; or
    - (iii) an officer of the Legislative Council or a member of staff of The Legislative Council Commission; or
  - (b) has, in Hong Kong or any other place, been sentenced to death or imprisonment (by whatever name called) and has not either -
    - (i) served the sentence or undergone such other punishment as a competent authority may have been substituted for the sentence; or
    - (ii) received a free pardon;<sup>2</sup> or
  - (c) has been convicted of treason; or
  - (d) on the date of nomination, or of the election, is serving a sentence of imprisonment; or
  - (e) without limiting paragraph (b), where the election is to be held or is held within 5 years after the date of the person's conviction, is or has been convicted -
    - (i) in Hong Kong or any other place, of an offence for which the person has been sentenced to imprisonment, whether suspended or not, for a term exceeding 3 months without the option of a fine; or
    - (ii) of having engaged in corrupt or illegal conduct in contravention of the Elections (Corrupt and Illegal Conduct) Ordinance (Cap. 554); or

<sup>2</sup> The Court of First Instance delivered written judgment on 21 June 2012 on *Wong Hin Wai & another v Secretary for Justice* (HCAL 51&54/2012) and declared section 39(1)(b) of the Legislative Council Ordinance (Cap. 542) to be unconstitutional. On 12 July 2012, the Government announced its decision not to appeal against the judgment. The future Legislative Council elections will be held in accordance with the prevalent electoral laws. Any person who would like to be nominated as a candidate for a Legislative Council General Election and is doubtful about his/her eligibility for nomination may seek independent legal advice, and may also apply to the Nominations Advisory Committee (Legislative Council) appointed by the Electoral Affairs Commission for advice on or before 17 July 2020 in accordance with the existing electoral law. However, the law does not empower or require the Nominations Advisory Committee to advise on any matter relating to the requirements under section 40 of the Legislative Council Ordinance (Cap. 542).

- (g) is a representative or salaried functionary of a government of a place outside Hong Kong; or
- (h) is a member of any national, regional or municipal legislature, assembly or council of any place outside Hong Kong, other than a people's congress or people's consultative body of the People's Republic of China, whether established at the national or local level; or
- (i) is an undischarged bankrupt or, within the previous 5 years, has either obtained a discharge in bankruptcy or has entered into a voluntary arrangement within the meaning of the Bankruptcy Ordinance (Cap. 6) with the person's creditors, in either case without paying the creditors in full.
- (2) A person is also disqualified from being nominated as a candidate at an election if the person has been found under the Mental Health Ordinance (Cap. 136) to be incapable, by reason of mental incapacity, of managing and administering his or her property and affairs, but a person disqualified under this subsection is eligible for nomination as a candidate if, under that Ordinance, it is subsequently found that the person has become capable of managing and administering his or her property and affairs.
- (2A) A person is also disqualified from being nominated as a candidate at a by-election if -
- (a) within the 6 months ending on the date of the by-election -
    - (i) the person's resignation under section 14 as a Member took effect; or
    - (ii) the person was taken under section 13(3) to have resigned from office as a Member; and
  - (b) no general election was held after the relevant notice of resignation or notice of non-acceptance took effect.
- (3) A person is also disqualified from being elected as a Member if the person has been found under the Mental Health Ordinance (Cap. 136) to be incapable, by reason of mental incapacity, of managing and administering his or her property and affairs, but a person disqualified under this subsection ceases to be disqualified if, under that Ordinance, it is subsequently found that the person has become capable of managing and administering his or her property and affairs.
- (4) A person is also disqualified from being elected as a Member for a functional constituency (other than the District Council (first) functional constituency and the District Council (second) functional constituency) if, since the close of nominations, the person has ceased to have a substantial connection with the constituency.
- (5) In this section -
- “judicial officer” (司法人員) means the holder of a judicial office, as defined in section 2 of the Public Service Commission Ordinance (Cap. 93);
- “prescribed public officer” (訂明的公職人員) means any of the following -
- (a) the Chairman of the Public Service Commission;
  - (b) the Commissioner and Deputy Commissioner of the Independent Commission Against Corruption and the holder of any other office under the Independent Commission Against Corruption Ordinance (Cap. 204);
  - (c) The Ombudsman and the holder of any appointment under section 6 of The Ombudsman Ordinance (Cap. 397);
  - (d) a member of the Electoral Affairs Commission;
  - (e) the chief executive of the Monetary Authority and any member of the senior management of that Authority, including divisional heads, executive directors, managers and counsel employed by that Authority;
  - (ea) the Privacy Commissioner for Personal Data and any person employed or engaged by him or her under the Personal Data (Privacy) Ordinance (Cap. 486);
  - (eb) the Chairperson of the Equal Opportunities Commission and any person employed or whose services are engaged by the Commission under the Sex Discrimination Ordinance (Cap. 480);
  - (f) any person holding an office, whether permanent or temporary, in a Government department or bureau and employed in the department or bureau.

- (a) a deposit has, in the manner prescribed by regulations in force under the Electoral Affairs Commission Ordinance (Cap. 541), been lodged by or on behalf of the person with the Returning Officer concerned; and
  - (b) the nomination form includes or is accompanied by -
    - (i) a declaration to the effect that the person will uphold the Basic Law and pledge allegiance to the Hong Kong Special Administrative Region; and
    - (ii) a declaration as to the person's nationality and as to whether or not the person has a right of abode in a country other than the People's Republic of China; and
    - (iii) a promissory oath given by the person to the effect that, if elected, he or she will not do anything during his or her term of office that results in his or her -
      - (A) becoming -
        - (I) a prescribed public officer within the meaning of section 39(5); or
        - (II) an officer of the Legislative Council or a member of staff of The Legislative Council Commission;

        - (III) of any offence prescribed by regulations in force under the Electoral Affairs Commission Ordinance (Cap. 541);
      - (E) being disqualified from being elected as a Member at an election because of the operation of this or any other law;

- (F) becoming a representative or salaried functionary of a government of a place outside Hong Kong;
  - (G) becoming a member of any national, regional or municipal legislature, assembly or council of any place outside Hong Kong, other than a people's congress or people's consultative body of the People's Republic of China, whether established at the national or local level;
  - (H) becoming a member of the armed forces of the Central People's Government or any other country or territory; or
  - (I) in the case of a Member elected for a functional constituency (other than the District Council (first) functional constituency and the District Council (second) functional constituency), ceasing to have a substantial connection with the constituency.
- (2) The person must sign the declarations.
- (3) The deposit is to be of such an amount as is prescribed by the regulations for the purposes of this section.

- (3) The name of a person whose name is included in a nomination list for the District Council (second) functional constituency is not, at the same election, eligible to be included in another list of candidates nominated for the constituency.

Candidates have the responsibility to ensure that the Returning Officer can contact him/her through the address provided.
