- (c) knowingly omit any material particular from any document referred to in paragraph (a).

A person who contravenes the above regulation commits an offence and is liable to a fine at level 2 and to imprisonment for 6 months.

The Electoral Affairs Commission must process any application made in any annual registration cycle —

- (a) if the application is made on or before the relevant cut-off date of that annual registration cycle, as soon as practicable after that cut-off date, and in any event within that annual registration cycle; or
- (b) if the application is made after the relevant cut-off date of that annual registration cycle, as soon as practicable after the relevant cut-off date of the next following annual registration cycle, and in any event within the next following annual registration cycle.

"Annual registration cycle" means the period that begins on 1 January of a year and ends on 31 December of the same year. "Relevant cut-off date" means 15 July in relation to the annual registration cycle ending on 31 December 2021; or 15 June in that annual registration cycle in relation to any subsequent annual registration cycle.
