The information to be made available for online public inspection will not include the identity document number, correspondence address, telephone number, personal photograph and signature of the candidate concerned.

(b) Transfer of Information

The information in this form may be provided to other authorised departments or persons including but not limited to the law courts for election-related purposes.

(c) Access to Personal Data

Any person has the right to request access to and correction of the personal data he/she supplied in accordance with the provisions of the Personal Data (Privacy) Ordinance (Cap. 486).
