For instance, a member of the Election Committee may choose to subscribe a candidate in the capacity as an elector in respect of his/her own functional constituency, and subscribe another candidate in his/her capacity as a member of the Election Committee. He/she may also choose to subscribe in both capacities and sign on both Section 2 and Section 3 of the same nomination form of a candidate of the functional constituency.

Notes on Completion of Nomination Form for a Functional Constituency of the Legislative Council General Election

The Notes below are for reference only. For legislation concerning nomination matters, please refer to the Legislative Council Ordinance (Cap. 542), the Elections (Corrupt and Illegal Conduct) Ordinance (Cap. 554) and other relevant legislation, including the Electoral Affairs Commission (Electoral Procedure) (Legislative Council) Regulation (Cap. 541D).

If a candidate downloads the nomination form from the website of the Registration and Electoral Office, please print on **A4 size white papers**. Please do not use pencil or erasable pen to fill in the nomination form.

According to the Legislative Council (Subscribers and Election Deposit for Nomination) Regulation (Cap. 542C), a nomination form in respect of a functional constituency must be **personally signed and subscribed by no fewer than 10 registered electors as subscribers for the relevant functional constituency to indicate agreement to the nomination**. A candidate should not sign as a subscriber in his/her nomination form. To avoid the risk of invalidation of the nomination if any subscriber is unqualified, the nomination form may be subscribed by more than 10 but not exceeding 20 subscribers. Please use the "Supplementary Sheet for Subscribers" if the space provided in this nomination form is insufficient. All the subscribers must be registered electors for the functional constituency concerned. A candidate is advised to check the qualification of the subscribers. If for any reason a subscriber is found to be unqualified, his/her name will be disregarded. If the subscriber is an individual elector, he/she must provide the name as shown on his/her identity document (being the identity document based on which the particulars of the subscriber are recorded in the geographical constituencies final register). In the case of a corporate elector, the subscription of the nomination form by that elector may only be effected by that elector's authorized representative. The authorized representative must provide the corporate elector's name as shown in the functional constituencies final register.

Out of the 28 functional constituencies, only the Labour functional constituency is to return three Members to the Legislative Council, and each of the remaining 27 functional constituencies is to return one Member. Thus, an elector of the Labour functional constituency is entitled to subscribe up to three nomination forms in the capacity as a subscriber of the Labour functional constituency, whereas an elector of any other functional constituency is entitled to subscribe only one nomination form in the capacity as a subscriber in respect of his/her/its own functional constituency.

According to the Legislative Council (Subscribers and Election Deposit for Nomination) Regulation (Cap. 542C), a nomination form in respect of a functional constituency must be **subscribed by at least 10 but not more than 20 members of the Election Committee (other than the candidate), which must include at least 2 but not more than 4 members from each of the 5 sectors of the Election Committee**. A candidate should not sign as a subscriber on his/her nomination form. Candidate may use the “2021 Legislative Council General Election Supplementary Sheet for Subscribers from the Election Committee” (Form no.: REO/N/2021LC(SF)(Supplementary sheet for EC subscribers)). Each supplementary sheet should be marked with a consecutive serial number in accordance with the Sector the subscriber belongs to. For example, the supplementary sheet for the subscriber from the Second Sector with priority number 1 should be marked “7(1)” and that for the subscriber from the Second Sector with priority number 2 should be marked “7(2)” and so on. All pages (including all supplementary sheets of pages 6 to 10) of this form must be submitted to the relevant Returning Officer in one complete set. Candidate should check the qualification of the subscribers. If for any reason a subscriber is found not to be qualified to subscribe the nomination form, his/her subscription will be disregarded. Candidate should also remind each subscriber to provide the name as shown on his/her identity document (being the identity document based on which the particulars of the

subscriber are recorded in the geographical constituencies final register).

For instance, a member of the Election Committee may choose to subscribe a candidate in the capacity as an elector in respect of his/her own functional constituency, and subscribe another candidate in his/her capacity as a member of the Election Committee. He/she may also choose to subscribe in both capacities and sign on both Section 2 and Section 3 of the same nomination form of a candidate of the functional constituency.

For publication of the Notice of Valid Nominations and other specified notices in the Government Gazette, in accordance with the Electoral Affairs Commission (Electoral Procedure) (Legislative Council) Regulation (Cap. 541D), please provide the name and address of the candidate in both Chinese and English. A candidate can fill in his/her office or business address, correspondence address¹, residential address or post office box number as address. The address information should be complete (see PART II of Appendix). Besides, a candidate must provide the name as shown on his/her identity document (being the identity document based on which the particulars of the candidate are recorded in the geographical constituencies final register, which is usually his/her Hong Kong Identity Card) (see PART I of Appendix). The candidate should strictly follow the writing of his/her Chinese name as shown on his/her identity document in Traditional Chinese or Simplified Chinese (as the case may be). Failure to comply with this requirement would cause a delay in checking the candidate's identity document and/or require him/her to return to the relevant Returning Officer's office for rectification. If the relevant Returning Officer is satisfied that the candidate is usually known by a name different from that shown on his/her identity document, that candidate may include such different name as his/her alias. **The name (including alias) of the candidate as shown in the Notice of Valid Nominations will be printed on the ballot papers.** Candidates may refer to the Appendix for the points to note when filling in the Chinese name and address.

If an address of another person/organization is used as correspondence address, the prior consent of the person/organization concerned must be obtained.

10. 根據《選舉管理委員會（選舉程序）（立法會）規例》（第541D章）第19(3)及(4)條，有關的選舉主任必須將一份關於候選人資格審查委員會就某人是否獲有效提名的決定的通知，送交該人及有關功能界別的每名獲有效提名的候選人。這份通知必須按各候選人在有關的提名表格上所提供的地址送交。除有關提名是否有效的通知外，所有由選舉事務處或有關的選舉主任發出的信件、重要資料及公告，將會以電郵、傳真或按提名表格上所提供的通訊地址（如有的話）送交給候選人。

According to section 19(3) and (4) of the Electoral Affairs Commission (Electoral Procedure) (Legislative Council) Regulation (Cap. 541D), the relevant Returning Officer must send a notice of a decision of the Candidate Eligibility Review Committee that a person is validly nominated or is not validly nominated to the person concerned and each validly nominated candidate for the functional constituency concerned. Such a notice must be sent to the address provided by each candidate concerned as given on his/her nomination form. All correspondence, important information and notices, except the relevant notices on the validity of a nomination, from the Registration and Electoral Office or the relevant Returning Officer will be sent to the candidate by email, by fax or by mail to the correspondence address, if provided, as given on the nomination form.

A candidate may choose to state his/her occupation and political affiliation in the nomination form, which will be made available for public inspection. If the candidate mentions the name of any organization when stating his/her political affiliation, he/she must seek the consent of the organization concerned beforehand. Candidate's name, sex, occupation and political affiliation will also be published in the dedicated website for the 2021 Legislative Council General Election. Information (such as occupation and political affiliation) provided by the candidate in the Grid Paper for "Introduction to Candidates" or the specified form "Request by a Candidate for a Legislative Council Geographical Constituency, a Legislative Council Functional Constituency or a District Council Constituency to Print Particulars relating to the Candidate on a Ballot Paper" (REO/BP/7/2021(SF)) should not be inconsistent with the information stated in the nomination form.

A nomination form must be handed in by the candidate **in person** (except where the Chief Electoral Officer has, on application, authorized any other manner of submission) and received by the relevant Returning Officer within the nomination period from 30 October 2021 to 12 November 2021 (both days inclusive) during ordinary business hours (Monday to Friday: from 9 am to 5 pm; Saturday: from 9 am to 12 noon) on any day other than a general holiday. According to section 2A(3) of the Electoral Affairs Commission (Electoral Procedure) (Legislative Council) Regulation (Cap. 541D), if the last day of the nomination period falls on an inclement weather warning day (a working day on which a gale warning or a rainstorm warning is in force at any time during ordinary business hours; gale warning and rainstorm warning have the same meaning as in the Judicial Proceedings (Adjournment During Gale Warnings) Ordinance (Cap. 62)), the period is extended to end on the next working day which is not an inclement weather warning day. The nomination form should be accompanied by –

No legal proceedings may be instituted in respect of a decision made by the Candidate Eligibility Review Committee on the eligibility of a candidate for membership of the Legislative Council pursuant to the opinion of the Committee for Safeguarding National Security of the Hong Kong Special Administrative Region. As for the Candidate Eligibility Review Committee's other decision on the validity of a nomination, it cannot be questioned in any proceeding except by an election petition.
16. 提名表格必須按《立法會條例》（第 542 章）及《選舉管理委員會（選舉程序）（立法會）規例》（第 541D 章）的規定列載所需的資料，提名方才有效。有關的選舉主任可要求候選人提供就下述目的而屬適當的任何其他資料：(a) 為使候選人資格審查委員會信納該候選人有資格獲提名為功能界別的候選人；或 (b) 其他關於提名是否有效的事宜。另一方面，候選人資格審查委員會在決定某候選人是否就某選區或界別獲有效提名時，亦可要求該候選人提供該委員會認為適當的任何其他資料，以令該委員會信納 (i) 該候選人有資格獲提名為有關選區或界別的候選人；或 (ii) 其他關於提名是否有效的事宜。若候選人資格審查委員會要求候選人提供資料，候選人應以委員會所指明的方式向委員會提交有關資料。
A nomination will not be valid unless the nomination form contains the information as required in the Legislative Council Ordinance (Cap. 542) and the Electoral Affairs Commission (Electoral Procedure) (Legislative Council) Regulation (Cap. 541D). The Returning Officer concerned may require a candidate to furnish any other information that Officer considers appropriate for enabling the Candidate Eligibility Review Committee to be satisfied - (a) that the candidate is eligible to be

nominated as a candidate for a functional constituency; or (b) otherwise as to the validity of the nomination. On the other hand, in deciding whether a candidate is validly nominated for a constituency, the Candidate Eligibility Review Committee may require the candidate to furnish any other information that Committee considers appropriate to be satisfied (i) that the candidate is eligible to be nominated as a candidate for the constituency concerned; or (ii) otherwise as to the validity of the nomination. If the Candidate Eligibility Review Committee requires such information from the candidate, the candidate should provide the same to the Committee in accordance with the manner specified by the Committee.

17. 候選人不得在2021年的立法會換屆選舉中在多於一個選區或選舉界別獲得提名。候選人呈交提名表格時，必須已撤回所有其他選區或選舉界別的提名，否則，他／她其後所呈交的提名表格將被當作無效。

A candidate cannot be nominated for more than one constituency in the 2021 Legislative Council General Election. When he/she submits his/her nomination form, he/she must have withdrawn his/her nomination in respect of all other constituencies, if any, or else his/her nomination form subsequently submitted will be treated as invalid.

18. 根據《選舉管理委員會（選舉程序）（立法會）規例》（第541D章）第103條，任何人在與選舉有關的文件中作出他／她明知在要項上屬虛假的陳述，或任何人罔顧後果地在該等文件中作出在要項上不正確的陳述，或任何人明知而在該等文件中遺漏任何要項，均屬犯罪。

In accordance with section 103 of the Electoral Affairs Commission (Electoral Procedure) (Legislative Council) Regulation (Cap. 541D), a person who, in an election related document, makes a statement which that person knows to be false in a material particular or recklessly makes a statement which is incorrect in a material particular or knowingly omits a material particular from an election related document commits an offence.

19. 候選人如欲撤回提名，可填寫一份「候選人退選通知書」的指明表格（REO/C/5/2021LC(SF)），並於提名期結束前送遞予有關的選舉主任。

If a candidate wishes to withdraw his/her nomination, he/she may do so by completing and delivering to the Returning Officer concerned a “Notice of Withdrawal of Candidature” in a specified form (REO/C/5/2021LC(SF)) before the end of nomination period.

20. 本提名表格第二部分必須於見證人在場下由候選人填寫及簽署。任何年滿18歲並持有身分證明文件的人士均可擔任見證人。見證人必須填寫及簽署本提名表格第三部分。根據《立法會條例》（第542章）第3(1)條，「身分證明文件」（identity document）指—

PART II of this nomination form should be completed and signed by a candidate in the presence of a witness who can be any person who is in possession of an identity document and aged 18 years or over. The witness is required to complete PART III of this nomination form and sign thereunder. According to section 3(1) of the Legislative Council Ordinance (Cap. 542), “identity document” (身分證明文件) means –

- (a) 根據《人事登記條例》（第177章）向某人發出的身分證；或
an identity card issued to a person under the Registration of Persons Ordinance (Cap. 177);
or

a document issued by the Commissioner of Registration (within the meaning of section 1A(1) of the Registration of Persons Ordinance (Cap. 177)) to a person certifying that the person is exempt, under regulation 25 of the Registration of Persons Regulations (Cap. 177A), from being required to register under that Ordinance; or
- (c) 向某人發出的獲選舉登記主任接受為該人的身分證明的任何其他文件。
any other document issued to a person that is acceptable to the Electoral Registration Officer as proof of the person’s identity.

22. 根據《立法會條例》（第542章）第37(2)及(3)、39、40及41條，有關獲提名為候選人的資格、喪失獲提名為候選人或當選為議員的資格的情況、獲提名的候選人須遵從的規定及不得就多於一個選區或選舉界別獲得提名的規定載列如下，以供參考－

Eligibility for being nominated as a candidate, disqualification from being nominated as a candidate and from being elected as a Member, requirements to be complied with by persons nominated as candidates and the requirement for a person not to be nominated for more than one constituency are dealt with in sections 37(2) & (3), 39, 40 and 41 of the Legislative Council Ordinance (Cap. 542) which are reproduced below for reference-

- (2) 符合以下條件的人方有資格在某功能界別的選舉中獲提名為候選人－
- (a) 年滿 21 歲；及
 - (b) (i) 已登記為並有資格登記為該功能界別的選民；或
(ii) 令該功能界別的選舉主任信納他與該功能界別有密切聯繫；及
 - (c) 已登記為地方選區的選民並有資格如此登記；及

Who is eligible to be nominated as a candidate of a functional constituency (section 37(2) & (3) of the Legislative Council Ordinance (Cap. 542))

- (2) A person is eligible to be nominated as a candidate at an election for a functional constituency only if the person -
- (a) has reached 21 years of age; and
 - (b) either-
 - (i) is both registered and eligible to be registered as an elector for the constituency; or
 - (ii) satisfies the Returning Officer for the constituency that the person has a substantial connection with the constituency; and
 - (c) is both registered and eligible to be registered as an elector for a geographical constituency; and
 - (d) is not disqualified from being elected as a Member by virtue of section 39 or any other law; and
 - (e) has ordinarily resided in Hong Kong for the 3 years immediately preceding the nomination; and
 - (f) except in the case of the 12 functional constituencies specified in subsection (3), is a Chinese citizen who is a permanent resident of Hong Kong with no right of abode in any country other than the People's Republic of China.
- (3) The following 12 functional constituencies are specified for the purposes of subsection (2)-
- (a) the legal functional constituency;
 - (b) the accountancy functional constituency;
 - (c) the engineering functional constituency;
 - (d) the architectural, surveying, planning and landscape functional constituency;
 - (e) the real estate and construction functional constituency;
 - (f) the tourism functional constituency;
 - (g) the commercial (first) functional constituency;

- (h) the industrial (first) functional constituency;
- (i) the finance functional constituency;
- (j) the financial services functional constituency;
- (k) the import and export functional constituency;
- (l) the insurance functional constituency.

喪失獲提名為候選人或當選為議員的資格的情況（《立法會條例》（第 542 章）第 39 條）

- (1) 任何人如有以下情況，即喪失在選舉中獲提名為候選人的資格及當選為議員的資格—
- (a) 是—
 - (i) 司法人員；或
 - (ii) 訂明的公職人員；或
 - (iii) 立法會的人員或立法會管理委員會的職員；或
 - (b) 已在香港或任何其他地方被判處死刑或監禁（不論如何稱述），但—
 - (i) 既未服該刑罰或主管當局用以替代該項刑罰的其他懲罰；而
 - (ii) 亦未獲赦免²；或
 - (c) 已被裁定犯叛逆罪；或
 - (d) 在提名當日或選舉當日正因服刑而受監禁；或
 - (e) 在不局限(b)段的原則下，被裁定或曾被裁定犯以下罪行，而選舉於或將於其被定罪的日期後的 5 年內舉行—

 - (g) 是香港以外地方的政府的代表或該政府的受薪政府人員；或
 - (h) 是香港以外任何地方的國家級、地區級或市級立法機關、議院或議會（中華人民共和國的全國或地方人民代表大會或人民協商機構除外）的成員；或
 - (i) 是未獲解除破產的人，或於過去 5 年內在沒有向債權人全數償還債務的情況下，獲解除破產或與其債權人訂立《破產條例》（第 6 章）所指的自願安排的人。
- (1A) 任何人如有以下情況，亦即喪失在選舉中獲提名為候選人的資格及當選為議員的資格—
- (a) 該人因拒絕或忽略作出指明誓言而根據法律離任，或喪失就任的資格，而選舉於或將於該人離任或喪失資格的日期後的 5 年內舉行；或
 - (b) 該人被按照任何法律宣告、宣布或裁定為—
 - (i) 違反指明誓言；或
 - (ii) 不符合擁護《基本法》、效忠中華人民共和國香港特別行政區的法定要求和條件，而選舉於或將於作出該項宣告、宣布或裁定的日期後的 5 年內舉行。
- (2) 任何人如根據《精神健康條例》（第 136 章）已被裁斷為因精神上無行為能力而無能力處理和管理其財產及事務，即喪失在選舉中獲提名為候選人的資格，但如在其後根據該條例被裁斷為已有能力處理和管理其財產及事務，則根據本款喪失資格的人有獲提名為候選人的資格。
- (2A) 如有以下情況，某人亦喪失在任何補選中獲提名為候選人的資格—
- (a) 該人—
 - (i) 根據第 14 條辭去議員席位，而其辭職在截至該補選當日為止的 6 個月期間內生效；或
 - (ii) 在截至該補選當日為止的 6 個月期間內，根據第 13(3) 條被視為已辭去議員席位；及
 - (b) 在有關辭職通知或不接受席位的通知生效後，並無換屆選舉舉行。
- (3) 任何人如根據《精神健康條例》（第 136 章）已被裁斷為因精神上無行為能力而無能力處理和管理其財產及事務，即喪失當選為議員的資格，但如在其後根據該條例被裁斷為已有能力處理和管理其財產及事務，則根據本款喪失資格的人有當選為議員的資格。
- (4) 任何人如在提名期結束後已不再與某功能界別有密切聯繫，則該人即喪失當選為該功能界別的議員的資格。

² 原訟法庭於 2012 年 6 月 21 日就黃軒璋及另一人訴律政司司長（高院憲法及行政訴訟 2012 年第 51 及 54 號）給予書面判詞，裁定《立法會條例》（第 542 章）第 39(1)(b)條違憲。政府已於 2012 年 7 月 12 日宣布決定不會就有關判決提出上訴。日後的立法會選舉會按屆時生效的法例進行。任何人士如欲在立法會換屆選舉獲提名為候選人，並對他／她的提名資格有疑問，他／她可徵詢獨立的法律意見，亦可根據現行選舉法例在 2021 年 10 月 27 日或之前向由選舉管理委員會委任的提名顧問委員會（立法會）申請提供意見。然而，法例並不賦權或規定提名顧問委員會就關乎《立法會條例》（第 542 章）第 40 條下的規定的事宜提供意見。

 - (ea) 個人資料私隱專員及其根據《個人資料(私隱)條例》(第 486 章)僱用或聘用的人；
 - (eb) 平等機會委員會的主席及由該委員會根據《性別歧視條例》(第 480 章)僱用或聘用的人；
 - (f) 受僱於政府部門或政策局而在該政府部門或政策局任職(不論該職位屬永久性或臨時性的)的人。

When person is disqualified from being nominated as a candidate and from being elected as a Member (section 39 of the Legislative Council Ordinance (Cap. 542))

- (1) A person is disqualified from being nominated as a candidate at an election, and from being elected as a Member, if the person-
- (a) is-
 - (i) a judicial officer; or
 - (ii) a prescribed public officer; or
 - (iii) an officer of the Legislative Council or a member of staff of The Legislative Council Commission; or
 - (b) has, in Hong Kong or any other place, been sentenced to death or imprisonment (by whatever name called) and has not either-
 - (i) served the sentence or undergone such other punishment as a competent authority may have been substituted for the sentence; or
 - (ii) received a free pardon²; or
 - (c) has been convicted of treason; or
 - (d) on the date of nomination, or of the election, is serving a sentence of imprisonment; or
 - (e) without limiting paragraph (b), where the election is to be held or is held within 5 years after the date of the person's conviction, is or has been convicted-
 - (i) in Hong Kong or any other place, of an offence for which the person has been sentenced to imprisonment, whether suspended or not, for a term exceeding 3 months without the option of a fine; or
 - (ii) of having engaged in corrupt or illegal conduct in contravention of the Elections (Corrupt and Illegal Conduct) Ordinance (Cap. 554); or
 - (iii) of an offence against Part II of the Prevention of Bribery Ordinance (Cap. 201); or
 - (iv) of any offence prescribed by regulations in force under the Electoral Affairs Commission Ordinance (Cap. 541); or
 - (f) is-
 - (i) ineligible to be a candidate, or to be elected as a Member, at the election; or
 - (ii) disqualified from being a candidate, or from being elected as a Member, at the election, because of the operation of this or any other law; or
 - (g) is a representative or salaried functionary of a government of a place outside Hong Kong; or
 - (h) is a member of any national, regional or municipal legislature, assembly or council of any place outside Hong Kong, other than a people's congress or people's consultative body of the People's Republic of China, whether established at the national or local level; or
 - (i) is an undischarged bankrupt or, within the previous 5 years, has either obtained a discharge in bankruptcy or has entered into a voluntary arrangement within the meaning of the Bankruptcy Ordinance (Cap. 6) with the person's creditors, in either case without paying the creditors in full.
- (1A) A person is also disqualified from being nominated as a candidate at an election, and from being elected as a Member, if the election is held or is to be held within 5 years after—
- (a) the date on which the person vacates an office, or is disqualified from entering on an office, under the law, for declining or neglecting to take a specified oath; or
 - (b) the date on which the person is declared or decided in accordance with any law -

² The Court of First Instance delivered written judgment on 21 June 2012 on *Wong Hin Wai & another v Secretary for Justice* (HCAL 51&54/2012) and declared section 39(1)(b) of the Legislative Council Ordinance (Cap. 542) to be unconstitutional. On 12 July 2012, the Government announced its decision not to appeal against the judgment. The future Legislative Council elections will be held in accordance with the prevailing electoral laws. Any person who would like to be nominated as a candidate for a Legislative Council General Election and is doubtful about his/her eligibility for nomination may seek independent legal advice, and may also apply to the Nominations Advisory Committee (Legislative Council) appointed by the Electoral Affairs Commission for advice on or before 27 October 2021 in accordance with the existing electoral law. However, the law does not empower or require the Nominations Advisory Committee to advise on any matter relating to the requirements under section 40 of the Legislative Council Ordinance (Cap. 542).

- (2) A person is also disqualified from being nominated as a candidate at an election if the person has been found under the Mental Health Ordinance (Cap. 136) to be incapable, by reason of mental incapacity, of managing and administering his or her property and affairs, but a person disqualified under this subsection is eligible for nomination as a candidate if, under that Ordinance, it is subsequently found that the person has become capable of managing and administering his or her property and affairs.
- (2A) A person is also disqualified from being nominated as a candidate at a by-election if—
 - (a) within the 6 months ending on the date of the by-election—
 - (i) the person's resignation under section 14 as a Member took effect; or
 - (ii) the person was taken under section 13(3) to have resigned from office as a Member; and
 - (b) no general election was held after the relevant notice of resignation or notice of non-acceptance took effect.
- (3) A person is also disqualified from being elected as a Member if the person has been found under the Mental Health Ordinance (Cap. 136) to be incapable, by reason of mental incapacity, of managing and administering his or her property and affairs, but a person disqualified under this subsection ceases to be disqualified if, under that Ordinance, it is subsequently found that the person has become capable of managing and administering his or her property and affairs.
- (4) A person is also disqualified from being elected as a Member for a functional constituency if, since the close of nominations, the person has ceased to have a substantial connection with the constituency.
- (5) In this section-
 "judicial officer" (司法人員) means the holder of a judicial office, as defined in section 2 of the Public Service Commission Ordinance (Cap. 93);
 "prescribed public officer" (訂明的公職人員) means any of the following-
 - (a) the Chairman of the Public Service Commission;
 - (b) the Commissioner and Deputy Commissioner of the Independent Commission Against Corruption and the holder of any other office under the Independent Commission Against Corruption Ordinance (Cap. 204);
 - (c) The Ombudsman and the holder of any appointment under section 6 of The Ombudsman Ordinance (Cap. 397);
 - (d) a member of the Electoral Affairs Commission;
 - (e) the chief executive of the Monetary Authority and any member of the senior management of that Authority, including divisional heads, executive directors, managers and counsel employed by that Authority;
 - (ea) the Privacy Commissioner for Personal Data and any person employed or engaged by him or her under the Personal Data (Privacy) Ordinance (Cap. 486);
 - (eb) the Chairperson of the Equal Opportunities Commission and any person employed or whose services are engaged by the Commission under the Sex Discrimination Ordinance (Cap. 480);
 - (f) any person holding an office, whether permanent or temporary, in a Government department or bureau and employed in the department or bureau;
 "specified oath" (指明誓言) means an oath taken under the law that the oath-taker will uphold the Basic Law and bear allegiance to the Hong Kong Special Administrative Region of the People's Republic of China.

 - (I) 第39(5)條所指的訂明的公職人員；或
 - (II) 立法會的人員或立法會管理委員會的職員；

 - (G) 成為香港以外任何地方的國家級、地區級或市級立法機關、議院或議會（中華人民共和國的全國或地方人民代表大會或人民協商機構除外）的成員；
 - (H) 成為中央人民政府或任何其他國家或地區的武裝部隊的成員；或
 - (I) （如是某功能界別選出的議員）不再與有關功能界別有密切聯繫。

 - (3) 按金須為《規例》為施行本條而訂明的款額。

What requirements are to be complied with by persons nominated as candidates (section 40 of the Legislative Council Ordinance (Cap. 542))

- (1) A person is not validly nominated as a candidate for an election for a constituency unless-
 - (a) a deposit has, in the manner prescribed by regulations in force under the Electoral Affairs Commission Ordinance (Cap. 541), been lodged by or on behalf of the person with the Returning Officer concerned; and
 - (b) the nomination form includes or is accompanied by-
 - (i) a declaration to the effect that the person will uphold the Basic Law and pledge allegiance to the Hong Kong Special Administrative Region; and
 - (ii) a declaration as to the person's nationality and as to whether or not the person has a right of abode in a country other than the People's Republic of China; and
 - (iii) a promissory oath given by the person to the effect that, if elected, he or she will not do anything during his or her term of office that results in his or her-
 - (A) becoming-
 - (I) a prescribed public officer within the meaning of section 39(5); or
 - (II) an officer of the Legislative Council or a member of staff of The Legislative Council Commission;
 - (B) being sentenced to death in Hong Kong or any other place;
 - (C) being convicted of treason;
 - (D) being convicted-
 - (I) of having engaged in corrupt or illegal conduct in contravention of the Elections (Corrupt and Illegal Conduct) Ordinance (Cap. 554); or
 - (II) of an offence against Part II of the Prevention of Bribery Ordinance (Cap. 201); or
 - (III) of any offence prescribed by regulations in force under the Electoral Affairs Commission Ordinance (Cap. 541);
 - (E) being disqualified from being elected as a Member at an election because of the operation of this or any other law;
 - (F) becoming a representative or salaried functionary of a government of a place outside Hong Kong;
 - (G) becoming a member of any national, regional or municipal legislature, assembly or council of any place outside Hong Kong, other than a people's congress or people's consultative body of the People's Republic of China, whether established at the national or local level;
 - (H) becoming a member of the armed forces of the Central People's Government or any other country or territory; or
 - (I) in the case of a Member elected for a functional constituency, ceasing to have a substantial connection with the constituency.
- (2) The person must sign the declarations.
- (3) The deposit is to be of such an amount as is prescribed by the regulations for the purposes of this section.

不得就多於一個選區或選舉界別獲得提名 (《立法會條例》(第 542 章) 第 41 條)

Person not to be nominated for more than one constituency (section 41 of the Legislative Council Ordinance (Cap. 542))

A person is not eligible to be nominated as a candidate for a constituency if the person is currently nominated as a candidate for another constituency.

In accordance with sections 16(3A)(a) and (3B) of the Electoral Affairs Commission (Electoral Procedure) (Legislative Council) Regulation (Cap. 541D), the Candidate Eligibility Review Committee may require the Returning Officer to advise the Committee on any of the matters specified below:

- (a) whether, in the opinion of the Returning Officer, section 10, 11 or 12A (as may be applicable) are complied with in relation to the candidate;
- (b) subject to subsection (3C), whether, in the opinion of the Returning Officer, sections 37, 39 and 40 of the Legislative Council Ordinance (Cap. 542) are complied with in relation to the candidate;
- (c) whether, in the opinion of the Returning Officer, the nomination form of the candidate is valid;
- (d) whether the candidate has withdrawn candidature for that constituency;
- (e) whether the nomination form of the candidate has been signed by the prescribed number of subscribers qualified to subscribe to the nomination form under the Legislative Council (Subscribers and Election Deposit for Nomination) Regulation (Cap. 542C);
- (f) whether the nomination form of the candidate has been completed or signed as required under this Regulation;
- (g) in the opinion of the Returning Officer—
 - (i) whether the candidate is eligible to be nominated as a candidate under the Legislative Council Ordinance (Cap. 542); and
 - (ii) whether the candidate is disqualified from being nominated as a candidate under that Ordinance;
- (h) whether the candidate has been nominated for another constituency in the same election and, if so, whether the other candidature has been withdrawn;
- (i) whether the candidate has lodged the appropriate deposit; and
- (j) whether, according to the information available to the Returning Officer, the candidate is dead.

In accordance with section 40(1)(b)(i) of the Legislative Council Ordinance (Cap. 542), a candidate must declare in the nomination form that he/she will uphold the Basic Law and pledge allegiance to the Hong Kong Special Administrative Region. Upholding the Basic Law means to uphold all the provisions of the Basic Law, including the following provisions –

No amendment to this Law shall contravene the established basic policies of the People's Republic of China regarding Hong Kong.

A person upholds the Basic Law and bears allegiance to the Hong Kong Special Administrative Region of the People's Republic of China ("HKSAR") if the positive list is satisfied; and that the person does not uphold the Basic Law and bear allegiance to the HKSAR if the person does or intends to do any of the things set out in the negative list. Section 3AA of the Interpretation and General Clauses Ordinance (Cap. 1) is reproduced below -

 - (i) 作出《基本法》第23條規定禁止的行為；
 - (ii) 犯《中華人民共和國香港特別行政區維護國家安全法》規定的罪行；及
 - (iii) 犯成文法則或普通法規定的關於危害國家安全的罪行；
 - (b) 拒絕承認中華人民共和國對香港特別行政區擁有並行使主權，包括反對中央政權機關按照－
 - (i) 《中華人民共和國憲法》；
 - (ii) 《基本法》；或
 - (iii) 《中華人民共和國香港特別行政區維護國家安全法》，履行職務和職能；
 - (c) 拒絕承認香港特別行政區作為中華人民共和國一個地方行政區域的憲制地位；
 - (d) 宣揚或支持“港獨”主張，包括－
 - (i) 主張、推動或實施香港“獨立建國”；
 - (ii) 參與以“香港獨立”為宗旨的組織；
 - (iii) 主張、推動或實施“自決主權或治權”、“全民公投”、“全民制憲”等活動，或參與以“自決”為宗旨的組織；及
 - (iv) 主張或推動香港轉歸外國統治；
 - (e) 尋求外國政府或組織干預香港特別行政區的事務；
 - (f) 作出損害或有傾向損害《基本法》中以行政長官為主導的政治體制秩序的行為，包括－
 - (i) 以非法手段強迫或威嚇行政長官改變某項政策或提交立法會審議的議案；
 - (ii) 無差別地反對特區政府提出的議案，並－
 - (A) 意圖以此要脅特區政府；
 - (B) 意圖以此使特區政府無法正常履行職務和職能；或
 - (C) 意圖以此逼使行政長官下台及推翻特區政府；及
 - (iii) 利用特區政府舉行的選舉，組織或實施（或煽動他人組織或實施）任何形式的對抗中央人民政府和特區政府的“變相公投”；
 - (g) 作出損害或有傾向損害香港特別行政區的整體利益的行為；
 - (h) 公開及故意以焚燒、毀損、塗劃、玷污、踐踏等方式侮辱國旗或國徽或區旗或區徽；
 - (i) 侮辱或貶損國歌或國家主權的任何其他象徵和標誌。

References to upholding Basic Law and bearing allegiance to HKSAR (section 3AA of the Interpretation and General Clauses Ordinance (Cap. 1))

In accordance with section 3AA of the Interpretation and General Clauses Ordinance (Cap. 1),

- (1) A person upholds the Basic Law and bears allegiance to the Hong Kong Special Administrative Region of the People's Republic of China if the person -

- (a) upholds the constitutional order of the Hong Kong Special Administrative Region established by the Constitution of the People's Republic of China and the Basic Law;
 - (b) upholds the national sovereignty, unity, territorial integrity and national security of the People's Republic of China;
 - (c) upholds –
 - (i) the fact that the Hong Kong Special Administrative Region is an inalienable part of the People's Republic of China;
 - (ii) the People's Republic of China's exercise of sovereignty over the Hong Kong Special Administrative Region; and
 - (iii) the Central Authorities' exercise of governance over the Hong Kong Special Administrative Region under the Basic Law;
 - (d) upholds the implementation of "one country, two systems" principle, and safeguards the political structure of the Hong Kong Special Administrative Region;
 - (e) upholds the objective to maintain the prosperity and stability of the Hong Kong Special Administrative Region within the framework of the Basic Law; and
 - (f) is loyal to, and safeguards the interests of, the Hong Kong Special Administrative Region.
- (2) In subsection (1), a reference to uphold is a reference to intend to genuinely and truthfully observe, support, maintain and embrace, and genuinely and truthfully observe, support, maintain and embrace in words and deeds.
- (3) A person does not uphold the Basic Law and bear allegiance to the Hong Kong Special Administrative Region of the People's Republic of China when the person does, or intends to do, any of the following –
- (a) commits acts or carries out activities that endanger national security, including –
 - (i) commits an act required by Article 23 of the Basic Law to be prohibited;
 - (ii) commits an offence under the "Law of the People's Republic of China on Safeguarding National Security in the Hong Kong Special Administrative Region" (a translation of "《中華人民共和國香港特別行政區維護國家安全法》"); and
 - (iii) commits an offence relating to endangering national security under an enactment or under the common law;
 - (b) refuses to recognize the People's Republic of China's sovereignty over the Hong Kong Special Administrative Region and the exercise of the sovereignty, including objecting to the performance of duties and functions by the body of central power in accordance with –
 - (i) the Constitution of the People's Republic of China;
 - (ii) the Basic Law; or
 - (iii) the Law of the People's Republic of China on Safeguarding National Security in the Hong Kong Special Administrative Region (a translation of "《中華人民共和國香港特別行政區維護國家安全法》");
 - (c) refuses to recognize the constitutional status of the Hong Kong Special Administrative Region as a local administrative region of the People's Republic of China;
 - (d) advocates or supports "Hong Kong independence", including –
 - (i) pursues, promotes or implements "independence and state-building" of Hong Kong;
 - (ii) participates in an organization the object of which is "Hong Kong Independence";
 - (iii) pursues, promotes or implements an activity for "self-determination of sovereignty or jurisdiction", "referendum" or "devising constitution by all people", or participates in an organization the object of which is "self-determination"; and
 - (iv) pursues or promotes the reign over Hong Kong to be transferred to a foreign country;
 - (e) solicits interference by foreign governments or organizations in the affairs of the Hong Kong Special Administrative Region;
 - (f) commits acts that undermine or have a tendency to undermine the order of the political structure led by the Chief Executive, contained in the Basic Law, including –
 - (i) compels or overawes the Chief Executive by any unlawful means to change a policy, or a motion to be submitted to the Legislative Council for consideration;
 - (ii) indiscriminately objects to the Government's motion, and with this –
 - (A) intends to threaten the Government;
 - (B) intends to render the Government incapable of performing its duties and functions as normal; or
 - (C) intends to force the Chief Executive to step down and to overthrow the Government; and
 - (iii) makes use of an election held by the Government to organize or implement, or to incite another person to organize or implement, a "de facto referendum" in any form to confront the Central People's Government and the Government;
 - (g) commits acts that undermine or have a tendency to undermine the overall interests of the Hong Kong Special Administrative Region;
 - (h) desecrates the national flag or national emblem, or regional flag or regional emblem, by publicly and wilfully burning, mutilating, scrawling on, defiling or trampling on it;
 - (i) insults or disrespects the national anthem or any other symbol and sign of national sovereignty.
