(Note: According to Chapter 9 of “Guidelines on Election-related Activities in respect of the Legislative Council Election”, a candidate **must inform the relevant Returning Officer (“RO”) of his/her intention to display election advertisements at designated spots in writing within the nomination period.** Only candidates of contested constituencies will be allocated with designated spots. The number and size of designated spots for allocation to the contesting candidates will be finalised by the RO, taking into account the number of candidates in the relevant constituency, after the close of nominations. Designated spots will be allocated by agreement of the representatives of all candidates contesting in the same constituency or by the drawing of lots.)
